HB 426 HD1 - RELATING TO TUITION WAIVERS

Chair Luke, Vice Chair Yamashita, and members of the committee:

Thank you for the opportunity to testify on HB 426 HD1 which requires tuition waivers to be given to the dependent children of disabled veterans or active or reserve members of the armed forces who were killed in action.

The University of Hawai'i (UH) appreciates the intent of this measure as it honors the service of those who serve(d) in our armed forces. The UH does not believe this measure is necessary as UH is in compliance with several federal legislative actions which already provide education benefits for survivors and dependents of a veteran.

The following are federal programs that provide support for dependent children of disabled veterans or active or reserve members of the armed forces killed in action:

<u>Chapter 35 - Dependents' Educational Assistance (DEA) Program.</u> The DEA program provides up to 45 months of education and training benefits to eligible dependents of service members who have died or are permanently disabled due to active service in the armed forces. These benefits may be used for degree and certificate programs, apprenticeship, and on-the-job training. Effective October 1, 2013, some recipients may be eligible to receive up to 81 months of GI Bill® benefits if they use DEA program benefits in conjunction with other VA education benefits.

Eligible children may use this benefit while they are between the ages of 18 and 26; however, under some circumstances the period of eligibility can be extended until the age of 31.

Spouses generally have ten (10) years from the date the VA establishes eligibility to use the benefit. However, effective October 10, 2008, a spouse may remain eligible for this benefit for twenty (20) years from the effective date of rating if the veteran was rated permanently and totally disabled within an effective date of three (3) years from discharge.

Surviving spouses of service members who died while on active duty have twenty (20) years from the date of death to use this benefit.

<u>Public Law No: 116-315</u> which went into effect on 01/05/2021. Section 1002 of this Public Law expands eligibility for the Fry Scholarship to a child or spouse of a person who dies on or after September 11, 2001, in the line of duty while serving on duty other than active duty as a member of the Armed Forces, and a child or spouse of a member of the Selected Reserve who dies on or after September 11, 2001, from a service-connected disability while a member of the Selected Reserve. The UH has implemented this as of August 1, 2021.

<u>Section 1011.</u> Expansion of Transfer of Entitlement for Dependents under the Post-9/11 GI Bill expands the eligibility for dependents to whom Post-9/11 GI Bill benefits can be transferred. Eligibility now includes certain unmarried children placed in the legal custody of the service member for at least twelve (12) months as a result of a court order.

For these reasons, the UH does not feel there is a need for this bill and respectfully requests that HB 426 HD1 be deferred.

Chair Luke, Vice Chair Yamashita, and members of the Committee.

I'm Ron Han, Director of the State Office of Veterans Services (OVS). I appreciate this opportunity to provide testimony in **Support** of the concepts in House Bill 426, HD1.

This measure allows the University of Hawaii system including the respective community colleges to waive tuition for dependent children of service-connected one hundred per cent disabled veterans and active or reserve members of the armed forces who were killed in action, subject to certain requirements. These 100% disabled Veterans receive federal compensation for their injuries and ailments. However, many are total and permanently disabled precluding them from employment making it very challenging to support their dependents with educational opportunities. This measure would also assist dependent children who's loved one was killed in action and paid the ultimate sacrifice. We recommend that the Department of Veterans Affairs (VA) Chapter 35 benefits and entitlements program be verified first by the UH system. This will ensure that eligible dependent children can be initially screened for or potentially qualify for other educational benefits sponsored by the VA.

The OVS supports the intent expressed in this measure as long as its implementation does not impact or replace the priorities set forth in the Executive Budget.

Thank you for this opportunity to provide testimony on behalf of Hawaii's Veterans and their families.

I SUPPORT HB4 26 HD1 - RELATING TO TUITION WAIVERS. Requires UH and the community colleges under certain circumstances to waive tuition for dependent children of service-connected one hundred per cent disability veterans, active or reserve members of the armed forces who were killed in action, and purple heart medal recipients awarded in 2001 or later.

Other states have recognized the need to offer veteran's benefit that enables qualifying resident children and spouses to attend public post-secondary educational institutions tuition-free. This measure will align Hawaii with those states in support of service members' dependent children that are disabled, killed in action or deceased.

I would like to request that children's AGE EXTEND BEYOND THE 24 AGE LIMIT to allow for those children that have already aged out. And if possible, include spouses that have desired to attend higher education institutions but were too busy taking care of the children, disabled veteran and/or working to make (financial, educational, social-mental, etc.) ends meet.

My multi-toured Vietnam veteran husband is 100% disabled and has had his days & times. Our daughters have experienced first-hand what living with this type of physical, mental, sociological, etc. disabled father is like. Make no mistake, he still has loving, caring, thoughtful and other desired fatherly and husband/soulmate characteristic's - we're BLESSED. I myself, am a disabled veteran too, but not to that extent - PRAISE THE LORD.

All this shared, I ask for PASSAGE OF HB 426 HD1, with amendments, out of your committee and thanking you in advance.
