HB 426 HD1 - RELATING TO TUITION WAIVERS

Chair Takayama, Vice Chair Clark, and members of the committee:

Thank you for the opportunity to testify on HB 426 HD1 which requires tuition waivers to dependent children of disabled veterans or active or reserve members of the armed forces who were killed in action.

The University of Hawai'i (UH) appreciates the intent of this measure as it honors the service of those who serve(d) in our armed forces. The UH does not believe this measure is necessary as the UH is in compliance with Public Law No: 116-315 which went into effect on January 5, 2021.

Section 1002 of this Public Law expands eligibility for the Fry Scholarship to a child or spouse of a person who dies on or after September 11, 2001, in the line of duty while serving on duty other than active duty as a member of the Armed Forces, and a child or spouse of a member of the Selected Reserve who dies on or after September 11, 2001, from a service-connected disability while a member of the Selected Reserve. The UH has implemented this as of August 1, 2021.

Section 1011. Expansion of Transfer of Entitlement for Dependents under the Post-9/11 GI Bill® Expands the eligibility for dependents to whom Post-9/11 GI Bill® benefits can be transferred. Eligibility now includes certain unmarried children placed in the legal custody of the service member for at least 12 months as a result of a court order. The UH has implemented this as of January 5, 2021.

For these reasons, the UH does not feel there is a need for this bill and respectfully requests that HB 426 HD1 be deferred.

Chair Takayama, Vice Chair Clark, and members of the Committee.

I'm Ron Han, Director of the State Office of Veterans Services (OVS). I appreciate this opportunity to provide testimony in **Support** of the concepts in House Bill 426, HD1.

This measure allows the University of Hawaii system including the respective community colleges to waive tuition for dependent children of service-connected one hundred per cent disabled veterans and active or reserve members of the armed forces who were killed in action, subject to certain requirements. These 100% disabled Veterans receive federal compensation for their injuries and ailments. However, many are total and permanently disabled precluding them from employment making it very challenging to support their dependents with educational opportunities. This measure would also assist dependent children who's loved one was killed in action and paid the ultimate sacrifice. We recommend that the Department of Veterans Affairs Chapter 35 benefits and entitlements program to be verified first. This will ensure that eligible dependent children can be initially screened for or potentially qualify for other educational benefits.

The OVS supports the intent expressed in this measure as long as its implementation does not impact or replace the priorities set forth in the Executive Budget.

Chairs Takayama, Vice Chair Clark, and Members of the Committee:

The Hawaii Military Affairs Council ("MAC") **supports** House Bill 426, HD 1 which requires UH and the community colleges under certain circumstances to waive tuition for dependent children of service-connected one hundred per cent disability veterans and active or reserve members of the armed forces who were killed in action.

The Hawaii Military Affairs Council (MAC) was established in 1985 when the Chamber was appointed by the State to serve as the liaison to the military. The MAC advocates on behalf of Hawaii's military, and is comprised of business leaders, academic institutions, State and County officials, members of the CODEL, community leaders, labor unions and organizations and retired U.S. flag and general officers. The MAC works to support Hawaii's location as a strategic U.S. headquarters in the Indo-Asia-Pacific region which is crucial for U.S. national and homeland security.

It is recognized that many states offer veteran's benefit that enables qualifying resident children and spouses to attend public post-secondary educational institutions tuition-free. This measure will align Hawaii with the many states in support of service members' dependents that are disabled, killed in action or deceased.

He is a 100% Service Connected Disabled Combat Veteran.

In Late 2019, I requested Tuition Waivers for Children of Deceased and 100% Service Connected Disabled Veterans. I had no experience with the Arduous and Confusing Legislative process. I am still learning, how very Long it takes to pass a Bill.

May I please ask every one on this HET committee and beyond, for your empathy and kokua? Please understand how disappointed we were to realize back in 2019 that the Tuition Waiver was not in place. We thought it was offered in the State of Hawaii in the Public University of Hawaii Stysem. Especially because we know that the States of California Oregon and Washington and others, have had this Law in place for a very very long time. Hawaii has a very strong Military presence. Why is thisTuition Waiver in the State of Hawaii not in place for our yet?

Please support HB426. It will provide much needed peace of mind and relieve a very great financial burden for the Children of Deceased or 100% Service Connected Veterans.

Grants and Scholarships are not enough to cover Tuition 100%. Please pass HB426 and work as hard as you can to continue to talk about it with All of your colleagues in the House of Representatives and in the Sentate.

Please, at this point, (2 years later since introduced in Janauary 2020),

I wish to suggest an Ammendment : To include Children of ALL Ages and Tuition to be waved for Any Degree of Higher Education or Training, up to the Highest Level of PhD .

Passing HB426 would be a perfect way to say Mahalo nui loa, Thank you very much for

Your Sevice, and to honor out Fallen Veterans for their Ultimate Sacrifice for our Freedom!

If my words are not clear, please reach out to me anytime for clarification. I can elaborate on how badly needed this Tuition Waiver is needed for all of our Fallen Ohanas in the State of Hawaii. I can tell you more about experiences our Veterans endured in All Wars. Having a Parent go thru the atroicities of War is a Family Affair.
