# H.B. 678 - RELATING TO STATE HOLIDAYS

The Hawaii Government Employees Association, AFSCME Local 152, AFL-CIO supports the intent of H.B. 678 which reestablishes La Ku`oko`a – Hawaiian Recognition Day – as an official state holiday.

The increasing desire to recognize and honor Hawai`i's past and the recent coinciding change to convert to an all-mail election in November 2020 marks an opportune moment to discuss, and potentially adjust, our official state holidays. While the Legislature is empowered to designate state holidays, we reserve the exclusive right to negotiate the terms, conditions, and impact of holidays on included employees with the Employer. We respectfully request that should this measure continue to move through the legislative process, the Employer initiate collective bargaining negotiations with all exclusive representatives.

Common Cause Hawaii provides commitments on HB 678, which (1) recognizes La Kuokoa, Hawaiian Recognition Day, as an official state holiday and (2) removes election day as an official state holiday.

Common Cause Hawaii is a nonprofit, nonpartisan, grassroots organization dedicated to reforming government and strengthening democracy through voting modernization efforts.

Common Cause Hawaii notes that Hawaii is a vote-by-mail state with voter service centers that currently open 10 days prior to primary and general elections on government facilities. Election workers – both administrators, staff, and volunteers – are the backbone of our democracy and Common Cause Hawaii thanks them for their service. Common Cause Hawaii wants to ensure that there will not be any issue or difficulty with locating voter service centers on government facilities, especially for general election Tuesday, if election day is removed as a state holiday. For the 2020 elections, there were people who confirmed that they still wanted to vote in person on general election day and showed up to the voter service centers, resulting in long lines forming. This could disrupt government operations, if it were not a state holiday.
