SUBJECT: HB794 Relating to Disability Awareness.

The Hawaii State Council on Developmental Disabilities **offers comments for HB794**, which Designates the month of October as "Disability Awareness Month: Employment, Enrichment, and Inclusion" in recognition of the employment challenges and successes of persons with disabilities in the State.

The Council supports this measure's goal of supporting and bringing awareness to our working-age disability population. People with disabilities still face disparities in our workforce and, on average, earn less per year than their peers. Our intellectual and developmental disability population still faces challenges finding gainful employment and face unnecessary barriers to our workforce in Hawai'i. However, October is already established as National Disability Employment Awareness Month (NDEAM), and our State has recognized this through proclamations from the Governor and our Mayors.

NDEAM was created to educate the general public on the issues that workers with disabilities face and how employers can be more inclusive in their hiring practices. This tradition started in 1945 with Public Law 176 from congress. This month has taken many forms over the years and currently resides in the Office of Disability Employment Policy (ODEP), which has been in charge of the month and its theme since 2001. This year makes 76 years since the first NDEAM was celebrated.

Hello Chair Tam, Chair Belatti, and members of the Committees,

My name is Gabrielle Ulloa residing on the island of Guam and a student in the Master of Social Work Program, Distance Education Option at the University of Hawai'i at Manoa's Thompson School of Social Work and Public Health. I would like to thank you for this opportunity to provide testimony. I am writing in support of HB 794 which seeks to recognize the employment challenges and successes of individuals with disabilities by designating the month of October as "Disability Awareness Month: Employment, Enrichment, and Inclusion."

According to the Centers for Disease Control and Prevention, 218,444 adults in Hawaii have a disability.¹ Disability awareness is an important part of establishing inclusion for people with disability, especially in the workplace. A study found that individuals with disabilities who disclosed their disability status at work experienced discriminatory behaviors such as coworker unease, inappropriate questions, and assumptions about their capability.² By highlighting the employment challenges experienced by individuals with disabilities, the community can work together with individuals with disabilities to create effective solutions to facilitate inclusion, positive attitudes, and ensure equity. By highlighting the successes of individuals with disabilities in the workplace, the community may be informed on the vast capabilities, skills, and strengths of individuals with disabilities in a variety of workplace settings. Fear and discomfort about interacting with individuals with disabilities are often due to lack of knowledge and stereotypes. The more informed people are on disabilities, the more comfortable and understanding they will likely be in interacting with an individual that has disability.
