#### RE: H.B. 818; RELATING TO CRIMINAL TRESPASS ONTO STATE LANDS.

Chair Nakashima, Vice Chair Matayoshi, and members of the House Committee on Judiciary and Hawaiian Affairs, the Department of the Prosecuting Attorney of the City and County of Honolulu ("Department") submits the following comments regarding H.B. 818.

The purpose of H.B. 818 is to clarify that an offense under section 708-814, H.R.S. may be established by use of authenticated photographs, video recordings, or other recordings that show the commission of the offense being committed.

Although these proposed amendments are well-intended, they are unnecessary, as the rules of evidence already address what is competent evidence for purposes of trial and allow use of photographs and video recording. The Department is very concerned that the language proposed in H.B. 818 would confuse existing standards and create negative unintended consequences in court. Specifically, the Department notes that singling out specific offenses to specify when photographs and video recordings are allowed could create the opposite effect this bill intends. Courts may begin requiring similar language in all offenses rather than relying on the rules of evidence and established case law.

For all of the foregoing reasons, the Department of the Prosecuting Attorney of the City and County of Honolulu submits these comments regarding H.B. 818. Thank you for the opportunity to testify on this matter.

# H.B. No. 818: RELATING TO CRIMINAL TRESPASS ONTO STATE LANDS

Chair Nakashima, Vice Chair Matayoshi, and Members of the Committee:

The Office of the Public Defender opposes H.B. 818.

This measure includes language that allows the use of photographs, video recordings, or other recordings that show the commission of the offense subject to authentication by one or more witnesses. The Hawaii Rules of Evidence that govern the admission of photographs, video records, or other recordings in any criminal trial already allow for this type of evidence to be used subject to authentication. This measure is unnecessary and provides no additional means of evidence not already anticipated in the Hawaii Rules of Evidence as codified in HRS Chapter 626.
