# H.B. 822 RELATING TO MOTOR VEHICLES

House Committee on Transportation

The Department of Transportation (DOT) **opposes** H.B. 822, which requires that motorcycles receive safety inspections once every 10 years instead of once every 12 months. Requires the Director of Transportation to adopt rules to increase to \$75 the inspection fee for motorcycles. Establishes a 2—year moratorium on motorcycle certificates of inspection requirements.

Due to safety concerns, the DOT recommends that current inspection periods remain unchanged from the current time periods and durations. However, we will support allowing new motorcycles to start inspections two years after purchase to be consistent with motor vehicles.

The HPD opposes this bill that would allow motorcycles to be inspected once every ten years instead of once every twelve months.

The law may also encourage motorists to make modifications to their vehicles that do not necessarily meet the Department of Transportation's safety standards; therefore, resulting in an increase of unlawful vehicles on roadways for a longer period of time.

## **RE: HB 822- RELATING TO MOTOR VEHICLES**

#### **POSITION:**

We are in support of the Bill with amendments. Motorcycles have components that need to be replaced on a more regular basis than cars. Motorcycles are also more likely to be repaired after an accident without being declared a "Total Loss". Tire wear is higher than a car, lights and turning signals are the most exposed on a motorcycle and most prone to damage from tip-overs and accidents. While a yearly inspection; especially new motorcycles is excessive, a shorter term of five years than the proposed ten years is appropriate.

An expanded period for motorcycle inspections does not provide for a more expansive inspection so no further inspection time is warranted. However, due to inflation the fee to inspect motorcycles should be increased approximately 47% to \$25.00
