RELATING TO THE HAWAII STATE BUILDING CODE.

Chair Hashimoto, Vice Chair Aiu, and Members of the Committee, the Hawaii State Energy Office (HSEO) respectfully offers comments on this bill which allows the counties to adopt a county building code for single-family dwellings, additional dwellings, duplexes, and non-commercial structures that is distinct from the Hawaii state building codes.

Hawai'i Revised Statutes 107-28 states that "The governing body of each county shall amend, adopt, and update the Hawaii state building codes as they apply within their respective jurisdiction, in accordance with section 46-1.5(13), without approval of the council" [emphasis added].

The HSEO participated in the writing of HRS 107-28 when the county building division managers made it clear that Hawai'i is a home-rule state and autonomy regarding building codes is a very important issue for them.

HSEO feels that HB 920 is thereby unnecessary due to the clarity of the phrase "The governing body of each county shall amend" and the current practice of counties amending the state building codes prior to adoption.

On behalf of the County of Hawai'i, I am expressing our strong support for HB 920 relating to the county authority to amend and adopt the Hawai'i State Building Codes without council approval, specific to a county building code for single-family dwellings, additional dwelling units, duplexes, and non-commercial structures distinct from the Hawai'i State building codes.

The County of Hawai'i supports the passage of HB 920, which would give counties flexibility and remove identified, unnecessary regulations that, at times, create delays and add time and costs to the construction of desperately needed, affordable, single-family dwellings, ohana units, and duplexes.

BIA-Hawaii takes a leadership role in unifying and promoting the interests of the industry to enhance the quality of life for the people of Hawaii. Our members build the communities we all call home.

BIA Hawaii is in strong support of HB 920, Relating to the Hawaii State Building Code. This bill would allows the counties to adopt a county building code for single-family dwellings, additional dwellings, duplexes, and non-commercial structures that is distinct from the Hawai'i state building codes.
