- 2. Access to Honolua Bay and protection of the greater Honolua-Mokulēia Bay Marine Life Conservation District are State and County priorities.

For the foregoing reasons, I **support** this measure.

#### Aloha e JHA committee,

I am writing in strong support of this resolution as both the Councilmember representing West Maui and the current President of the Save Honolua Coalition. I started receiving calls in the early morning of February 19 about the grounding of this luxury yacht through March 5, when DLNR was able to have the yacht freed and continue to get calls to this day. This is a very serious issue because Honolua Bay is so loved and treasured by such a broad range of people both near and far, many of whom, like myself felt powerless to do anything to protect this space. There are three legally installed and permitted sets of Day Use Mooring Buoys at Honolua, that are supposed to be only for day use and if another party is waiting, use should be limited to 2.5 hours, vessels are to be tied at both stern and bow and there should be no overnight mooring. In the lawsuit against Jim Jones, by the yacht Nakoa's owners, the plaintiffs allege, the personal trip was in violation of the contract they had, and the Captain that Jones claims was on the vessel at the time was not an approved Captain to use the boat. The Bare boat (demise) charter scheme that Jones reported to the media (Civil Beat) is not a valid business model here in Hawaii because they are considered commercial activity. I am not sure he was ever issued a validcommercial use permit as one of his vessels is foreign made and can not be operated commercially in Hawaii State waters until the documentation has been changed. It defies common sense that a licensed 100T commercial Captain would moor overnight on a day use mooring buoy, not secure the bow and stern, not have someone to stand watch, not set up the alarm systems that would alert them they are drifting and not remove their belongings from the boat as it was grounded. It seems as though the initial work directed by Jones also made the situation worse as when the boat was first grounded, it was in a different position than where it ended up Tuesday morning when the fuel began to leak. There has also been assertion that previous businesses that this individual has run are in court and were not operated in accordance with the law either. Please fully investigate this incident to protect the people of Hawaii from more of Mr. Jones reckless schemes that seem to have hurt not only many people of this State but also our precious ecosystems. The area where the boat was leaking hazardous fluids used to be community tako grounds and is probably the reason it is just outside of the marine life conservation district, corals, live rock and habitat and it has been completely decimated. I also acknowledge that a lot of what I have written I have gathered from various news sources and legal papers but could be wrond and so a full and thorough investigation needs to be done to sort out fact from fiction and hold those responsible fully accountable for their actions. Ignorance of our laws is no excuse to not be held accountable.

The Save Honolua Coalition strongly supports HCR148. Having worked with the community, DLNR, Coast Guard, and Salvage Companies from the beginning of this disaster as well as been given access to the site for all 13 days, we feel we have a unique and accurate perspective of the incident. Through it all, we have been measuring public response and collecting public opinion. It is the overwhelming opinion of the community that justice be served to the strongest extent of the law.

Here are some examples of Jim Jones' negligence and/or incompetence that resulted in great damage to our reef and marine ecosystem.

- Illegally tied up to a 2.5 hour mooring for over two days and two nights
- Did not check the mooring to see that it was not strong enough for a 120 ton yacht
- Voided his insurance by not having a licensed captain onboard
- Did not have a warning device activated to alert him to being adrift
- Did not have a watch system organized with his crew/passengers
- Did not organize an effective rescue attempt while the DLNR gave him a chance over the first 48 hrs resulting in two wasted days. Meanwhile the yacht got pushed further up the rocks.
- Left his bilge pump on while grounded resulting in a large diesel spill
- When given the chance, did not remove loose items and rubbish on board even though there was a good chance that the boat would sink during salvage (he did remove valuables)

Honolua Bay is precious to our community and people all over the world. Please pass HCR148 so that justice be served to the greatest extent of the law and that the public's deep appreciation and concern for Honolua Bay be honored in doing so.

I'm not one to really question or get in the middle of the judicial system, but as a mariner born & raised on Maui in the US Coast Guard I have to say Mr. Jones should be punished for his negligence of operating his motor vessel NAKOA running it aground at Honolua Bay to the max of what can be done by the Hawaii judicial system.

This rule I know has been broken by many others with boats many times and that they may have not been punished, however, this rule is in place for many reasons and we can all foresee one of the reasons was to lessen the chances of a boat running aground in the marine reserve...

Therefore this rule being broken should help be grounds for the Attorney GENERAL TO INVESTIGATE, REVIEW, AND PURSUE ALL APPLICABLE CIVIL CLAIMS AND CRIMINAL CHARGES AGAINST THE OWNER AND COMMERCIAL OPERATOR OF THE YACHT "NAKOA".

I hope the AG can grip its teeth into this to get what the state can financially, even criminally against Mr. Jones. Ignorance should not be a means of going unpunished.
