# HOUSE CONCURRENT RESOUTION NO. 65 REQUESTING THE DEPARTMENT OF AGRICULTURE TO DEVELOP A CERTIFICATION PROCESS FOR HUNTERS TO BECOME CERTIFIED INSPECTORS IN ORDER TO INSPECT THEIR OWN GAME FOR SALE.

Chairpersons Hashem and Members of the Committee:

Thank you for the opportunity to testify on House Concurrent Resolution No. 65 requesting the Department of Agriculture (DOA) develop a certification process for hunters to become certified inspectors in order to inspect their own game for sale. DOA does not support this measure. Meat inspection and processing for sale involves more than post-mortem examination for food safety.

The state of Hawaii does not have a state meat inspection program. Therefore, the state does not have facilities, staff or resources to train and certify individuals for this competency. As a result, all Federal Meat Inspection Act (FMIA) inspected facilities within the state are governed by USDA/FSIS inspection, regulations and guidance as to the facility and practice requirements. However, deer meat is not under the FMIA like beef and falls under voluntary inspection by USDA/FSIS. Game meat for sale must be inspected antemortem, before being

killed, in addition to postmortem by FSIS. To sell game meat a FSIS inspector must accompany the hunt and observe the kill. In addition, the carcass and slaughter/processing facility must be inspected by FSIS where the game is being processed. This is to ensure proper handling for food safety. It is not just a matter of training as an inspector. In addition, FSIS inspector training involves more than gross anatomy but knowledge of regulations, food security, post-mortem disposition, pathology, food microbiology, humane handling and slaughter to list a few. For example, a government meat inspector certification is acquired through instruction, on the job training, a series of validated competency examinations and on-the-job evaluations.
