In Consideration of HOUSE CONCURRENT RESOLUTION 79 REQUESTING A WORKING GROUP TO BE CONVENED TO MAKE RECOMMENDATIONS TO PREVENT THE RE-OCCURRENCE OF WILDFIRES ON WAAHILA RIDGE NEAR THE UNIVERSITY OF HAWAII AT MANOA.

House Concurrent Resolution 79 requests a working group to be convened to make recommendations to prevent the re-occurrence of wildfires on Waahila Ridge near the University of Hawaii at Manoa. The Department of Land and Natural Resources (Department) offers comments on this measure.

Three fires have occurred in recent history on Waahila Ridge that the Department's Division of Forestry and Wildlife (DOFAW) firefighters along with Honolulu Fire Department (HFD) have responded to. The first in 2007 burned 36 acres, the second in 2017 burned 1.5 acres, and the third in 2020 burned 54 acres. There was an additional fire in the area in 2015 that HFD responded to without DOFAW's assistance. The landownership of Waahila Ridge is divided between the University of Hawaii at Manoa (UHM), Honolulu Board of Water Supply (BWS), DLNR-DOFAW, and various private residents. The Ridge is dominated by nonnative, fire-adapted trees and shrubs. The Ridge is accessed by the public frequently, though technically not legally, from Dole Street. There are hikers and mountain bikers that frequent the area, as well as vagrants that have camps in various sites on the Ridge. Wildland fire ignitions have occurred from these camps. While the Department's staff can serve citations to illegal campers on the Department's land, it cannot enforce trespassing rules on UHM, BWS, or private residential land, where campers frequently move to avoid a citation.

The working group called for in this resolution would convene legislative representation, a Department representative, a member of the community living in the area, and a fire expert from the Pacific Fire Exchange. The Department recommends that representation from UHM, BWS, HFD, as well as a representative of the Department of Human Services be included. In addition, public recreational advocacy interests, i.e., hiking and biking, should be represented. The Department agrees that it should participate in this working group to determine feasibility, advisability, sufficiency, and responsibility when it comes to wildland fire and hazardous fuels management on public lands.
