Testimony on HCR93

In this testimony, I argue that the best option for the city is to turn empty lots into green spaces/infrastructure for the community. Here are three main points:

- 1) Green infrastructure can be more effective and resilient than gray infrastructure.
- 2) Green spaces reduce crime.
- 3) Green spaces increase the value of neighborhoods and cities.

To maintain and improve the resilience of Honolulu, it is essential to implement decisions that take into account the dynamic nature of our current environment. This past year has shown us a glimpse of future conditions under a warming climate. With recordsetting rainfalls flooding many parts of the island, these events threaten to destroy Honolulu's coastline through erosion and pollutionⁱ. Scenes such as this one picture below will become more



common; rains fall too fast for soil to absorb, which results in large amounts of water washing over the city surface, picking up garbage and pollution as it flows. These polluted waters go straight into the ocean, choking out the area coral reefs, polluting beaches, and damaging infrastructure in the processⁱⁱ. This problem is an opportunity for Honolulu to become a model for a resilient and sustainable community. (*Picture Above - pollution in Ala Wai Canal, source: staradvertiser.com*)

Cities are reliant on traditional "gray" infrastructure - a system of gutters, pipes, and tunnels used to transport stormwater through the city. However, when compared to green infrastructure, these systems are less capable of adapting to future uncertainty in the context of population growth and more frequent severe weatherⁱⁱⁱ. Green infrastructure, which includes parks, rain gardens, and other natural spaces, provides natural filtration and absorption of excess rainwater^{iv}. They also contribute towards healthier air and water quality. Community green spaces, such as garden co-ops, can cost very little to build and are successfully maintained by co-op fees and volunteer work hours. Parking lots and other infrastructure on the other hand can cost millions to build, contribute towards the heat island effect of cities, and contribute towards

noise pollution and more opportunity for property crimes. Many studies have shown that welldesigned green spaces contribute towards a lower crime rate^v. They help establish a better sense of community and provide places for people to exercise and improve mental and physical health^{vi}. This is especially useful for lower-income individuals who may be more reliant on social health programs, which ultimately come from city resources. Finally, people simply value green spaces; a building or community next to a park is worth more to everyone. Families with children, young active adults, retirees.

There are a plethora of resources to support building green spaces. The EPA provides a tool kit for implementing green infrastructure, and similarly, there are grants for green spaces from organizations ranging from the EPA to The Arbor Day Foundation, and the Garden Club of America:
