DEPARTMENT'S POSITION: The Office of Youth Services (OYS) appreciates the resolution's intent and offers comments.

<u>PURPOSE</u>: The purpose of these resolutions is to urge the Office of Youth Services to develop an inventory of programs that work with Pacific Islander youth and their families.

OYS appreciates the Legislature's commitment to providing resources for Hawaii's youth at risk recognizing the over-representation of Pacific Islander youth in our juvenile justice and child welfare systems.

The OYS supported session measure HB 438 RELATING TO YOUTH PROGRAMS, which provided a coordinator within OYS and funding to establish an inventory of programs and provide awareness and coordination of community-based services for Pacific Island youth and their families. The OYS annually <u>reports</u> to the Legislature on the programs it currently provides to the community. OYS is also working with community stakeholders and providers on new initiatives at Kawailoa Youth & Family Wellness Center that may inform additional program development for Pacific Island Youth. As OYS does not have additional resources or staff to

<u>COMMENTS ON HCR 71/HR 72 URGING THE OFFICE OF YOUTH</u> <u>SERVICES TO DEVELOP A LIST AND INVENTORY OF PROGRAMS</u> <u>THAT WORK WITH PACIFIC ISLANDER YOUTH AND THEIR FAMILIES</u>

Hawaii Youth Services Network, a statewide coalition of youth-serving organizations supports the intent of HCR 71/HR 72 Urging the Office of Youth Services to Develop a List and Inventory of Programs that Work with Pacific Islander Youth and Their Families

Hawaiian and Pacific Islander children and youth are consistently overrepresented in the juvenile justice and child welfare systems and among homeless youth. They have higher risks for poor educational and health outcomes. The need and deserve initiatives to identify and implement effective approaches.

Compiling a statewide directory of programs that work with Pacific Islander youth and their families is only the first step. The information is dynamic so a system to regularly update the data will be needed. Outreach and awareness campaigns to reach potential users – community members and service providers – will be needed. To effectively reach Pacific Islanders and Native Hawaiians, materials will have to be available in multiple languages and accessible formats.

All of this requires time, funding, and dedicated staffing..

Hawaii Youth Services Network recommends an amendment to the resolution to require the Office of Youth Services to develop a plan and budget for collecting and maintaining data on programs and resources for Pacific Islander youth and their families with the intent of funding the implementation of the plan in the 2024 legislative session.
