SB 1281 RELATING TO THE HAWAIIAN HOMES COMMISSION ACT

Aloha Chair Shimabukuro, Vice Chair Keohokalole, and members of the Committee:

The Department of Hawaiian Home Lands (DHHL) submits comments on this bill that requires DHHL to release to beneficiaries of the Hawaiian Homes Commission Act, 1920, quarterly reports that contain certain information on leases and fiscal matters.

DHHL prepares extensive reports on a monthly basis that can be accessed through DHHL's website. An example from January 2022 can be viewed here: https://dhhl.hawaii.gov/wp-content/uploads/2022/01/January-18-19-2022-HHC-Packet.pdf. These reports include but are not limited to the following:

- Homestead Lease & Application Totals and Monthly Activity Reports
- Delinquency Report Statewide and Delinquency Ratio Report by Island
- Consents to Mortgages for FHA, VA, USDA RD, HUD184A, and conventional loans
- Ratification of Loan Approvals
- Homestead Application Transfers/Cancellations
- Certification of Applications of Qualified Applicants
- Approval of Designation of Successors
- Approval of Assignment of Leasehold Interest
- Approval of Amendment of Leasehold Interest
- Approval to Issue a Non-Exclusive License for Rooftop Photovoltaic Systems for Certain Lessees
