In consideration of S.B. 1322 RELATING TO THE HAWAII HOUSING FINANCE AND DEVELOPMENT CORPORATION.

The HHFDC <u>opposes</u> S.B. 1322, which places the DHHL Chairperson on the HHFDC Board. Not knowing the intent of the bill, we believe that the current collaboration between HHFDC and DHHL on areas of mutual interest and benefit is far more productive. HHFDC has partnered with DHHL on the development of water infrastructure to support housing development in Lahaina, Maui and North Kona, Hawaii. HHFDC is providing \$10 million in DURF funds for a Honokowai well to facilitate housing development by DHHL and HHFDC in Leiali'i, Maui.

HHFDC is also partnering with DHHL for the development of North Kona wells (Keopu Well – Well no. 4 and/or Ota Well) that will benefit their project in the Villages of La'i'opua. HHFDC also regularly collaborates with DHHL on the Hawaii Housing Planning Study.

Aloha Chair Shimabukuro, Chair Chang, and members of the Committees:

Thank you for the opportunity to testify in support of SB 1322, which designates a seat for the Department of Hawaiian Home Lands (DHHL) on the board of the Hawaii Housing Finance and Development Corporation (HHFDC).

HHFDC is tasked with developing and financing low- and moderate-income housing projects and administering homeownership programs. The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u> SB1322, which establishes a seat for the Chairperson of the Hawaiian Homes Commission (HHC) or their representative, on the Hawai'i Housing Finance and Development Corporation (HHFDC) Board of Directors.

The Department of Hawaiian Home Lands (DHHL) and HHFDC have similar missions insofar as they relate to the development of housing opportunities, for native Hawaiians and for other state residents. Accordingly, both agencies currently collaborate on multiple projects to achieve their shared housing-related goals. For example, HHFDC has specifically partnered with DHHL on the development of water infrastructure to support housing development in Lahaina, Maui, and North Kona, Hawai'i. In addition, HHFDC also provides \$10 million in Development Unit Revolving Fund monies for a Honokōwai well to facilitate housing development with DHHL and HHFDC in Leiali'i, Maui.

This measure may further enhance the partnerships and collaboration between HHFDC and DHHL. As a voting member of the HHFDC Board, the HHC Chairperson can better advocate for DHHL's beneficiaries in the Board's decision making process, and ensure that both agencies remain aligned in their partnerships and joint initiatives. The HHC Chairperson can also bring new perspectives and ideas developed through the DHHL's activities and experiences, to the HHFDC Board's deliberations.

Accordingly, OHA urges the Committees to **PASS** SB1322. Mahalo nui for the opportunity to testify on this measure.

The existing HHFDC board composition includes qualified members of the public that have knowledge and expertise in the public or private financing and development of affordable housing.

As a practitioner in the development and management of affordable housing for the past three decades, I can attest that HHFDC's board members from the private sector have provided practical experience and perspective that have been critical in the development of housing that is critically needed in our community. The replacement of one of these seats with the DHHL chairperson would seem to dilute this valuable knowledge base for the HHFDC board of directors.

Dear Chairperson Shimabukuro & Vice Chair Keohokalole of the Committee on Hawaiian Affairs, and Members; Chairperson Chang & Vice Chair Kanuha of the Committee on Housing, and Members:

Thank you for the opportunity to provide testimony in support of **SB 1322** relating to placing the Chairman of the Hawaiian Homes Commission on the Board of the Hawaii Housing Finance and Development Board (HHFDC).

The Department of Hawaiian Home Lands (DHHL) is the primary state entity established pursuant to our State's Constitution tasked with carrying out the purpose and mandate of the federally passed Hawaiian Homes Commission Act of 1921. As part of Hawaii becoming a State, it agreed to incorporate the HHC into the State Constitution. Today, with over 28,000 native Hawaiian beneficiaries on DHHL's waiting lists, it is apparent and very clear that the State must do all that it can to move the program forward. Development and constructing affordable housing is the overwhelming challenge for DHHL and the State. HHFDC manages and awards the Federal and State Low-income Housing Tax Credits, Hula Mae Bonds, Rental Housing Revolving Fund, Dwelling Unit Revolving Fund (DURF), and National Housing Trust Fund – all critical and necessary funding sources necessary for any serious and successful affordable housing projects. DHHL and their developers are required to compete for these funding sources. Without any input and decision making authority relating to this HHFDC Board, it makes it very challenging to move DHHL projects forward. With a say and representation on this Board, DHHL would be in a better position to move its housing projects forward.

I urge you to please pass measure SB 1322 out of your committees.
