Aloha Chair Ichiyama, Vice-Chair Poepoe, and members of the committee:

I am James Barros, Administrator of the Hawai'i Emergency Management Agency (HI-EMA).

The HI-EMA provides written testimony to SUPPORT Senate Bill 1469 SD1.

SB1469 SD1 appropriates funds for the development of the First Responder Technology Campus and Cybersecurity Data Center. When complete, the campus would provide facilities serving multiple agencies, including our own.

The existing headquarters complex for HI-EMA at Diamond Head dates to World War I, which creates complications and costs that impact our ability to fulfill our mission. In addition, relocating HI-EMA's headquarters would reduce the potential for conflicts between our operations and the recreational uses of the State park inside the Diamond Head crater, which draw daily crowds of residents and visitors.

HI-EMA has been the beneficiary of federal and State funding that has advanced the design process that ultimately could deliver a new State Emergency Operation Center, with the eventual site envisioned at the First Responder Technology Campus. The campus site is situated out of the hurricane and tsunami inundation zone and would enable a more flexible, resilient and modern approach to emergency management. We ask for your support of this bill, provided that its passage does not replace or adversely impact priorities indicated in our Executive Budget.

The HPD has concerns regarding Senate Bill No. 1469, S.D. 1, Relating to the First Responders Technology Campus and Cybersecurity Data Center.

While the HPD supports the efforts of state law enforcement and first responder agencies to create shared training and data storage facilities, we are concerned about our expected contributions to the facility. The HPD does not have the necessary funding to meet our financial obligation for the infrastructure and maintenance of this facility.

We currently have the facilities, including a training facility, indoor firing range, emergency vehicle operation training track, helicopter hangar, and technology storage facilities, this bill proposes to create. The Honorable Linda Ichiyama, Chair and Members March 14, 2023 Page 2

Additionally we are concerned about the security of this facility, as a troubled youth diversion program is planned for the same area.

Lastly, this proposed facility would be a local military-controlled airspace that would impact helicopter operations when the military places restrictions on airspace usage.

Aloha, Chair Ichiyama, Vice Chair Poepoe, and Committee Members:

The Environmental Caucus of the Democratic Party of Hawai'i has an enrolled membership of 7,500 voting residents here in Hawai'i. **We strongly oppose SB 1469**, which would start the funding of an immense facility for a First Responders Training Campus for 19 state and federal agencies including police, the FBI, and Homeland Security on 243 acres of agriculture land in the Mililani area. It would cut down hundreds of acres of existing forest that is an environmentally important carbon sink, and replacing it with a virtual CITY of facilities.

The bill would authorize \$100 million in State funds, \$50 million in each of the two years of the 2024-2025 biennium, which supposedly will be matched by some \$300 million or more in federal funds. And we fully expect that this cost estimate will be quickly and substantially increased, just like the Honolulu Rail.

This proposal has been quietly lying around since 2017, and already has been through a poorly noticed EIS process. Simply put, this proposal is massive OVERKILL, and is seriously detrimental to the public interest. The stated rationale for this proposal is to relocate and consolidate law enforcement and first responder facilities in a location that will be secure from sea-level rise and other deleterious effects of climate change. Details of the proposal include:

• A new well for water use (estimated at 249,700 gal/day, plus an additional 228,600 gal/day of non-potable water for an onsite fire-fighting training facility);

- Wastewater infrastructure to process an estimated 1,018,215 gal/day,
- Electrical infrastructure;
- A 2,000-space parking garage;
- A privately developed hotel/dormitory;
- A vehicle wash facility;

- A fitness center and pool;
- Warehouses;
- Office buildings; and
- An indoor shooting range.

None of these facilities will help us prepare for impending disasters coming our way very soon – if not already here (coral reef bleaching and sea-level rise have already started) – due to climate change. We need attention to an entirely different set of societal goals for our State, including but not limited to: genuinely affordable housing, vital public infrastructure upgrades, more effective management of our shoreline, preservation and restoration of our coral reefs, promotion of sustainable local food production, and transition to full green, renewable energy sources.

With regard to the House companion to this bill, HB 1493, your colleagues on the House Committee on Higher Education and Technology noted that the companion bill (exactly like the present SB 1469) suffers from some major defects. The committee stated:

Your Committee finds that, under section 206M-2(a), Hawaii Revised Statutes, the Hawai'i Technology Development Corporation's statutory purpose is to "facilitate the growth and development of the commercial technology industry in Hawaii." It is unclear whether the first responder's training campus aligns with such purpose. Although involved agencies will use cybersecurity technology, the campus does not appear to proactively develop local commercialized innovation research and technology industries. If the use of technology is sufficient to justify Hawai'i Technology Development Corporation's involvement, that would significantly broaden the Corporation's mandate.

The Hawaii 2050 Sustainability Plan: Charting a Course for the Decade of Action (2021) identifies eight focus areas for this decade, each of which includes specific strategies and examples of actions that can be taken to advance the State's environmental, social, and economic sustainability objectives. None of the thirty-eight strategies identified in the existing Hawaii 2050 Sustainability Plan (2021) mention any urgent need for a massive two hundred forty-three acre first responders' campus. With limited social, economic, and political resources, <u>the investment necessary for this kind of project is</u> of questionable benefit and would seem to be a low priority in terms of the work the State needs to do to advance sustainability and climate resiliency objectives.

Your Committee also notes that this project still needs to go through the State Land Use Commission process.

On behalf of the Environmental Caucus, we urge you in the strongest possible terms to defer SB 1469. <u>This is an extremely bad bill</u>. The entire proposal needs to be either abandoned completely or at least taken back to the drawing boards and seriously down-sized. (The infamous "Cop City" in the Atlanta area, which is very similar to this proposal, is planned to use only 85 acres – only one-third of the Hawai'i proposal, and Georgia has much more land than we do.)

We thank you very much in advance for your favorable consideration of our request to kill this bill.

On behalf of Our Revolution Hawaii's 5,000 members and supporters statewide, we stand in STRONG OPPOSITION to passage of SB1469 that appropriates funds for the development of the First Responders Technology Campus and Cybersecurity Data Center.

First the Hawai'i Technology Development Corporation's statutory purpose is to "facilitate the growth and development of the commercial technology industry in Hawai'i" and to develop a "local, commercialized innovation research and technology workforce." By this definition the proposed First Responders Technology Campus and Cybersecurity Data Center's detailed description as stated in SB1469 does not fulfill the Hawai'i Technology Development Corporation's statutory purpose, because it will not facilitate the growth and development of the commercial technology industry nor will it develop a commercialized innovation research and technology workforce.

Second the proposed project would include: a new well for water use (est. 249,700 gal/day, plus another 228,600 gal/day of nonpotable water for an onsite fire-fighting training facility), and wastewater infrastructure to process an estimated 1,018,215 gal/day. At a time when the island of Oahu is already experiencing a drought due to the effects of the growing Climate Crisis that may continue for years, and a water contamination crisis as a result of the Navy's Red Hill Bulk Fuel Facility that may permanently close down some of our wells, our aquifer simply cannot sustain the project.

We encourage you to do the right thing and vote no on SB1469

The Waikakalaua name means "rough water (in) the rain." In 2014, the Hawai'i State Legislature appropriated funds for the acquisition of Parcel 057 and an adjacent parcel within Waikakalaua Gulch (Parcel 039) to create the FRTC on agricultural land.

The earliest description of the First Responder Technology Campus sounded like a good idea. It is really revealing that according to the Final EIS just released, the FRTC is planned to grow into a massive military-police facility to survive Cat 4-5 storms, nuclear war, with off grid utilities.



The Final EIS was just released a few days ago with much greater details that are surprisingly extensive, mostly unknown to the general Hawaii public and completely unreported by Hawaii news media. The FEIS sounds much more like a US Midwest millionaire's survivalist bunker compound for top Hawaii Insiders to survive, while the Hawaii public is told to try and survive the net big disaster however they can. This will be a mass tragedy as insiders save themselves.

I believe most the of the public is unaware of how different the Master Plan is from what was originally described as a "responder campus." It will be surrounded by guard towers, an arsenal of weapons and connected to miles of massive huge underground bunker tunnels for 2 1/2 ton military trucks, originally built in WW-II for surviving massive bombing and enemy invasion.

While politely called a "Responder Campus" some have recently compared the FRTC to "Cop City" in Atlanta, GA. However, unless "Cop City" also has a secret master plan unknown to the community, the Mililani FRTC will be even massively bigger in scale and scope according to its FEIS Master Plan. Some have also questioned WHY the State High Technology Development Corporation is behind this. This actually seems more like a well schemed out "under the radar" project that largely hides and masks its real plans and objectives, including being connected to miles of massive huge underground bunker tunnels for 2 1/2 ton military trucks.

In 2018 and during some large hurricane close calls, there were a lot of news media stories (see below) about the lack of safe public shelter for mega hurricanes or nuclear war. The City and State said this would all be too difficult and take too long - yet then it seems plans began for the Mililani "First Responder Technology Campus" with "responder" plaza, office buildings, etc; which will become a mega hurricane nuke war facility for top City and State insiders. Construction will begin with an extension of Kahelu Ave through Parcel 057 up to Parcel 039.

The Master Plan of the FRTC also starts to really look like the West Virginia Green Briar secret bunker facility built in the 1950's for the US Congress and the secret nuke war bunker facility revealed in a book called "Raven Rock". (see below)

While FRTC FEIS doesn't specifically state going this far it is amazing how the plan of "build it and they will come" could see more and more State money poured into it, and then Federal money, since the Master Plan says it will also be the survival HQ for the FBI, Homeland Security, and then on and on Federal agencies that want survival bunkers for their senior management.

By they way I grew up in a military family with my father directly involved in command and control of nuclear armed weapons and who was directly involved in the design of the NORAD facility in Cheyanne Mountain, Colorado in the early 60's. I remember the "duck and cover" days really well and believe we all better start learning mass disaster survival skills again.

The FRTC high security compound facility will have features that rival many millionaire survivalist underground bunkers being constructed in the central US in former ICBM missile silos. These are designed to survive major climate change disasters, deadly plagues, nuclear war scenarios, etc. This will be where top politicians and officials will go to survive a massive disaster. The public will not have any access and will be left to survive however they can under desolate disaster conditions. Secure and well fed the top bureaucrats will emerge when safe.

The FRTC FEIS Master Plan expects top City, State and Federal agencies including: FBI, Homeland Security, National Guard, DBEDT, HTDC, State DOT, DLNR, DAGS, EMS, State and City Civil Defense will all survive the mega climate change storms, mega hurricane or nuclear war along with (maybe) their families. Gov Green will be there also but maybe not all City and State legislators will make it in. Coin flip maybe? Money or political influence buys the way in?

The FRTC FEIS Master Plan says individual condominium units can be leased or sold in fee to the responder agencies. They will be exempt from DPP County subdivision requirements as to size, configuration, and zoning lot size limitations. Basically whatever anyone wants or can afford. Maybe they will also have millionaire features like movie theaters, game rooms, spas, etc. Servant workforce housing will include 400 to 500 studio and one bedroom units. A well will also be drilled on Parcel 057 to provide dedicated water for the FRTC security compound .

The FRTC FEIS Master Plan says there will be P3 private development of a hotel for visitors and overnight accommodations. The hotel is anticipated to have an approximate 150-bed hotel occupancy. Survival For City-State Insiders, months of food supplies, EMS medicines, weapons, pistol and rifle gun ranges, recreational facilities, Olympic swimming pools, underground parking, a high speed race track, storage for high security sensitive materials (?), etc.

In event of an approaching massive hurricane or missile launches top politicians and families can arrive by car or helicopter to escape to their secure condo apartments, knowing massive miles of deep underground tunnel bunker warehouses are packed with supplies to survive weeks and months. Sealed gates manned by armed guards with special weapons.

The FRTC FEIS Master Plan says the project plans to solicit P3 partners in luxury hotel and mega disaster bomb bunker business - likely including the multinational disaster bunker corporations like <u>https://www.terravivos.com/</u>

First Responder Technology Campus FEIS May, March, 2022, 2023, Feb 7, 2023 April 29, 2022 (?) Project (has numerous confusing dates, hiding the secret massive miles of tunnel bunkers.) Located next to Wheeler Army Airfield and nearby top secret DoD Signals Intelligence facilities. Campus have urban warfare village (swat house with simulations), warehouses with climate control restricted access, (due to the nature of the items?) HPD also requires additional space for their armory, tactical supplies, and equipment, including all terrain vehicles (ATVs), utility terrain vehicles (UTVs), vans, jet skis, watercrafts, trailers, Also towers for communications, observation towers, radio tower (microwave and satellites), cellular tower, emergency warning siren equipment (?), etc.

In 2014, the Hawai'i State Legislature appropriated funds for the acquisition of Parcel 057 and an adjacent parcel within Waikakalaua Gulch (Parcel 039) to create the FRTC. Parcel 039 is massive underground bunker tunnel complex large enough to drive fully loaded 2 1/2 ton Army trucks. Massive Mililani Army concrete ammunition tunnels estimated to total at least 16 miles.

The facility will survive the highest anticipated sea level rise, mega tsunamis and massive mega hurricanes as well as nuclear missiles. The nuclear missiles could be ballistic or hypersonic, which is likely why China is measuring the upper atmosphere with balloons and green laser firing satellites over Hawaii, to improve their accuracy. Those that survive at the "First Responder Technology Campus" will inherit what remains of Oahu Island and the Neighbor Islands. A Noah's Ark for top government bureaucrats.

A huge multi-story parking structure is proposed to serve most of the parking and vehicle storage needs for the FRTC. The parking structure would be located on the north portion of the site and is anticipated to be approximately five-stories high, with a basement level below-grade. The shared fitness facilities will include amenities such as weight rooms, mat rooms, shower and locker rooms, and a competition pool. The weight and fitness rooms and competition pool will be in the basement of the parking structure, located on the north portion of the site.
