S.B. 2008, S.D. 1, H.D. 1 RELATING TO HIGHWAYS

House Committee on Judiciary & Hawaiian Affairs

The Department of Transportation (DOT) **supports** this bill that allows the state and counties to apply flexibility in highway design pursuant to section 264-20 to privately owned roads that have been condemned. Additionally, this measure will provide immunity from joint and several liability of the state and counties for acts or omissions that occurred prior to the condemnation.

This measure reduces risk to government agencies when condemning roads that may not have been well maintained or may have environmental challenges that must be addressed. Assessments and or mitigations could take years. However, as DOT has not utilized this provision of law to condemn privately owned roads and has no plans to do so in the short term, we have no information or data to indicate whether this measure would facilitate more condemnations by the state.

S.B. 2008, SD1, HD1 - Relating to Highways Councilmember Carol Fukunaga, Chair Committee on Public Infrastructure and Technology

Thank you for the opportunity to submit written testimony in strong support of *Senate Bill 2008, SD1, HD1*, which would allow the State and counties to apply flexibility in highway design. It clarifies that the State and counties shall not be held jointly and severally liable for acts or omissions relating to a condemned road that occurred prior to condemnation.

There are numerous examples of roadways in which ownership may be unknown, or whose private ownership prior to State or County condemnation or acquisition actions resulted in lengthy delays in resolution of ownership and jurisdictional issues, before city and state agencies could undertake rehabilitation and reconstruction to provide safe vehicular travel on such roadways.

For example, in central Kaka'ako, where the Kaka'ako Land Company (KLC) asserted ownership claims over such industrial roadways as Queen Street (between Punchbowl Street and Ward Avenue), Kawaiahao and Waimanu Streets, City and State legislators have had to adopt numerous measures during the past 7-8 years to address long-term maintenance and public safety needs of abutting businesses and residential property owners:

- 1. **Resolution 16-213, CD1, FD1-** Providing for the Acquisition of Land for Public Use, to wit: Public Streets, situate at Kaka'ako, Honolulu, Oahu, Hawaii, and Determining and Declaring the Necessity of the Acquisition Thereof by Eminent Domain (adopted by Honolulu City Council on December 1, 2016).
- 2. Act 203, Relating to Highways Requires each county with a population of over five hundred thousand or greater to take jurisdiction over all disputed roads under certain circumstances, and establishes a definition of 'disputed roads.' (Passed State Legislature on May 2, 2017; became law without Governor's signature on July 12, 2017).
- 3. **Resolution 19-291, CD1** Requesting the City Administration to Expedite the Eminent Domain Proceedings to Acquire Certain Portions of Waimanu Street and Kawaiahao Street in order to Acquyire Certain Portions of Waimanu Street and Kawaiahao Street in Order to improve the Flow of Traffic and Protect the Access, Health and Safety of Residents of Abutting Properties and First Responders (adopted by Honolulu City Council on December 14, 2019).

- 4. **Resolution 19-292** Resolution Urging the City Administration to Repair and Enforce City Laws on Certain Portions of Waimanu and Kawaiahao Streets in Kaka'ako, Honolulu, in order to protect the Access, Health and Safety of Motorists and First Responders (adopted by Honolulu City Council on December 14, 2019).
- Resolution 20-194 Providing for the Acquisition of Land for Public Use, to wit: Waimanu Street (between Ward Avenue and Kamakee Street), situate at Kewalo, Honolulu, Oahu, Hawaii, and Determining and Declaring the Necessity of the Acquisition therof by Eminent Domain (adopted by Honolulu City Council on September 9, 2020; approved by Mayor on September 17, 2020).
- 6. **Resolution 20-195** Providing for the Acquisition of Land for Public Use, to wit: Waimanu Street (between Dreier Street and Ward Avenue), situate at Kewalo, Honolulu, Oahu, Hawaii, and Determining and Declaring the Necessity of the Acquisition thereof by Eminent Domain (adopted by Honolulu City Council on September 9, 2020; approved by Mayor on September 17, 2020).

As of today, long-term ownership and repaving of the streets identified in the foregoing listing remains unresolved while City and State agencies take temporary steps to authorize city agencies to repair potholes.

Senate Bill 2008, SD1, HD1 would offer a far more practical means of addressing public safety and access issues involving older urban Honolulu roadways. I therefore urge your favorable consideration of this bill.

My name is Evan Oue and I am presenting this testimony on behalf of the Hawaii Association for Justice (HAJ) in **Support** of SB 2008, SD1, HD1 - Relating to Highways.

HAJ supports the intent of this measure as it provides the State or counties flexibility in highway design to repair or maintain a condemned road, which is urgently needed for many of Hawaii's roadways. HAJ also appreciates the amendments made in the HD1 version of SB 2008. Immediate repairs may be difficult if the government does not have sufficient funds to repair or maintain these roads. However, the current 3-year grace period should be preserved for planning, budgeting and construction of condemned roads, but an unlimited period of exemption from liability on these roadways would not be in the best interest of Hawaii citizens. This procedure at least assures that there is an incentive for the government to repair the most dangerous roads as quickly and as feasibly as possible.

I live on Rawlins Lane and I've been hearing complaints almost every other day from my neighbors regarding our lane/private road. I've seen the difficulties of getting in the lane due to the unmaintained road because it's bumpy, rocky, and narrow for some who drives a truck. Another problem is our dump site, we noticed how other neighbors who don't reside on our lane dump their trash bags on our side and when they do that, it piles up and would make a mess which leads to us getting a lot of pests if not tied up properly. My grandma would always wake up around 8AM sweeping up on our dump site area to prevent more mess spreading on the road due to outside neighbors trash. If SB 2008 gets passed, this would resolve the issue that's been an ongoing thing for several years and would definitely increases the chances of getting our lane repaired.

My name is Hwa Ja Park, and our family has lived on Rawlins Lane for over 80 years, and throughout that time, the road condition has deteriorated greatly. Over the years, our family has tried to be good neighbors and we have filled in the more damaged areas with blacktop patch. In 2016, with my husband and son no longer with me, I hired someone to fill in some of the bigger holes near the entrance of Rawlins Lane with concrete, but due to the enormous cost, I could not fill the entire lane. I have tried to get abutting landowners to contribute to repave Rawlins Lane, but they are uninterested or do not have the monetary resources to do so.

I recently turned 91 and the uneven surface of Rawlins Lane makes it very difficult and dangerous for the elderly like me and the young children to pass safely. Please help us to improve this serious condition at Rawlins Lane and throughout the State by supporting and passing this measure with the contents of the SD1 version.
