S.B. 2105 RELATING TO RENEWAL OF DRIVER'S LICENSES

Senate Committee on Transportation

The Department of Transportation (DOT) **opposes** S.B. 2105, which would allow for the renewal of a driver's license by electronic or digital means without the requirement for a vision certification and other medical certification that the applicant is fit to operate a motor vehicle.

This is a serious safety concern for the driver, driving public and pedestrians. There are numerous cases as documented in the submittal of Medical Reports where the Department of Motor Vehicle staff will notice a physical condition that questions the applicant's ability to operate a motor vehicle. Removing the medical requirement will make it much simpler for an individual that should not be driving, due to a serious medical condition, to renew their driver's license.

DOT has no opposition to allowing for the inclusion of electronic or digital means to renew a driver's license as long as all requirements for mail renewals apply. It is important to note that renewing by mail, electronic or digital means will not be allowed for the applicant who is applying for an initial REAL ID driver's license at the time of renewal, the applicant has not renewed in-person for 2 consecutive renewals or 16 years or more has passed, or the applicant is renewing a limited-term REAL ID driver's license.

SUBJECT: S.B. No. 2105 - Relating to Renewal of Driver's Licenses

My name is Mark D. Wong, Director of the Department of Information Technology at the City and County of Honolulu. I am testifying in support of S.B. No. 2105 Relating to Renewal of Driver's Licenses.

For more than fifty years, the Department of Information Technology has been maintaining the systems that process the driver licenses and State IDs for the entire State of Hawaii. With an increase in population, additional requirements of the REAL ID Act of 2005, and most recently a global pandemic, we have seen county licensing operations strained to the breaking point.

In many states, websites and machine processing have reduced that long lines that are common at Hawaii's licensing offices. While the laws of these states and the federal government have been updated to acknowledge the need to provide alternatives to inefficient in-person transactions, Hawaii's laws have prevented much-needed modernization to its systems.

In a few days, the United States will begin accepting digital mobile driver licenses (mDL) at airport security checkpoints, an indication of the advanced level of technology being used in driver licenses. The federal government is allowing users to apply for the digital driver licenses from their mobile devices, yet HRS 286-107 still requires an applicant to appear in person.

I respectfully recommend amending HRS Section 286-107 to allow for any driver license transaction to be processed remotely, be it by mail or online, to the extent allowed by federal law.

The City and County of Honolulu, Department of Customer Services (CSD), Motor Vehicles, Licensing and Permitting Division, is in strong support of S.B. 2105 Relating to Renewal of Driver's Licenses.

CSD handles all requests and inquiries for new and renewals of Driver licenses as well as State Identification Cards for the island of Oahu. In FY2021, our Driver License clerks successfully processed 312,682 in-person applications during this current pandemic. 87,317 of those transactions were Driver License Renewals.

S.B. 2105 would provide the public with options to renew their Driver's Licenses online or through other electronic or digital means by bringing Hawaii's laws in alignment with new technologies that are available or in development. Electronic and online transactions have already become the new norm in our industry and are essential to providing the public with a modern registration system. This bill would enable the City & County of Honolulu to take advantage of the efficiencies and convenience of current and future innovations in the industry. Digital means to renew a Driver's License will give applicants an option to remain REAL ID compliant from home and avoid large crowds during our current conditions.

Chair LEE, Vice Chair INOUYE, and Members of the Senate Transportations Committee

Common Cause Hawaii provides comments on SB 2105, which allows for the renewal of driver's licenses online or by electronic or digital means.

Common Cause Hawaii is a nonprofit, nonpartisan, grassroots organization dedicated to reforming government and strengthening our representative democracy through voting modernization efforts such as adopting Automatic Voter Registration (AVR). AVR was passed by this Legislature in 2021 and signed into law as Act 126, SLH 2021.

Common Cause Hawaii provides comments inquiring as to how SB 2105 will interface with AVR, Act 126, SLH 2021. It is unclear, if a person is permitted to renew a driver's license online through electronic or digital means, the mechanism by which AVR will be extended to the person. Further, Section 5 of the National Voter Registration Act of 1993 requires that any motor vehicle driver's licensing transaction must provide an opportunity to register to vote. Such an opportunity, to be meaningful, should be part and parcel of and integrated with the licensing transaction.
