I am Bradon Ogata, Captain of the Legislative Liaison Office of the Honolulu Police Department (HPD), City and County of Honolulu.

Dear Chair Rhoads, Vice-Chair Keohokalole, and Honorable Committee members:

I serve as the President of the State of Hawaii Organization of Police Officers ("SHOPO") and write to you on behalf of our Union to express our strong <u>support</u> for SB2118. The bill will amend HRS §291C-194 and require a moped operator to have "immediate possession of a valid driver's license or instruction permit at all times."

We believe this amendment will eliminate any perceived ambiguity relating to the circumstances requiring a moped operator to have a driver's license in their actual possession while traveling on our public roadways. This bill will also assist our officers in their ability to accurately identify a driver who is stopped for a traffic violation in order to issue the appropriate written citation. In conducting patrol duties, our officers are involved in numerous traffic stops for various traffic infractions. Without observing an operator's driver's license and photograph, it is difficult for our officers to verify if the operator is really who they claim to be or is simply using a false name or alias. What often happens is the operator claims to have a valid driver's license but provides the officer with another person's name and personal information. The officer will run a license check in the computer system to confirm if there is a valid license under the name and personal information provided by the operator. However, if the operator gave a false name or false personal information, the system may confirm a valid driver's license but it would not be for the operator who gave the misleading information. The false information will also prevent the officer from running a valid warrant check on the driver. In our experience, drivers who do not have a valid driver's license often have outstanding arrest warrants and this holds true whether the person is operating a motor vehicle or a moped.

POSITION: In opposition to the passing of S.B. 2118.

Aloha All,

My name is Jor-El Isaac. I am a full-time student in the University of Hawai'i at Monoa Bachelors of Social Work program. I am writing in opposition for the following reasons:

Section 291C-194, Hawaii Revised Statutes, is amended by amending the title and subsection (a) to read as follows: "§291C-194 Driver's license possession; required. (a) No person shall drive a moped unless the person is in immediate possession of a valid driver's license or instruction permit at all times."

The right to travel is a "Liberty" of which citizens cannot be deprived without due process of law under the Fifth Amendment and Section 1 of the Fourteenth Amendment "No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws".

- According to Bouvier's Law Dictionary, 1856 A "driver must possess reasonable skills and be of good habits for the journey, because should an accident or injury occur; both the "Driver" and his "Employers" will be responsible. This would indicate that the driver is conducting commerce rather acting as a traveler on a journey.
- U.S. Supreme Court case Reno v. Condon decided on 12 January 2012 states "The activity licensed by state DMVs and in connection with individuals must submit personal information to the DMV (the operations of motor vehicles) is itself integrally related to interstate commerce.
- 4) Shuttlesworth v. Birmingham AL (1962) "If the state does convert your right into a privilege and issues a license and a fee for it. You can ignore the license and a fee and engage the right with full impunity".

Need of a Driver's license is a colorable action. A license is required only when conducting commerce. When a Citizen on the street cannot claim ignorance of the law there is no

judicial immunity. Therefore, this bill should be considered Unconstitutional as it violates the rights of Natural Citizens.
