Subject: Senate Bill 2125 Relating to Liquor Licenses

The County of Hawai'i Department of Liquor Control supports the adoption of SB 2125. The current fine amount has stood at \$2000 since 1987. While this may seem like a sizeable amount, in today's environment, our Liquor Adjudication Board reaches this maximum rather quickly and is only left with the option of a suspension or revocation of the liquor license, which are very severe penalties.

Thus, we feel that SB 2125 provides a good solution to both problems: it increases the penalties to provide the Liquor Adjudication Board with additional fining power; but at the same time, it allows a greater fine range, which gives the Liquor Adjudication Board more leeway before they must impose the greater penalties of license suspension or revocation. That is why we feel the licensees should understand that this amendment as proposed in SB 2125 works in their favor as well.

In consideration of Senate Bill 2125 Relating to Liquor Licenses

Honorable Chair Baker, Honorable Vice Chair Chang, and Members of the Committee:

I write in **strong support** of SB 2125 Relating to Liquor Licenses which serves to increase the maximum allowable fine for violation of liquor control laws by a licensee from \$2000 to \$5000. The current fees have been in effect since 1987, and as we move into 2022, the alcoholic beverage industry continues to evolve. At the same time, the methods of distributing and dispensing alcohol have also evolved creating new alcohol related offenses which could have a direct nexus to the licensed locations that are directly regulated by each respective Liquor Commission or Department.

We feel that an increase in the penalty amount limit, would permit the Liquor Commission a reasonable range of fines to adjudicate violations of the Hawaii Liquor Laws or Rules of the Commission. Currently, the fine maximum of \$2000 does at face value appear to be high, however offenses that have the probability of repeating within a short period of time would reach the maximum fine limit quickly leaving the only option for the Commission as a suspension or revocation of the liquor license.

Thank you for the opportunity to testify in support of this measure and again, we are in **strong support** of SB 2125.

Good morning Chair Baker and Vice Chair Chang of the Senate Committee on Commerce and Consumer Protection. I am Curtis Higashiyama, Manager of Government Affairs at ABC stores. I appreciate this opportunity to testify.

While we understand the intent, we are STRONGLY OPPOSED to SB2125 Relating to Liquor Licenses. This measure arbitrarily increases the maximum fine from \$2,000 to \$5,000 to grant flexibility in assessing fees to license holders.

We feel this would be overly punitive. In current law there are numerous deterrents available to mitigate violations. In the liquor laws there are numerous regulated items subject to violations and associated penalties. Stores have designated areas to sell liquor, if a store builds a floor stack of wines outside of the designated area, technically this is a violation. If a store does not have the mandatory sign up because a customer knocks it down, this technically is a fine. Individuals working for the licensee not following the liquor laws are also subject to punitive action. The individual must report to District Court for a charge of a full misdemeanor. A misdemeanor punishable by up to \$2,000 and/or 1 year in prison.

The Liquor Commission is a panel of judges with the flexibility to impose fines. For those who are frequent violators, they should receive the maximum fine to revocation. If as in the example above with a missing sign, we would defer to the judgement of the panel rather than the full fine. We would rather have due process.

There are different ways to get compliance to laws, not only through monetarily punitive actions. In one way, the Liquor Commission has the power to suspend or revoke a license. Other ways are through education, community outreach, and through enhanced enforcement of laws; programs that initiate or increase the frequency of compliance checks for laws against the sale of alcohol/tobacco to minors.

In our experience, deterrents based on education and warning, are better serving to get compliance. As a general rule, most licensees abide the law, honest, and do not deliberately break the law. We as a company understand the purpose of the Commission and the Commission should have the judgement to apply proper penalties. We thank you again for allowing us to testify.
