RELATING TO SCHOOL GARDENS

The Department of Budget and Finance (B&F) offers comments on this bill.

Senate Bill No. 2182, S.D. 1, establishes 1.00 full-time equivalent position for a school garden coordinator position within the Department of Education to provide technical support and startup resources for schools interested in starting a school garden program and appropriates an unspecified sum of general funds for FY 23.

B&F notes that, with respect to the general fund appropriation in this bill, the federal Coronavirus Response and Relief Supplemental Appropriations Act requires that states receiving Elementary and Secondary School Emergency Relief (ESSER) II funds and Governor's Emergency Education Relief II funds must maintain state support for:

- Elementary and secondary education in FY 22 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

Further, the federal American Rescue Plan (ARP) Act requires that states receiving ARP ESSER funds must maintain state support for:

- Elementary and secondary education in FY 22 and FY 23 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 and FY 23 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

The U.S. Department of Education has issued rules governing how these maintenance of effort (MOE) requirements are to be administered. B&F will be working with the money committees of the Legislature to ensure that the State of Hawai'i complies with these ESSER MOE requirements.

School gardents have been shown to improve student health and academic achievement, provide positive learning environments for teachers and students, increase students consumption of fresh fruits and vegetables, enhance the psychosocial development of youth and provide a valuable tool in educational engagement.¹ In 2019, 31% of Hawaii high school students were overweight or obese and in 2017, 28% of Hawaii middle school students were overweight. ^{2,3} Schools can play an integral role in changing behavior by shaping positive attitudes and beliefs about food as well as enhancing access to nutritious foods. In a national study across eight states, students in schools with more hands-on learning activities consumed three times the amount of fruits and vegetables than students who received less hands-on learning.⁴ School garden programs can provide the hands-on learning for students which includes activities such as cooking and gardening, talking to students about the benefits of eating fruits and vegetables, and how to incorporate more fruits and vegetables into their diet.

Aloha,

We're writing on behalf of the Food+ Policy Internship to express our SUPPORT for **SB2182**, Relating to School Gardens. Thank you for allocating time to read through our support for establishing a School Garden Coordinator within the DOE.

In order to take the next step in advancing Hawai'i towards a more sustainable and equitable food system, we must invest in our keiki and the education they deserve. Studies show that Hawai'i ranks 29th for youth with higher rates of mental illness and lower rates of access to care (2020). Gardens in schools will be able to address these mental health issues with outdoor space that works towards strengthening social-emotional wellbeing. We would like to see all schools benefit from garden spaces, but not all schools either have the capacity or the knowledge to implement such an opportunity.

By establishing the School Garden Coordinator position, we will have a dedicated professional who is tasked with providing technical support and startup resources for schools interested in a school garden program. Through conversations with teachers who run the Hōʻola Academy at Kapolei High School (2021), it is clear they have been educating their students using 'āina-based education. Many children who have a hard time learning in the classroom, due to a number of reasons, tend to thrive in garden settings. This is where they get to show what they know, and interchangeably be the kumu. This positive setting uplifts their mental wellbeing, cultivates autonomy, provides empowerment and skill building through garden spaces (2019). However, not all schools benefit the way Kapolei does, and we hope to change that by **SUPPORTING SB2182**.


