SUBJECT: MISCELLANEOUS, Doubles Fireworks Permit Fees

BILL NUMBER: SB 2185 SD1

INTRODUCED BY: Senate Committees on Commerce and Consumer Protection and Government Operations

EXECUTIVE SUMMARY: Doubles the fee required to obtain a consumer fireworks permit.

SYNOPSIS: Amends section 132D-10, HRS, to raise the fireworks permit fee from \$110 to \$220. All fees are earmarked to the emergency medical services special fund administered by the department of health and established under section 321-234, HRS.

Requires the Auditor to provide an annual report to the legislature.

EFFECTIVE DATE: January 1, 2023.

STAFF COMMENTS: Our comments relate to the earmarking of this fee to the EMS special fund.

In 2002, the Legislature set requirements for establishing and continuing special and revolving funds. Sections 37-52.3 and 37-52.4, HRS, now state that the criteria used to review special and revolving funds are the extent to which each fund:

- Serves a need, as demonstrated by the purpose of the program to be supported by the fund; the scope of the program, including financial information on fees to be charged, sources of projected revenue, and costs; and an explanation of why the program cannot be implemented successfully under the general fund appropriation process;
- Reflects a clear nexus between the benefits sought and charges made upon the program users or beneficiaries, or a clear link between the program and the sources of revenue—as opposed to serving primarily as a means to provide the program or users with an automatic means of support, removed from the normal budget and appropriation process;
- Provides an appropriate means of financing for the program or activity, that is used only when essential to the successful operation of the program or activity; and
- Demonstrates the capacity to be financially self-sustaining.

We are concerned that the new special fund clearly fails the second criterion and may fail other criteria as well. The establishment and intended use of the special fund as described subverts the appropriation process.

Good morning, Chairperson Dela Cruz and members of the Senate Committee on Ways and Means. I am Tina Yamaki, President of the Retail Merchants of Hawaii.

The Retail Merchants of Hawaii was founded in 1901, RMH is a statewide, not for profit trade organization committed to the growth and development of the retail industry in Hawaii. Our membership includes small mom & pop stores, large box stores, resellers, luxury retail, department stores, shopping malls, local, national, and international retailers, chains, and everyone in between.

We are opposed to SB 2185 SD1 Relating to Fireworks. This measure increases the fees for permits required for the purchase and use of fireworks. Requires the auditor of fireworks and articles pyrotechnic records for each county fire department to submit an annual report to the Legislature detailing inventory, recordkeeping, and sales of fireworks to license or permit holders. Effective 1/1/2023.

Raising taxes is not the solution to stop sales of illegal fireworks that include the aerials that we see lighting up the skies especially at new years. This bill would penalize wholesalers and retailers who are legally selling fireworks by imposing a new consumer fireworks tax. People with their fireworks permits who would normally come to our stores to purchase legal fireworks may look elsewhere like the black market where the fireworks would be a lot cheaper. We would also see more theft of fireworks as it would be a sough after high ticketed item.

We need to find solutions that are aimed directly at those selling illegal fireworks and not penalize retailers who sell legal fireworks.
