Kanu Hawaii is providing testimony in SUPPORT of SB2022 RECOGNIZING APRIL AS VOLUNTEER MONTH IN HAWAII.

April became National Volunteer Month as part of President George H. W. Bush's 1000 Points of Light campaign in 1991. This bill seeks to recognize Volunteer Month in the Sate of Hawaii. This request mirrors that of National Volunteer Month, which also encompasses National Volunteer Week (always in the month of April).

Although National Volunteer Week has been celebrated every year since 1974 by Presidential Proclamation, Hawaii only officially recognized the week beginning in 2018 when the legislature passed HCR153_SD1.

Through the support of that resolution in 2018, the community held over 60 events across 5 islands. Now, in its fifth year, Volunteer Week in Hawaii 2022 is being celebrated by over 200 organizations hosting over 250 events across 6 islands engaging thousands of volunteers.
