Hawai'i Health & Harm Reduction Center (HHHRC) <u>strongly supports</u> SB 2207, SD 1, which would add a representative of an LGBTQ+ focused organization as a member on the Hawai'i Interagency Council on Homelessness.

Representation matters. A key component of harm reduction is to include impacted persons in discussions around programs and policies designed to serve them. In this case, it is important to include the needs of trans and LGBQ persons experiencing housing instability, including unsheltered homelessness. Trans and LGBQ persons face range of minority stressors, including structural stigma and internalized shame, that can better inform the policymaking process around homelessness services delivery.

HHHRC Executive Director Heather Lusk currently serves as Board Chair of Partners in Care O'ahu, a planning, coordinating, and advocacy alliance that develops recommendations for programs and services to fill needs within O'ahu's continuum of care for homeless persons. HHHRC currently provides outreach and housing placement and navigation services for unaccompanied youth experiencing homelessness who are trans and LGBQ. We also helped to ensure that gender identity and sexual orientation were included the Point-in-Time survey of O'ahu's unsheltered homeless population.

HHHRC's mission is to reduce harm, promote health, create wellness, and fight stigma in Hawai'i and the Pacific. We work with many individuals impacted by poverty, housing instability, and other social determinants of health. Many have behavioral health problems, including those related to substance use and mental health conditions. Many of our program clients and participants have also been deeply impacted by trauma, including histories of physical, sexual, and psychological abuse.

POSITION: The Governor's Coordinator on Homelessness supports this measure.

PURPOSE: The purpose of the bill is to add a representative of an LGBTQ+ focused organization as a member on the Hawaii Interagency Council on Homelessness (HICH).

The Coordinator currently serves as Chair of the HICH, which is a 27-member advisory council, that advises on statewide planning and policy development with broad representation from state and county government and the community. Currently, there is no specific representation for the LGBTQ+ community on the council.

According to the Partners in Care Sexual and Gender Minorities 2020 Sub-Report¹ for the Oahu Point in Time (PIT) count, 94% of sexual and gender minorities experiencing homelessness on Oahu were unsheltered in January 2020. Sexual and gender minorities is an umbrella term that encompasses individuals identifying as LGBTQ+ and individuals whose sexual orientation or gender identity varies. The Partners in Care sub-report found that sexual

and gender minorities experiencing homelessness have higher rates of disabling conditions compared to the overall homeless population. For example, nearly half of sexual and gender minorities experiencing homelessness reported a physical, developmental, or other disability that impaired their daily life.

The addition of a representative from an LGBTQ+ focused organization would add value to the HICH. A designated representative would enable clear community feedback regarding the development of programs to better meet the unique needs of sexual and gender minorities experiencing homelessness.

If this measure proceeds, the Legislature may consider adjustments to the budget to support this addition of a new member to the HICH, as the addition of a new non-governmental member may add ongoing operational costs. Per section 346-382 (b), Hawaii Revised Statutes, non-governmental members of the HICH shall be reimbursed for expenses, including travel expenses, necessary for the performance of their duties.

Dear Senators,

The Hawaii Rainbow Chamber of Commerce has a mission to educate and advocate for the advancement of equality of economic and societal opportunities for Hawaii's LGBTQ+ community.

With this mission, we STRONGLY support that the Hawaii Interagency Council on Homelessness include adding a representative of an LGBTQ+ focused organization to be a member of that Council. As you are aware, many studies have shown a disproportionally high number of those experiencing homeless, whether youth or adults, identify as LGBTQ+, which presents an additional set of challenges and concerns. The LGBTQ+ homeless community needs to have dedicated advocacy on its behalf at all levels in working towards solutions.

Particularly concerning are the hugely disproportionate numbers, perhaps 40% of homeless youth, who identify as LGBTQ+ according to different surveys. These young people in particular face long-term consequences of homelessness and are at much greater risk in their mental and physical health, higher risk of sexual abuse and exploitation, and greater risk for drug and alcohol abuse, amongst other social concerns.

As these young people age, it has been found that they naturally experience lower levels of educational attainment, placing them at an even greater long-term disadvantage when they enter the job market with fewer formal skills and education. Growing up without the stable housing, supportive family structures and regular social support of course results in longer-term detrimental issues known by all in the field.

As various levels of government and nonprofits join together to work towards solving this complex issue, we ask that due to the disproportionately high numbers of people experiencing homelessness who identify as LGBTQ+ that a representative of an LGBTQ+ focused organization be a member of the Hawaii Interagency Council on Homelessness.
