1 Fiscal Implications: None

Department Testimony: Thank you for the opportunity to testify in support of SB 2241, which
would permit minors, as currently defined in §577A-1, HRS, "from the age of fourteen to
seventeen inclusive," to consent to medical care related to the diagnosis or prevention of HIV.
Parents or legal guardians would not be able to abrogate consent. The minor would not be liable
for payment. This measure would also update archaic terminology in §577A, HRS, by replacing
"venereal disease" with "sexually transmitted infection."

8 The department supports the intent of this bill as it could help prevent HIV acquisition in 9 minors and supports critical treatment of minors diagnosed with HIV. Safe, highly effective 10 medications for the treatment and prevention of HIV need to be accessible for all individuals 11 diagnosed with HIV or at high risk of acquiring HIV. Medications taken by an HIV-uninfected 12 individual to prevent acquisition of HIV are highly effective and were approved for use in 13 minors in 2018.

Current statutes do not appear to permit a minor to consent to medical care related to the prevention of HIV. This measure would resolve this critical gap. Permitting minors who cannot or will not seek the consent of their parents or guardians to consent to HIV medical care is essential to the health of the minor and a valuable step in ending the HIV epidemic in Hawaii.

Dear Chair Keohokalole, Vice Chair Baker and Members of the Comittee

The Hawaii Health & Harm Reduction Center (HHHRC) strongly supports SB 2241 which would give minors consent to life-saving HIV prevention medications called Pre-exposure Prophylaxis or PrEP. The Centers for Disease Control and Prevention strongly recommend PrEP as one of the most effective biomedical interventions to prevent HIV. The current HRS for minor consent does allow minors to consent to treatment of HIV and other sexually-related diseases but not have access to medications like PrEP to prevent the infections.

HHHRC respectfully asks for one important issue to be added to the bill, in collaboration with the health plans to ensure that if a minor does access PrEP and it is covered by the minor's parents' health insurance, that the services not be disclosed to the parents. Research indicates that if young people have to disclose sexually-related issue to parents, they may decide to avoid the services altogether. We respectfully submit this language:

Requiring a covered entity, upon notification that minor—initiated HIV prevention and/or PrEP services should not be disclosed, to maintain the confidentiality of minor—initiated HIV prevention and/or PrEP services.

HHHRC's mission is to reduce harm, promote health, create wellness and fight stigma in Hawaii and the Pacific. We focus our efforts on those disproportionately affected by social determinants of health, including but not limited to: people living with and/or affected by HIV, hepatitis, substance use, and the transgender, LGBQ and the Native Hawaiian communities.

HHHRC is one of the largest PrEP medical providers in the state and has had to turn away 17 year olds and other minors who wanted to learn about these effective prevention strategies. During COVID, there were HIV outbreaks on the continent and passing HB 1675 is one step to ensuring that Hawaii doesn't have unnecessary HIV infections that could have been prevented.

Aloha Chair Keohokalole, Vice Chair Baker, and fellow committee members,

I am writing in STRONG SUPPORT to Senate Bill 2241 on behalf of the Stonewall Caucus of the Democratic Party of Hawai'i (formerly the LGBT Caucus). SB 2241 will permit minors to consent to medical care related to the diagnosis or treatment of HIV or the prevention of HIV. - PrEP is a safe, FDA-approved daily medication proven to prevent HIV and recommended as first line of HIV prevention by the CDC
- PrEP is not covered under the current minor consent statute that allows 14-17 year old to consent to most sexually-related medical care so this law is needed to allow access
- If a minor gets PrEP, it should not be indicated on parent's insurance unless the minor gives consent so payment issues need to be addressed
- PrEP is part of a comprehensive medical visit that includes screening for sexually transmitted infections and laboratory monitoring and is done by a licensed healthcare provider who adheres to evidence-based practices so this measure also will hopefully have more minors getting comprehensive sexual health services (according to Hawaii YRBS, Hawaii youth have one of the lowest condom usage in the US)

Aloha Chair Keohokalole, Chair Baker and members of the committee I strongly support HB 2241 as a measure to prevent HIV infections by allowing minors access to HIV preventive drugs that could save their lives.

Pre-exposure prophylaxis (or PrEP) is medicine taken to prevent getting HIV. PrEP is highly effective for preventing HIV when taken as prescribed. Research shows that there is no association between use of prophylactic treatment and increased risk-taking.

Hawai'i law already allows youth ages 14 to 17 years old and older to protect the health of their bodies by allowing access to most sexual health services. Empowering and supporting youth to prevent the spread of HIV is a logical extension of this existing protection. Chair Keohokalole, Vice Chair Baker, and committee members, thank you for this opportunity to provide testimony on SB 2441, which permits minors to consent to medical care related to the diagnosis or treatment of HIV or the prevention of HIV and authorizes physician assistants, in addition to physicians and advanced practice registered nurses, to render such treatment to minors.

Kaiser Permanente Hawai'i SUPPORTS SB 2441.

Kaiser Permanente Hawai'i is Hawai'i's largest integrated health system that provides care and coverage for approximately 265,000 members. Each day, more than 4,400 dedicated employees and more than 650 Hawai'i Permanente Medical Group physicians and providers come to work at Kaiser Permanente Hawai'i to care for our members at our 20 medical facilities, including Moanalua Medical Center, providing high-quality care for our members and delivering on our commitment to improve the health of the 1.4 million people living in the communities we serve.

SB 2441 allows minors to consent to HIV treatment and prevention services and is a significant step in our statewide Hawai'i 2 Zero (H20) cure initiative, which aims to reduce HIV/AIDS cases down to zero — zero new infections, zero new deaths and zero stigma caused by HIV. Adolescents and young adults (aged 13-29) accounted for 21% of new HIV diagnoses in 2019¹ and are the least likely of any age group to be in treatment or have a suppressed viral load. Addressing HIV infection and spread among adolescents and young adults requires that they have access medical care to get the information and tools they need to make healthy decisions, reduce their risk factors, and get treatment. However, it is well established that minors may avoid seeking care for sexually transmitted diseases if they must involve their parents or guardian.² We support SB 2441 because it allows minors age fourteen to seventeen to obtain such services without parent or guardian
