Report Title: Department of Transportation; Construction; Projects; Sea Level Rise; Carbon Concrete Standards

Description: Requires the department of transportation to plan for a certain amount of sea level rise in all future or amended transportation projects. Requires all department of transportation highway, harbor, and airport projects to conform to certain carbon concrete standards except in certain circumstances.

Dibshawaii LLC business model was built upon using carbon dioxide from a carbon neutral stance. To be able to clean without creating any secondary waste stream. The result of the dry ice cleaning platform is mitigating our carbon footprint and being able to provide accolade level environmental cleaning without adding any additional waste streams and the burning of fossil fuels and consumption of other products that would then need to be disposed of. That was the premise of why I started this so we could clean at a higher level with integrity to our consumption and the mindfulness of protecting the environment.

As a small business we are dependent on carbon dioxide in its liquid state. Stored liquid carbon dioxide can be utilized to create dry ice. The Dry ice would then be used to supplement sand for sandblasting and water for pressure washing. So instead of using sand and water with chemicals we are using carbon dioxide to clean. Eliminating the costly steps to dispose of contaminated spent media and water greatly reducing the projects carbon emissions.

Our local supply chain issues with carbon dioxide in the state of Hawaii and our availability of carbon dioxide has put us at a disadvantage for the last decade meaning it inhibited us from truly reaching our potential. It did not allow for us to expand our operations because of the unreliability, unavailability and ultimately the high cost of the carbon dioxide. Hawaii is the most expensive place in the world to buy carbon dioxide as a small business or individual.

Hawaii and other island communities will be the first to experience climate change through rising sea levels, and we must act now to mitigate our carbon emissions by capturing the co2 stream one source at a time.

SB2295 SD2 will allow for a natural progression towards education and awareness and the connection between food, energy, and infrastructure our ability to utilize and sequester carbon dioxide.
