TESTIMONY OF BONNIE KAHAKUI, ACTING ADMINISTRATOR STATE PROCUREMENT OFFICE

SENATE BILL 2383 RELATING TO THE STATE PROCUREMENT POLICY BOARD

Chair Moriwaki, Vice Chair Dela Cruz, and members of the committee, thank you for the opportunity to submit testimony on Senate Bill 2383.

The State Procurement Office (SPO) appreciates the intent of S.B 2383 and respectfully provides comments as follows:

The SPO wishes to improve the efficiency of the rule-making process, which is currently under the authority of the Procurement Policy Board (PPB). However, the PPB last held a meeting in May 2019, and has not been able to hold subsequent meetings due to vacancies and lack of quorum. The inability for the PPB to meet hinders the SPO's ability to adopt, amend, or repeal administrative rules to carry out the objective of Chapter 103D, Hawaii Revised Statutes. To overcome this challenge, the SPO had previously recommended amending Section 103D-201, Hawaii Revised Statues, by reducing the PPB to five (5) members, eliminating the PPB Nominating Committee, and reducing the minimum number of applicants for vacant positions from three (3) to two (2) to ease the burden of receiving more applications and getting quorum.

The SPO strongly supports eliminating the Procurement Policy Board Nominating Committee and aligning rule-making authority in accordance with Chapter 91, HRS, and therefore provide the balance necessary to ensure fair and equitable treatment to government entities and vendors. The SPO wishes to comment that if §103D-201 and §103D-202, HRS, are repealed, the Hawaii Administrative Rules will have to be amended and will require time to process.

Instead of taking the drastic measure of complete elimination, HANO supports efforts to streamline and strengthen the nominating process, such as those proposed in the Administration's Senate Bill 3040.
