SENATE BILL 2387, SD1, HD2 RELATING TO PROCUREMENT

Chair Luke, Vice Chair Yamashita, and members of the committee, thank you for the opportunity to submit testimony on SB2387, SD1, HD2. The State Procurement Office (SPO) supports this bill.

SB2387, SD1, HD2, proposes to add the following language to HRS §103D-308 - Cancellation of invitations for bids or requests for proposals:

"...The reasons therefor shall be made part of the contract file and be publicly posted, for a minimum of ten business days, on a purchasing agency's website, government electronic notification system, or by any other means the procurement officer deems effective for publicizing the cancellation notice."

The Hawaii Public Procurement Code is the single source of public procurement policy to be applied equally and uniformly while providing fairness, open competition, a level playing field, government disclosure, and transparency in the procurement and contracting process vital to good government. Publicly posting the cancellation reason will promote transparency and efficiency in government.
