# SB 2398 RELATING TO THE HAWAII COMMUNITY DEVELOPMENT AUTHORITY

#### In consideration of SB 2398 RELATING TO THE HAWAII COMMUNITY DEVELOPMENT AUTHORITY.

Chairs Wakai and Inouye, Vice Chairs Misalucha and Keith-Agaran, and members of the Committees. The Hawaii Community Development Authority (HCDA), **supports SB** 2398 with amendments.

This measure establishes the Pulehunui community development district and board to be placed within HCDA and administratively attached to the Department of business, economic development, and tourism, to facilitate the development and improvement of state-owned lands in Pulehunui, Maui.

The bill also makes changes to the governance structure of the HCDA board and community development district boards.

We suggest the following amendment pertaining to the composition of the authority to make the membership align with the other related measures. On page 6, lines 11 and 12, page 8, lines 11 and 12, page 10, lines 1 to 3, page 11, lines 3 to 5, page 12, lines 7 to 9, page 13, lines 9 to 11, and page 14, lines 5 and 6 please make the following change:

Replace "the director of the office of planning and sustainable development or the director's designee" with "the director of the department of business, economic development, and tourism or the director's designee". Note: the additional language, "or the director's designee", will not need to be inserted in every instance.

Please delete the extraneous language on page 14, lines 10 to 12 as follows:

HCDA Testimony SB 2398 February 16, 2022 Page 2

".... provided that the initial terms of all voting members initially appointed pursuant to Act 61, Session Laws of Hawaii 2014, shall commence on March 1, 2015..."

Passage of SB 2398 would allow HCDA to facilitate and lead regional infrastructure planning between several State agencies and ensure the most efficient use of State funds.

It would also enable HCDA to engage with the U.S. Department of Agriculture's Rural Development division about potentially utilizing federal infrastructure funds to finance regional infrastructure improvements as well as the new correctional facility.

The HCDA has considerable experience in implementing infrastructure improvements and facilitating development and welcomes the opportunity to use its development expertise in facilitating development and improvement in Pulehunui.

Chair Wakai, Chair Inouye and Committee Members:

The League of Women Voters opposes SB 2398.

Regardless of whether SB 2398 would comply with the State Constitution, the League's position is that it is simply, obviously wrong for the Legislature to encourage people who might develop or lease public lands at Pulehunui to "play politics" to gain special unfair treatment. Besides changing who is included on the board of the HCDA, SB 2398 proposes to authorize specified HCDA board members (but not all board members) to regulate (and override county zoning for) "underutilized" public lands at Pulehunui but not to regulate (and override county zoning for) similar "underutilized" public lands at any other location. However, Article XI, Section 5 of the Hawaii Constitution prohibits enactment of a "special" law which only applies to public lands at one specific location and nowhere else in the State. This requirement is explained in the Attorney General's February 11, 2022 testimony on SB 2833.
