# Re: S.B. 2445 RELATING TO PHYSICIAN ASSISTANTS

# I. OVERVIEW OF PROPOSED LEGISLATION

This measure seeks to broaden the scope and practice of physician assistants by amending multiple chapters of the Hawaii Revised Statutes (HRS) including Chapter 392, HRS, the Temporary Disability Insurance (TDI) law. The proposal will allow physician assistants to provide care to and certify the disabilities of individuals for TDI purposes.

DLIR supports this measure.

# II. CURRENT LAW

Sections 392-26(a) and 392-26(c), HRS, specify that an individual must be under the care of and have the individual's disability certified by a person duly licensed to practice medicine, surgery, dentistry, chiropractic, osteopathy, or naturopathic medicine, or an advanced practice registered nurse.

# III. COMMENTS ON THE SENATE BILL

DLIR supports the intent of the measure to assist with the critical physician shortage by allowing Physician Assistants to certify an employee's disability after receiving treatment.

Chair Keohokalole, Vice Chair Baker, and committee members, thank you for this opportunity to provide testimony on SB 2445, which modernizes the practice of physician assistants.

# Kaiser Permanente Hawai'i STRONGLY SUPPORTS SB 2445.

Kaiser Permanente Hawai'i is Hawai'i's largest integrated health system that provides care and coverage for approximately 265,000 members. Kaiser Permanente Hawai'i believes that physicians assistants should be permitted to practice medicine at the top of their training, education and experience. Kaiser Permanente Hawai'i appreciates the contributions made by licensed physician assistants and has a great deal of confidence in the quality of health care they provide to our members. Our physician-owned Hawai'i Permanente Medical Group (HPMG) – Hawai'i's largest multispecialty medical group – employs over 650 physicians and licensed medical providers, including over 80 physician assistants. Within the Kaiser Permanente system, physician assistants collaborate with physicians and other medical professionals to provide high quality patient care in a variety of specialties and settings, including: Family Medicine, Internal Medicine, Pediatrics, Dermatology, Orthopedics, Cardiology, Oncology, Obstetrics & Gynecology, Emergency medicine, Nephrology, Occupational Medicine, Vascular, General and Cardiothoracic Surgery, Infectious Disease, Radiology, Urology and Otolaryngology (ears, nose and throat).

Kaiser Permanente Hawai'i supports SB 2445 because it removes barriers for the practice of physician assistants and ensures greater access to health care for Hawai'i residents, especially those who reside on the neighbor islands where the need is greatest. As of 2021, Maui and the island of Hawai'i each needed to increase their number of care providers by a staggering 40%, Kauai by 26%, and Oahu by 15%. Yet since 2016 the number of physician assistants has increased by 105% on the island of Hawai'i, 114% on Kauai, and 35% Maui. Despite increased physician assistant presence throughout the islands, they remain unable to practice at the top of their training and education due to Hawai'i restrictive practice laws. As such, physician



assistants are restricted from being able to adequately meet the healthcare needs for our populations.

SB 2445 builds on the Legislature's previous successes modernizing physician assistants' practice in Hawai'i. SB 2445 will allow physician assistants, like Advanced Practice Nurses (APRNs), to sign temporary disability insurance forms, disability parking permits, Provider Orders for Life Sustaining Treatment (POLST) forms, and other administrative forms that are time sensitive and critical for patients' quality of life but, are often delayed by the physician shortage.

Physician assistants are skilled health care providers and authorized by the Affordable Care Act, along with physicians and APRNs, to provide primary care. They receive rigorous medical training modeled on medical school curriculum which typically includes rotations in family medicine, internal medicine, general surgery, pediatrics, obstetrics and gynecology, emergency medicine and psychiatry. In practice, physician assistants routinely take medical histories, perform physical examinations, order and interpret laboratory tests, diagnose illnesses, develop and manage treatment plans, prescribe medications, and assist in surgery. With their skills and training, physician assistants play a critical role on our care delivery teams and are represented in every medical specialty within our medical group. Kaiser Permanente Hawai'i continues to focus on recruiting physician assistants because physician assistants possess a skillset and training that allows them to be able to pivot quickly and supply care when and where it is needed most. This has been invaluable during the pandemic when we rely heavily on our physician assistants' unique adaptability to provide care in an ever-changing landscape.

Dear Chair Keohokalole, Vice Chair Baker, and Committee Members,

Thank you for this opportunity to provide testimony on SB 2445, which serves to modernize scope of practice for physician assistants in the state of Hawai`i.

### Hawai`i Academy of Physician Assistants (HAPA) STRONGLY SUPPORTS SB 2445 WITH AMMENDMENTS

HAPA is the Hawai'i state chapter of The American Academy of Physician Assistants. According to the 2021 annual report on findings from the Hawai'i physician workforce assessment report, Hawai'i has an unmet need for 732 full time physicians across the state with neighbor island counties facing the most severe shortages.

Paradoxically, physician assistant practice in Hawai`i has grown by 36% over the past five years. This is most noticeable on some of the neighbor islands, where physician assistant presence has grown over 100%.

Notably, physician assistants are one of the three health care professionals (along with physicians and nurse practitioners) authorized by the Affordable Care Act to serve as primary care provider (PCP).

Physician assistants already play an integral role in filling our well-known provider shortage gaps in Hawai'i, but state restrictions on physician assistant practice, some of the toughest in the nation, limit physician assistants from practicing medicine to their highest ability.

HAPA appreciates the Legislature's passage of Act 181, Session Laws of Hawai'i 2019, which was a monumental bill that modernized physician assistant chart review by collaborating physicians. This has successfully lowered administrative burden for physicians, without compromising patient care. SB 2445 will allow physician assistants, like Advanced Practice Nurses (APRNs), to sign temporary disability insurance forms, disability parking permits, Provider Orders for Life Sustaining Treatment (POLST) forms, and other administrative forms that are time sensitive and critical for patients' quality of life but, are often delayed by the physician shortage. Like 2019, we expect this change will continue to prioritize patient care while significantly decreasing physician administrative burden.



#### To ensure continuity of care delivery for patients requiring occupational therapy rehabilitation, HAPA respectfully requests that SB 2455 be amended to include physician assistant authority to sign orders for occupational therapy and plans of care.

Currently under HRS 453-5.5, physician assistants can sign orders and plans of care for both physical and speech therapies, but arbitrarily, not for occupational therapy. Allowing physician assistants the ability to sign occupational therapy orders ensures that patient access to occupational therapy is timely.

Proposed amendment would add line number (10) to HRS 453-5.5 and read as:

§453-5.5 Physician assistant; authority to sign documents. Any physician assistant who holds a current, valid, and permanent license to practice medicine pursuant to this chapter, and who is under the supervision of a licensed physician or osteopathic physician, shall have the authority to sign the following documents:

- Certification of psychiatric medical condition of the parents of a child applicant for aid from the temporary assistance for needy families program;
- (2) Evaluation forms for Hansen's disease patients;
- (3) Orders for physical therapy and plans of care;
- (4) Pharmacist orders to assist in monitoring and management of anticoagulation anemia and atrial fibrillation;
- (5) Orders for speech therapy and plans of care;
- (6) Applications for bracelets indicating compassionate care only;
- (7) Admissions applications for foster homes;
- (8) Dietary consultations forms; and
- (9) Medicaid application forms for nursing care facility admission; and
- (10) Orders for occupational therapy and plans of care.

At HHRS, occupational therapists work closely with Physician Assistants from All Access Ortho, which are orthopedic urgent care facilities. These urgent care facilities provide immediate and specialized care for mild to moderate bone and joint injuries. Referrals from All Access Ortho are often time sensitive. Therefore, it is important for Physician Assistants to have the ability to order necessary care, including occupational therapy services. Delaying medically necessary care may delay and negatively impact healing. At HHRS, we specialized in hand injuries. Improper healing of one's hands greatly impact one's ability to fulfill school and job duties, essential self-care, and valued leisure and social activities.

On behalf of the OT practitioners at HHRS and our professional state association, Occupational Therapy Association of Hawaii, I support the intent of the suggested amendment to this bill. The suggested amendment is as follows: by inserting after Section 9 Section 10. CHAPTER 453 MEDICINE AND SURGERY §453-5.5 Physician assistant; authority to sign documents.

## Comments:

Even though I am a licensed physician and member of the Hawaii Medical Association, my testimony is submitted as a private citizen. I have served on the Hawaii Board of Medical Examiners when physician assistants and nurse practitioners first applied for prescription writing privileges. I also hired and trained the first few Hawaii neurosurgical physician assistants beginning in 1984. In those days, there was considerable resistance to the use of any physician extenders. We had physician shortages then that raised comparable practical concerns relative to the limited access of Hawaii citizens to high quality care. Back then, it was clear physician extenders were quite helpful but they could not be used to replace physicians. As a physician extender friendly professional, I know that it is a mistake for Hawaii, the healthcare state, to adopt the false narrative that we can address physician shortages in our state by trying to replace MDs with physician extenders. Legislative efforts can facilitate looking for real solutions to real problems, but legislators cannot improve the physician shortage problem by extending the scope of practice of non-physicians. That is at best an attractive sounding myth. Legislators can find out what makes primary care and specialist physicians choose to leave Hawaii for practice opportunities elsewhere. Legislators can potentially use such knowledge to eliminate MD disincentives and increase MD incentives favorable to MDs coming and / or staying to live and work in Hawaii. I have never met a patient who wanted to be treated by the least trained MD on the team, let alone a non-physician. The scope of training of any MD or DO compared to any physician extender is basically incomparable. The least trained MD after completing college and medical school, spends years in a primary care or specialty training residency program before becoming employable as a licensed - certified practicing physician. Making it legally possible for non-physicians to do traditional physician required work would, in my opinion, expose the state of Hawaii to civil liability for malpractice. I strongly oppose this bill as well meaning but counter productive to the goal of pursuing a healthcare infrastructure for our state that pursues acceptable high quality and sustainable healthcare. Quick fixes as proposed by this and similar bills are basically ill advised and highly likely to make matters worse than they already are.
