### SUBJECT: SB 2587 – RELATING TO THE YOUTH COMMISSION.

DEPARTMENT'S POSITION: The Department of Human Services (DHS) comments on

this measure, provides clarification, and requests clarification.

**PURPOSE**: The purpose of this measure is to require the Youth Commission to appoint

an Executive Director.

The Department requests clarification to the following comment in the committee report,

As the Office of Youth Services currently has one long-term vacant position, your Committee finds that it is not necessary to establish a new position within the Office of Youth Services for an Executive Director.

The existing administrator position to the Hawaii Youth Commission is recently vacant; if the intent is to convert this civil service position to an exempt Executive Director position, it will take an appropriation to address the difference in salary and time to convert the position to exempt.

The Department also seeks clarification whether the Legislature intends to have two positions dedicated to the Youth Commission. If this is the case, an appropriation for the total

amount of the Executive Director's salary and other benefits are required. The Department notes that it is unclear whether there is a workload for two full-time employees at this point.

The Department supports the mission of the Youth Commission, which is to advise the governor and Legislature on the effects of legislative policies, needs, assessments, priorities, programs, and budgets concerning the youth of the State. Section 352D-11, Hawaii Revised Statutes. As the Youth Commission is attached to the Office of Youth Services, which is attached to DHS, the current administrator of the Youth Commission is a civil service employee of the DHS. As such, the proposed exempt Executive Director of the Youth Commission would also be a DHS employee and will be expected to follow and comply with all applicable state and federal laws and policies and procedures of the Office of Youth Services and the DHS.

From an employment perspective, to vet potential candidates for the proposed Executive Director position, commissioners should have the education or relevant work experience to make the hiring decision. The Legislature should consider that the authority and responsibility for making employment decisions come with inherent liability, including potential negligent hiring or discrimination claims. When commissioners are still minors, it is unlikely they would have the education or relevant work experience to be considered legally responsible for those employment decisions. DHS suggests as a viable option that the commissioners discuss with OYS ways to participate in the selection process to fill the current administrator position or proposed Executive Director position.

The bill refers to appointing the Executive Director. However, it is silent on the other typically related employment matters, such as conducting performance evaluations and discharging the Executive Director, if necessary. The Department requests clarification as to who will be responsible for those activities and decisions. A reorganization will likely be needed to address these responsibilities.

**OFFICE'S POSITION:** The Office of Youth Services (OYS) submits comments and suggests amendments. OYS respectfully requests that any general fund appropriation not reduce or replace budget priorities identified in the executive budget.

**PURPOSE**: The purpose of the measure is to authorize the Hawaii State Youth Commission to appoint an Executive Director to oversee the administration of the Youth Commission.

The Office of Youth Services strongly supports the Youth Commission's mission, and its ability to provide strong youth voice in advising the governor and effecting legislative policies as they relate to youth issues in the State. Signed into law in 2018, Act 106 established the Youth Commission and appropriated funds for administration costs and one Children and Youth Program Specialist (CYPS) staff position, who acts as the administrative coordinator and liaison for the Youth Commission.

The OYS agrees with the concerns raised in testimony provided by the Department of Human Services related to the inherent liability of employment decisions that this bill tasks the youth commissioners with, and request clarification as to who will be responsible for all of the

decisions and activities of this civil service Executive Director. Alternately, it is recommended that the youth commissioners instead be solely involved in the selection process of their CYPS Coordinator, which became vacant in January 2022. It is recommended that the staffing for the Youth Commission remain as is, and language be added within Page 4, line 7, (i) The youth commission shall appoint <u>one youth commissioner to serve on the selection committee of its an executive director assigned staff position.</u> For the proper administration and enforcement of this section without regard to chapter 76.
