

Testimony to the Senate Committee on Ways and Means Friday, February 26, 2021; 9:30 a.m. State Capitol, Conference Room 211 Via Videoconference

RE: SENATE BILL NO. 0262, SENATE DRAFT 1, RELATING TO VACCINES.

Chair Dela Cruz, Vice Chair Keith-Agaran, and Members of the Committee:

The Hawaii Primary Care Association (HPCA) is a 501(c)(3) organization established to advocate for, expand access to, and sustain high quality care through the statewide network of Community Health Centers throughout the State of Hawaii. The HPCA <u>SUPPORTS</u> Senate Bill No. 0262, Senate Draft 1, RELATING TO VACCINES.

The bill, as received by your Committee, appropriate an unspecified amount of general funds for fiscal year 2020-2021, to sustain and enhance the State's SARS-CoV-2 virus vaccination goals.

By way of background, the HPCA represents Hawaii Federally-Qualified Health Centers (FQHCs). FQHCs provide desperately needed medical services at the frontlines in rural and underserved communities. Long considered champions for creating a more sustainable, integrated, and wellness-oriented system of health, FQHCs provide a more efficient, more effective and more comprehensive system of healthcare.

Ever since COVID-19 hit Hawaii's shores, FQHCs have worked with our partner health care providers and the State Department of Health, the Counties of Hawaii, Kauai, and Maui, and the City and County of Honolulu to plan and implement the enormous task of immunizing Hawaii's citizens. The federal government has helped enormously by fast-tracking the vaccine and paying for the hundreds of millions of doses that will need to be distributed throughout our Nation. However, the federal government is not paying for the administrative costs of delivering this medication to citizens. This includes, among other things, the purchase of needles, syringes, personal protection equipment, as well as the time of health care professionals away from their normal duties to perform this added responsibility.

Because these costs were not previously budgeted, the Department of Health (DOH) has had to scramble to find resources within its existing budget to start the immunizations of first responders and health care providers. That they had gotten us this far, the DOH and the Administration should be commended for their creativity and willingness to work with the providers.

FQHCs have done our part as well. We have searched within our limited resources to make the plan work. This has forced us and our partner organizations to make sacrifices for the benefit of our patients and communities. We gladly do this but to continue these efforts, we will need help.

This bill would appropriate funds to continue the State's immunization efforts after June 30, 2021. As such, the HPCA urges your favorable consideration of this important measure.
