RELATING TO THE HAWAII STATE HEALTH INSURANCE ASSISTANCE PROGRAM

The Department of Budget and Finance (B&F) offers comments on this bill.

Senate Bill No. 2678, S.D. 2, H.D. 1, appropriates an unspecified amount in general funds in FY 23 to the Executive Office on Aging to expand the Hawai'i State Health Insurance Assistance Program by contracting with third-party service providers and staffing consultants and recruiting more volunteers.

B&F notes that, with respect to the general fund appropriation in this bill, the federal Coronavirus Response and Relief Supplemental Appropriations Act requires that states receiving Elementary and Secondary School Emergency Relief (ESSER) II funds and Governor's Emergency Education Relief II funds must maintain state support for:

- Elementary and secondary education in FY 22 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

Further, the federal American Rescue Plan (ARP) Act requires that states receiving ARP ESSER funds must maintain state support for:

- Elementary and secondary education in FY 22 and FY 23 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 and FY 23 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

The U.S. Department of Education has issued rules governing how these maintenance of effort (MOE) requirements are to be administered. B&F will be working with the money committees of the Legislature to ensure that the State of Hawai'i complies with these ESSER MOE requirements.

- EOA's Position: The Executive Office on Aging (EOA), an attached agency to the Department
- of Health, supports the intent of SB2678 SD2 HD1, Relating to the Hawaii State Health
- 3 Insurance Assistance Program, a program of the Executive Office on Aging.
- 4 **Fiscal Implications:** This measure appropriates state funds to expand the EOA's Hawaii State
- 5 Health Insurance Assistance Program (SHIP) for FY22-FY23.
- 6 **Purpose and Justification:** The purpose of this bill is to appropriate funds to SHIP for operating
- 7 costs to expand access to important Medicare-related services to Hawaii residents statewide by
- 8 recruiting more volunteers and contracting with third party service providers and staffing
- 9 consultants. EOA will ensure that third party service providers, including all members of the
- 10 governing board, are independent and free from all conflicts of interest.
- Hawaii SHIP is a volunteer-based program whose mission is to empower, educate, and assist
- Medicare-eligible individuals, their families, caregivers, and soon-to-be-retirees through

- objective outreach, counseling, and training to make informed health insurance decisions that
- optimize access to care and benefits. SHIP is recognized as a reliable, unbiased, and free source
- 3 in Hawaii for accurate information on health plans and other related topics such as: Medicare
- 4 eligibility/enrollment in Medicare Parts A, B, C, D, Medicare Supplement Insurance (Medigap)
- 5 to prevent lifetime late enrollment penalties; Financial assistance programs: Extra Help,
- 6 Medicare Savings Program, and Medicaid eligibility; Medical/drug plan comparisons to include
- dental, vision, and hearing coverage and coordination of benefits; Claims/appeals; summary
- 8 notice/billing discrepancies; plan terminations; broker/agent misrepresentation.
- 9 SHIP is cost efficient. The services provided by SHIP has demonstrated at the national level to
- save beneficiaries hundreds of thousands of dollars. For example, Medicare beneficiaries who
- chose the least expensive Part D prescription plan available in their region, saved an average of
- \$368 per year. In SFY 2021, Hawaii SHIP volunteers and in-kind staff contributed 3,523 hours
- valued at over \$100,194, based on the 2021 national rate of \$28.44 per hour of volunteer work
- 14 (source: Independent Sector Releases New Value of Volunteer Time of \$28.54 Per Hour —
- 15 Independent Sector). Volunteers provide one-on-one counseling, presentations to employers and
- senior groups, administrative support, training, and distribution of information, and support
- 17 community outreach events statewide.
- 18 SHIP needs to expand to meet the growing demand. In 2021, Hawaii had 278,077 Medicare
- beneficiaries, a figure that continues to grow as the Baby Boomers (1946-1964) become eligible
- for Medicare at age 65. However, the number of dedicated staffing positions has not changed
- since the inception of the program in 1992. The program employs two full-time equivalent (2.0
- FTE) who train and support eighty-four (84) certified Medicare volunteers and in-kind staff
- statewide. Compared to other states, Hawaii SHIP has the least number of staff for the largest
- 24 number of Medicare beneficiaries. The table below compares the total number of full-time
- 25 dedicated staff of other states.

- Hawaii has the fastest rate of growth of the Medicare population. Additionally, Hawaii SHIP increased the number of beneficiaries reached during the past four years (from 1,918 in 2018 to 2,930 in 2021), yet the program continues to fall below the penetration goal of the total Medicare population, as set by the federal funders at 1.83%. or 5,089 individuals. In 2021, Hawaii SHIP's penetration rate was 1.05% or 2,930 individuals assisted. Rather than hiring more FTEs, we plan to contract with additional third-party service providers and to recruit more volunteers who will assist our program to reach beneficiaries and individuals turning age 65.

  This proposal is requesting general funds to support the invaluable, unbiased counseling and educational services that Hawaii SHIP provides to older adults, their families, caregivers, and soon-to-be retirees. Increased funding will expand access to SHIP services through volunteers and third-party service providers and enable greater focus to reach target populations, such as individuals with limited income, limited English proficiency, and/or who are rurally isolated with limited access to services and supports.
- Recommendation: EOA supports the intent of SB2678 SD2 HD1 provided that its enactment does not reduce or replace priorities with the Administration's budget request.

The Hawaii SHIP program protects consumers against the complex and confusing system that makes seniors vulnerable to exorbitant health care costs -- a severe problem in the US which has the highest health care costs in the world.

Medicare is a federally financed and administered flagship entitlement program established under the Social Security Act, and Medicare is regulated at the national level.

Nevertheless, the creation of State Health Insurance Assistance Programs at the state level provide a cost-effective means that leverages federal funding to train certified volunteer counselors to help seniors make informed insurance choices.

State resources will enhance the outreach and sustainability of this crucial (and likely cost-savings) program. Future research can help to assess the return on investment of this valuable public program.

I strongly support HB1825 / SB2678.

I spent 20+ years working for many large and small providers and payers in the U.S. including Hawaii and know the types of complexity that exist in healthcare. I can honestly say Medicare is in a class by itself with many nuances from eligibility, enrollment, plan selection, coordination of benefits, financial support, appeals, and grievances. These constantly change.

From a more personal perspective, my husband encountered this as he approached 65 years. He spent his entire career solving engineering issues but was at a loss with understanding the fragmented Medicare sector and the shower of mailings he received - most from private insurance companies vying for his business. I cannot imagine the apprehension and frustration that kupunas and others face navigating the Medicare world.

Hawaii SHIP is unique as it's the only Hawaii-based organization private or public that provides free, unbiased counseling to those in need of comprehensive Medicare information. Others are typically insurance agents and brokers who may be knowledgeable particularly on enrollment but have a vested interest in certain products.

In 2021, there were 278K+ Medicare beneficiaries in Hawaii and forecasts indicate this population will substantially grow. Hawaii SHIP's service will be critical to provide objective information as Medicare complexities are not changing anytime soon.

I strongly urge the committee to pass SB2678.

Catholic Charities Hawai'i (CCH) is a tax exempt, non-profit agency that has been serving people in need in the State of Hawaii since 1947.

CCH supports SB 2678, SD2, HD1, which would provide State funding to ensure the stability and continuity of the SHIP program in Hawaii.

CCH provides services for over 4,000 older adults each year. Our Benefits Enrollment Center and Case Management Programs assist low-income older adult clients to access needed benefits they are eligible for, such as SNAP (i.e. food stamps), Medicaid, Medicare subsidies and other income-eligible resources. We are aware that many seniors, from all income categories, are barraged with Medicare plan information particularly during Medicare Open Enrollment. We have seen what happens when a senior is enticed to enroll in a Medicare plan that does not meet the specific needs of that individual senior. This sometimes means seniors can no longer receive services from specific health care professionals (who may not accept their Medicare plan) or that seniors end up paying more for medications because they changed their Medicare plan and the plan no longer covers some of their required medications.

SHIP is an unbiased resource that we refer seniors to when they have questions about Medicare options or other questions about Medicare. We can trust that SHIP will have the most up-to-date Medicare information and that they are not influenced by any ties to specific Medicare plans.

SHIP has also been a training resource for CCH – providing essential Medicare training for our staff so that we can better assist our senior clients.

SHIP provides an essential service for Medicare recipients statewide. Catholic Charities Hawai`i asks for your support of SB 2678, SD2, HD1. Hawaii State Health Insurance Assistance Program (SHIP) is a federally funded, volunteer-based program that is administered by the Hawaii State Department of Health, Executive Office on Aging. Hawaii SHIP helps Medicare-eligible individuals, their families and caregivers, and soon-to-be retirees make informed, cost-effective healthcare decisions. This is accomplished through one-on-one counseling sessions, answering questions, and distributing informative brochures at health fairs, and providing Medicare-related presentations. These services are free to the public who contact Hawaii SHIP through the Helpline and website. Volunteers, who provide these important services, are recruited and trained throughout the year to keep up with the changes or updates to Medicare.

I am a 2nd-year Master's in Social Work (MSW) Graduate student at the University of Hawai'i at Mānoa Thompson School of Social Work and Public Health, specializing in the area of Gerontology. Also, I am a current practicum student with the SHIP Program and the Graduate Research Assistant for the Introduction to Medicare Course under instruction of Dr. Victoria Fan for the Spring 2022 semester. This course is a partnership between the Department of Health Executive Office on Aging (EOA) Hawaii SHIP Program and the University of Hawai'i Center on Aging (COA). In Spring 2021, I was presented with the opportunity to complete the Introduction to Medicare Course before my title as a Graduate Research Assistant. Learning and comprehending the Medicare system was difficult for a student as it would be for a beneficiary. The complexity in navigating the system creates barriers for older adults and their families to affordable and accessible healthcare. Misleading or misunderstood information could result in costly consequences if healthcare decisions are poorly made. According to the National Council of Aging (NCOA), current studies have shown that older adults "routinely" make mistakes when selecting Medicare plans, generating costly consequences. In one identified study, researchers have found that older adults spent an average of \$368 per year more than they needed to, and, while only 5% of older adults chose the lowest cost plan, more than 20% were overspending by \$500.00 per year (Kina, 2021). These factors contribute to widening the gap of affordability and accessibility in healthcare coverage for the aging population. Throughout my various titles, I witnessed the dedication of the two full-time employees and kindhearted volunteers in providing Medicare-related services for Hawai'i's Kūpuna, their families, and the aging community. As a future Social Work clinician and an advocate for older adults, the sustainability for the SHIP

Program to continue and expand is needed for the aging population and their families to make confident, healthcare related decisions.

Hence, I strongly support SB2678, relating to the State Health Insurance Assistance Program, which would provide Hawaii SHIP with much-needed funding to expand access to important Medicare-related services to Hawaii residents statewide by contracting with third party service providers and staffing consultants.

There are 278,077 Medicare beneficiaries statewide as of 2021. Hawaii SHIP's goal is to assist as many beneficiaries in Hawaii as possible. In 2021, SHIP assisted 2,930 with Medicare counseling and reached 7,701 beneficiaries through outreach presentations and fairs/exhibits. By 2025, SHIP will need to reach 10,000 Medicare beneficiaries which is a drastic increase from SHIP's current capacity.

With more partnerships and volunteers, Hawaii SHIP could provide more outreach and education to Hawaii's residents. I urge the committee to pass SB2678. Thank you for this opportunity to testify.
