RELATING TO CRYPTOCURRENCY

The Department of Budget and Finance (B&F) offers comments on this bill. Senate Bill (S.B.) No. 2695: 1) establishes a Blockchain and Cryptocurrency (BC) Task Force (BCTF) to be placed within B&F for administrative purposes; and 2) requires the BCTF to review BC data, compile proposed legislation, consult with industry experts, and submit a report of its findings and proposed legislation no later than 20 days prior to the start of the 2023 Legislative Session.

B&F believes that the BCTF would be more appropriately placed within the Department of Commerce and Consumer Affairs (DCCA). DCCA's Division of Financial Institutions is currently partnering with the Department of Business, Economic Development and Tourism's Hawai'i Technology Development Corporation (HTDC) to operate the Digital Currency Innovation Lab (DCIL) and research digital currency-related legislation. B&F would also like to highlight that the DCCA has already introduced Administration Proposal CCA-2(22) (S.B. No. 3076 and House Bill No. 2108) to establish a new regulatory and licensing framework for digital currency transmitters based on the findings of the DCIL. B&F defers to DCCA and HTDC regarding the proposed BCTF and other BC-related legislation.

On the following measure: S.B. 2695, RELATING TO CRYPTOCURRENCY

Chair Wakai and Members of the Committee:

My name is Iris Ikeda, and I am the Commissioner of the Department of Commerce and Consumer Affairs' (Department) Division of Financial Institutions (DFI). The Department appreciates the intent and offers comments on this bill.

The purpose of this bill is to establish a blockchain and cryptocurrency task force to review data on the scope of blockchain and cryptocurrency throughout the country; compile an overview of potential legislation; solicit ideas and opinions from industry experts on additional legislation; and submit a report of its findings and recommendations to the legislature.

The DFI has been active in the area of digital currency regulation, including collaborating with the Hawaii technology development corporation to establish the Digital Currency Innovation Lab (DCIL) program to study digital currency transactions in the state. As such, the department suggests that if a task force is formed, a representative from DFI be included as a member of the task force.

Testimony of DCCA S.B. 2695 Page 2 of 2

The Department notes that as a result of DFI's work on the DCIL, DFI has drafted a special purpose digital currency bill (Senate Bill 3076) that provides for licensure and regulation of digital currency transactions. If the bill is enacted, the digital currency climate in the state will be significantly altered, and it may be difficult for the task force to develop recommendations for additional legislation before the new law can be fully operationalized. As such, the convening of a task force as proposed in this bill may be unnecessary or premature.

Finally, the Department recommends that if the task force is convened, the scope of its review be broadened to encompass other aspects of the industry besides possible legislation, including but not limited to the development of a plan for expansion of blockchain adoption in both the private and public sector.

In consideration of SB2695 RELATING TO CRYPTOCURRENCY

Chair Wakai, Vice Chair Misalucha, and Members of the Committee on Energy, Economic Development, and Tourism.

I **support** SB2695 that calls for the establishment of a blockchain and cryptocurrency task force.

Hawaii is currently one of the first in the nation to lead on crypto innovation with the establishment of the Digital Currency Innovation Lab two years ago. Unfortunately, that sandbox expires this coming June. Without an extension of that lab or legislative action, crypto companies will be forced to leave the state and the assets in the 61,000 local accounts opened in the past two years under the sandbox environment will likely be frozen. It is imperative to pass good laws such as this Task Force bill to look at future regulation and how to keep the progress we have made to date.



To give the Committee context on how important it is to maintain Hawaii's leading edge on crypto below is a map¹ tracking all active sandboxes across the country, many of which looked at Hawaii's sandbox for inspiration.

Even now the state of Virginia created the Department of Regulatory Innovation and borrowed from Utah's universal sandbox which created the Regulatory Relief Office within the Governor's Office of Economic Development.

If the State of Hawaii were to pass this Task Force bill, it would give us time and space to study the regulatory environment and other state efforts (see below) that are also trying to answer the difficult but exciting questions on regulating an entirely new digital asset ecosystem.
