# SUPPORT SB 2768, SD2 RELATING TO THE HAWAII YOUTH CONSERVATION CORPS.

Chair Luke, Vice Chair Yamashita, and Members of the Committee, the Hawai'i State Energy Office (HSEO) supports SB 2768, SD2, which authorizes the Governor to designate the Department of Land and Natural Resources to administer or enter into an agreement for the administration of a green jobs youth corps to provide temporary work and training opportunities in the fields of natural resource management, agriculture, or other sustainability-related professions to young adults ages thirty-eight and younger. Requires the Department to partner with an organization that has received accreditation from the Corps Center of Excellence Accreditation Program or has at least ten years of experience providing similar programming statewide in the State, or both. This bill also appropriates funds.

HSEO believes that DLNR is well-suited to oversee the corps, provide training and job experience for the workforce of the future, in the areas noted above. This program will help advance Hawai'i's clean energy and decarbonization goals, expand the green workforce, and launch a new generation of clean energy leaders. HSEO is in support of this and other green workforce development efforts, as we work together toward achieving 100% clean energy by or before 2045.

# In consideration of SENATE BILL 2768, SENATE DRAFT 2 RELATING TO THE HAWAII YOUTH CONSERVATION CORPS

Senate Bill 2768, Senate Draft 2 proposes to authorize the Governor to designate the Department of Land and Natural Resources (Department) to administer or enter into an agreement for the administration of a green jobs youth corps to provide temporary work and training opportunities in the fields of natural resource management, agriculture, or other sustainability-related professions to young adults ages twenty-six and younger. The bill also proposes to appropriate unspecified funds to the Department. **The Department supports this bill.** 

The State of Hawaii's progressive move towards a zero-emissions clean economy by 2045 requires that we actively invest in the community and emerging economic sectors and provide residents with the education and training opportunities they need to make the transition. A job corps program designed specifically to address the State's climate change goals would be beneficial in helping the growing green sector scale up efforts to address climate change and provide diversified training opportunities to a displaced workforce, supporting a resilient local economy.

The Department has been long-time partners with AmeriCorps and Kupu through their mentorship programs which have been successful in getting the youth of Hawaii not only into conservation jobs but into the workforce at large. The Kupu Aina Corps Program, funded by the CARES Act and ARPA funding, demonstrated how eager the local workforce is to get back to work and provided new opportunities for many to enter emerging and growing fields of work.

# RELATING TO THE HAWAII YOUTH CONSERVATION CORPS

The Department of Budget and Finance (B&F) offers comments on this bill.

Senate Bill No. 2768, S.D. 2: authorizes the Governor to designate the

Department of Land and Natural Resources (DLNR) to administer a green jobs youth

corps to provide temporary work and training opportunities in the fields of natural

resource management, agriculture, or other sustainability-related professions; requires

DLNR to partner with a qualified organization; and appropriates an unspecified amount

of general funds for FY 23 for DLNR to administer the green jobs youth corps.

B&F notes that \$5,000,000 in Coronavirus State and Local Fiscal Recovery Funds has been appropriated and awarded for this program with a performance period of May 11, 2021 through June 30, 2023. It is uncertain whether there is a need for additional funds for FY 23.

B&F also notes that, with respect to the general fund appropriation in this bill, the federal Coronavirus Response and Relief Supplemental Appropriations Act requires that states receiving Elementary and Secondary School Emergency Relief (ESSER) II funds

EMPLOYEES' RETIREMENT SYSTEM HAWAI'I EMPLOYER-UNION HEALTH BENEFITS TRUST FUND OFFICE OF THE PUBLIC DEFENDER and Governor's Emergency Education Relief II funds must maintain state support for:

- Elementary and secondary education in FY 22 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

Further, the federal American Rescue Plan (ARP) Act requires that states receiving ARP ESSER funds must maintain state support for:

- Elementary and secondary education in FY 22 and FY 23 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 and FY 23 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

The U.S. Department of Education has issued rules governing how these maintenance of effort (MOE) requirements are to be administered. B&F will be working with the money committees of the Legislature to ensure that the State of Hawai'i complies with these ESSER MOE requirements.

Testimony Before The House Committee on Finance IN SUPPORT OF SB 2768 SD 2 April 5, 2022, 2:30PM, Room 308

My name is Kevin Chang and I am the Executive Director of <u>Kua'āina Ulu 'Auamo (or KUA)</u>. KUA works to empower grassroots rural and Native Hawaiian mālama 'āina groups -fishers, farmers, families- to celebrate their places and pass on their traditions to better Hawai'i and achieve 'āina momona— an abundant, productive ecological system that supports community well-being.

KUA employs a community-driven approach that currently supports a statewide network of 36 mālama 'āina community groups collectively referred to as E Alu Pū (moving forward together), 40 fishpond projects and practitioners called the Hui Mālama Loko I'a, and a growing group of over 60 Limu practitioners and supporters called the Limu Hui. Our vision of 'āina momona includes pathways to new economic and environmental regenerative opportunities for present and future generations.

KUA generally supports SB 2768 SD 2 as an incremental step toward 'āina momona. This bill would continue to support the Green Job Youth Corps program within the DLNR to help address the unemployment impacts of the COVID-19 pandemic and support economic diversification. It would also appropriate funds for this purpose. Without passing this bill current funding for the Green Job Youth Corps will expire next year.

Beyond supporting a stop gap in employment for our state the Green Job Youth Corps are important pathway to meeting the greater systemic needs we as a state identified during this pandemic: new workforce training, economic diversification, caring for our environment, and supporting businesses in Hawai'i as they work to make our state more self-sufficient and resilient

A primary function of KUA includes development of an 'auwai, a stream of resources, tools, bridges, relationships, and networks that help to cultivate and take our communities' work to greater levels of collective impact. A core catalyst for the flow in this 'auwai includes increasing the percentage of our economy which helps to manage and better the conditions of the natural resource and systems that sustain us. Indeed, the University of Hawai'i Economic Research Organization, with input from KUA and a number of partners (DLNR, Kupu, TNC, KS,OHA etc.) now tracks natural resource workforce development as a key part of a "Green Economy."

We are also supportive for what this opportunity could mean for increased environmental comanagement, co-governance and uplifting an ethic of mālama 'āina. Our current state institutions lack in resources but also in institutional ethos and policies that could better bolster citizen stewardship of our home. Key new generation staff members -such as exist within the Division of Aquatic Resources community-based subsistence fishing area and DOCARE Makai Watch programs- that do more work in partnership with communities are the future of environmental stewardship. This program will continue to help develop these new leaders and economic pathways toward sustainability. A state job corps that can build a conservation workforce for Hawai'i is a necessary pathway toward uplifting the environment which sustains and undergirds the "economy" for our state. It also further places our island community like others in the Pacific as a leader for environmental leadership and adaptation.

Please pass this bill out of your committee and mahalo for this opportunity to testify.

Aloha Chair Luke, Vice Chair Yamashita, and Members of the Committee:

The Nature Conservancy (TNC) supports SB 2768 SD2, Relating to the Hawai'i Youth Conservation Corps, which authorizes the Department of Land and Natural Resources to administer a green jobs youth corps program.

Hawai'i's natural environment is the engine that drives our state's economy and a natural, recreational, and cultural treasure supporting our island lifestyle and livelihoods. Careful, thoughtful, and intentional conservation, management, and restoration is required to ensure our environment can withstand the increasing impacts of climate change while continuing to fuel our islands' economic engine. TNC is proud of our decades of working in partnership with so many local organizations, agencies, and communities to care for this vital and fragile resource.

Since 2011, TNC has benefitted from the tremendous work of dozens of Kupu interns. These interns provide much needed capacity to help us manage our native forested watersheds and coral reefs. These enthusiastic and committed interns have created positive environmental, cultural, and community impact across the islands while also learning under the mentorship of environmental experts. Through their work, these interns are making a positive difference right now while also paving the way for the next generation of conservationists dedicated to perpetuating our unique island environment and diversifying Hawai'i's economy. This program would be funded and strengthened through SB 2768 SD2, which provides the platform and funding for additional Kupu internships and other green jobs across our islands. If the bill is not passed, there will be no continued funding for the program begun under Act 181 last year.

As we work together to create a diversified economy, green jobs can and must play a role. By providing opportunities for local jobs while also paving the way for long-term green jobs, environmental expertise, and local leadership, this legislation is an important step in the right direction, and we urge the committee to pass it.

Testimony in Strong Support of S.B. 2768 S.D. 2, Relating to the Hawai'i Youth Conservation Corps House Finance Committee Submitted by Kupu CEO John Leong, hearing date April 5, 2022

Aloha e Chair Luke, Vice Chair Yamashita, and Honorable Committee Members,

My name is John Leong, and I am the Chief Executive Officer and co-founder of Kupu, a statewide youth-focused conservation nonprofit. On behalf of Kupu, I am pleased to testify in **strong support** of **S.B. 2768 S.D. 2, Relating to the Hawai'i Youth Conservation Corps**. This bill is needed to continue the recently established Green Job Youth Corps, an innovative program helping young adults, expanding our green collar workforce, and supporting the vibrancy of Hawai'i's growing sustainability-focused economy.

As written, this measure would continue funding for the Green Job Youth Corps, a program that provides employment and training opportunities for young adults in conservation, sustainable agriculture, clean energy, and other sustainability-related industries. As the organization that managed the original green job corps program upon which the Green Job Youth Corps is based, and as the organization now partnering with the Department of Land and Natural Resources to administer this program, we have seen firsthand the benefits it is providing to individuals and to the diversification of our economy. We thank the legislature for establishing this program last year, and especially thank Senator Lorraine Inouye for introducing S.B. 2768 this year. The Green Job Youth Corps is an urgently needed addition to Hawai'i's strategy to address many of the needs of our state, including workforce development, environmental sustainability, economic diversification, and others.

Kupu was established in 2007, in the early stages of the Great Recession. Today we are a statewide organization, developing youth and young adults through hands-on service training in conservation and natural resource management professions. Since 2007 we have trained over 5,000 youth in conservation, sustainability, and environmental education. Young adults served by Kupu have provided more than 3 million service hours during this time, which included planting over 1 million native plants and removing over 100,000 acres of invasive species. This has created a cumulative \$155+ million in impact for Hawai'i with a 1:3 cost to benefit ratio. We

believe more investment in the green economy - as this bill provides - would enable similar economic benefits to our state, create jobs in related fields, and help diversify our economy.

In the early stages of the pandemic, Kupu saw the economic devastation happening in Hawai'i and wondered what more we could do to help. We created a new program -- in concept -- that would help unemployed and underemployed people of all ages work in the green economy during the pandemic. This program, called the Kupu 'Āina Corps, received funding and partnership from the state thanks to the foresight of the legislature and the support of Governor Ige, as provided by Act 9 (SLH 2020). With this program Kupu helped over 350 displaced workers and recent graduates connect with work, training, and the dignity of helping themselves and their communities. We are humbled that our program could serve as an example of what a longer-term program of this nature could achieve.

The ecological, economic, and human benefits of the Kupu 'Āina Corps were clear. Over 90 percent of our participants completed the program, gaining its full benefits and helping 150 different host sites across the state. Based on a post-program evaluation survey completed by participants, one in three remained employed or were moving on to other employment at the end of the program. Logging over 89,000 work hours, these participants produced an economic benefit estimated at \$6.55 million, based on a formula developed by Columbia University. (This was more than twice the cost of the program.) Additionally, these participants collectively improved over 21,700 acres of land across our state. Community-based conservation corps around the nation have inquired about the program, which has also received national media coverage.

When the legislature passed H.B. 1176 in 2021, signed into law by Governor Ige as Act 181 (SLH 2021), we were excited to see that the progress made in the 2020 Kupu 'Āina Corps program was going to continue in some form. Late last year, Kupu was selected by DLNR to partner on the continuation of this program. We spent the remaining months of 2021 recruiting and selecting participants, and have participants currently working and training in conservation, clean energy, and other sustainability-focused professions. In the early stages of the program, from the recruitment and onboarding alone we have seen tremendous interest from applicants, with well over two-and-a-half applicants for every position available. We also saw significant willingness from nonprofits and for-profits to host and train individuals. Without legislation to continue funding this program, the Green Job Youth Corps will not have funds to operate after this year, due to Act 181 providing funds on a one-year and not biennial basis.

We also strongly support S.B. 2768 S.D. 2's provision setting the maximum participant age at 38-years-old. In this year's program, the Green Job Youth Corps is focused on participants between the ages of 20 and 40-years-old, as was directed in H.B. 1176. Since the U.S. Census Bureau recently reported that Hawai'i's median age is 38.5 years old, the cap provided in the S.D. 2 still limits the program to individuals below the state's median age, and well below the median age for adults.

Please pass <u>S.B. 2768 S.D. 2</u>. Mahalo for this opportunity to testify in strong support of this important bill.

During the height of the pandemic, when hundreds of individuals found themselves out of work, Kupu was able to start up the Green Jobs Youth Corps program, which was modeled on a successful 2020 partnership between the State and Kupu. In this program, young adults have the chance to transition into jobs in conservation, sustainable agriculture, or clean energy/energy efficiency. The program has provided employment at a critical economic time for so many Hawaii households and introduced new people to the possibilities of a career in fields essential to the future of this State.

The program also supports nonprofits and for-profit sustainability organizations by giving them access to new workers at a reduced budget price point. This kind of support helped buoy many different organizations and businesses when everyone was struggling.
