Chair Ohno, Vice Chair Ganaden, and Members of the Committee:

The Department of Public Safety (PSD) supports the intent of Senate Bill (SB) 2774, Senate Draft (SD) 1, which provides funding to further expand huikahi restorative circles as part of the reentry planning process at the Women's Community Correctional Center (WCCC).

The success of these circles has allowed inmates to reconnect and reconcile with their families prior to release and to further develop their support system in the community.

As with other programs and services, the COVID-19 pandemic has impacted this program, and WCCC has not been able to schedule these circles on a consistent basis. One restorative circle was conducted in the Fall of 2021.

The Department believes that this process would be even more effective as a jail-diversion option for individuals in the community, such as, probation violators.

#### RELATING TO WOMEN'S COMMUNITY CORRECTIONAL CENTER

The Department of Budget and Finance (B&F) offers comments on this bill.

Senate Bill No. 2774, S.D. 1, appropriates an unspecified amount of general

funds for FY 23 to the Department of Public Safety for the Women's Community

Correctional Center to further expand reentry planning circles, also known as "huikahi"

circles, which are a part of a reentry planning process shown to decrease recidivism.

B&F notes that, with respect to the general fund appropriation in this bill, the

federal Coronavirus Response and Relief Supplemental Appropriations Act requires that states receiving Elementary and Secondary School Emergency Relief (ESSER) II funds and Governor's Emergency Education Relief II funds must maintain state support for:

- Elementary and secondary education in FY 22 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

Further, the federal American Rescue Plan (ARP) Act requires that states receiving ARP ESSER funds must maintain state support for:

- Elementary and secondary education in FY 22 and FY 23 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 and FY 23 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

The U.S. Department of Education has issued rules governing how these maintenance of effort (MOE) requirements are to be administered. B&F will be working with the money committees of the Legislature to ensure that the State of Hawai'i complies with these ESSER MOE requirements.

The Women's Prison Project (WPP) strongly supports this measure appropriating \$200,000 to provide the <u>reentry planning process</u>, <u>known as huikahi circles</u>, for incarcerated women in the Women's Community Correctional Center (WCCC). I am Lorenn Walker and a member of WPP. After leaving my position as a Hawai'i deputy attorney general, including defending the state in prison litigation, I earned a masters degree in public health to address social problems our legal system cannot solve. I have been studying effective reentry strategies for incarcerated people for almost 20 years. I've authored over 50 published papers about my work in academic journals and books. My personal experiences motivate this work including being incarcerated at age 16, and assaulted by a stranger (required major surgery and hospitalization) at age 24.

Reentry planning for incarcerated individuals is vital for their successful return to the community, and their desistance from crime (<u>Taxman, 2004</u>). Huikahi circles are for people who take responsibility for their behavior and want to make amends with harmed loved ones and the community—and who want to plan for their transition back into the community.

The process was first piloted in 2005 at Waiawa Correctional Facility. It has been provided at several state prisons, and mainly at WCCC. The circles have been provided *pro bono* and with private grants to the state prisons. Except for the state's federal 2021 <u>GEER grant</u>, the state has never funded the process for adults.

The process has been <u>extensively researched</u>. It is <u>healing for children</u> of incarcerated parents <u>and other loved ones</u>. Hawai'i Friends of Restorative Justice (HFRJ) strongly supports this measure appropriating \$200,000 to provide the <u>reentry planning process</u>, known as huikahi <u>circles</u>, for incarcerated women in the Women's Community Correctional Center (WCCC). HFRJ was incorporated as a non-profit in 1981 by a group of educators and lawyers testing an education program (*Street Law*) for youth under Honolulu's family court jurisdiction. Since then, HFRJ has developed and studied numerous educational and restorative justice projects. Over 50 papers about HFRJ's work have been published.

Reentry planning for incarcerated individuals is vital for their successful return to the community, and for their desistance from crime (<u>Taxman, 2004</u>). Huikahi circles are for people who take responsibility for their behavior and want to make amends with harmed loved ones and the community—and who want to plan for their transition back into the community.

HFRJ first piloted the huikahi reentry circle model in 2005 at Waiawa Correctional Facility. It has been provided at several state prisons, and mainly at WCCC. The circles have been provided *pro bono* and with private grants to the state prisons. Except for the state's federal <u>2021 GEER grant</u>, the state has never funded the process for adults.
