The Hawai'i Technology Development Corporation (HTDC) **supports** SB2807 that appropriates funds to the Hawaii Technology Development Corporation for the Manufacturing Assistance Program.

HTDC supports initiatives aimed at promoting technology and manufacturing jobs. HTDC has been providing MAP matching grants to manufacturers since FY16. A summary of the awards made by the matching grant program is listed below:

Due to budget shortfalls caused by the pandemic, HTDC did not receive an appropriation for FY21. Every year, there have been more qualified applicants than available funds. The funding awarded to companies provides a partial reimbursement (20%) for equipment upgrades and other eligible expenses. Through our federally funded INNOVATE Hawai'i program, HTDC provides wrap-around support services for the matching grants to help Hawai'i manufacturers become more globally competitive.

Hawai'i manufacturers plays an important role in our economy, for food-security, sustainability, and resilience initiatives, and is an important driver for innovation. HTDC believes the grant programs provide leverage and positive economic development value for the State. We support this request provided it does not supplant the Governor's priorities in the Administrative budget. Thank you for the opportunity to offer these comments.

RELATING TO THE HAWAII TECHNOLOGY DEVELOPMENT CORPORATION

The Department of Budget and Finance (B&F) offers comments on this bill.

Senate Bill No. 2807 appropriates \$1,500,000 in general funds for FY 23 to the

Hawai'i Technology Development Corporation (HTDC) for the Manufacturing Assistance

Program (MAP). B&F notes that the Governor's FY 23 Executive Supplemental Budget

already includes an appropriation request of \$500,000 in general funds for HTDC for the

MAP.

B&F notes that the federal Coronavirus Response and Relief Supplemental Appropriations Act requires that states receiving Elementary and Secondary School Emergency Relief (ESSER) II funds and Governor's Emergency Education Relief II funds must maintain state support for:

 Elementary and secondary education in FY 22 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and Higher education in FY 22 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

Further, the federal American Rescue Plan (ARP) Act requires that states receiving ARP ESSER funds must maintain state support for:

- Elementary and secondary education in FY 22 and FY 23 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 and FY 23 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

The U.S. Department of Education has issued rules governing how these maintenance of effort (MOE) requirements are to be administered. B&F will be working with the money committees of the Legislature to ensure that the State of Hawai'i complies with these ESSER MOE requirements.

SB 2807 – RELATING TO THE HAWAII TECHNOLOGY DEVELOPMENT CORPORATION

Chair Wakai, Vice Chair Misalucha, and Members of the Committee:

The University of Hawai'i (UH) supports this bill that appropriates funds to support the Manufacturing Assistance Program (MAP) at the Hawai'i Technology Development Corporation (HTDC).

HTDC's MAP offers Hawai'i-based manufacturers up to a 20 percent reimbursement of up to \$100,000 on qualified expenses to help them become globally competitive. These expenses include: equipment purchases, training, energy efficiency projects, and manufacturing feasibility studies.

The University of Hawai'i shares a similar vision with HTDC to help establish a thriving innovation-based sector to boost the local economy, create jobs and to develop a highly skilled technical workforce. Manufacturing is an important component of this process to help keep these businesses in Hawai'i.

With programs such as MAP, continued or increased funding for HTDC is crucial to moving innovation, commercialization and manufacturing efforts forward in the state.

To the Honorable Glenn Wakai, Chair; the Honorable Bernadette Misalucha, Vice Chair; and Members of the Committee:

Our company is an Oahu-based small business developing new ways to recycle waste generated in Hawaii into sustainable aviation fuel, green hydrogen, and other beneficial products such as new building materials. In part thanks to the coaching and commercialization planning assistance from the Hawaii Technology Development Corporation, we received our first-ever competitive Small Business innovation Research award a little over a year ago, and have now won our first-ever Phase II SBIR award. The matching funding provided by the State's HSBIR program were critical to be able to double our number of employees (all of whom are local) and cover the commercialization and patent protection costs that SBIR awards cannot fund. We have been able to use the SBIR and HSBIR funds to hire five University of Hawaii at Manoa and at West Oahu undergraduate interns for paid internships in Science, Technology, Engineering, and Math (STEM) projects over the past year. Our federal funding awards to date combined total over \$900,000, and our HSBIR matching funding grant last year was \$28,000. This represents a 32-times multiple on the State's funding for our company alone.

Please accept this testimony in support of this bill and urge you to restoring funding to the Phase II SBIR and Manufacturing Assistance Programs, at least to pre-pandemic levels. We will be continuing our feasibility study for a renewable jet fuel, green hydrogen, and firm renewable power manufacturing plant in Hawaii over the next several months. With the matching funding from those programs, we will be able to compete at the national level for the larger multimillion dollar competitive solicitations from federal agencies, such as the U.S. Department of Energy's \$5-8 million grants to construct pilot plants for new sustainable aviation fuel and green hydrogen manufacturing processes.

Makai Ocean Engineering, Inc. **STRONGLY SUPPORTS SB2807** that makes an appropriation to HTDC to provide grants to businesses through the manufacturing assistance program.

Makai Ocean Engineering, Inc. is a locally-owned and operated technology company based in Hawaii for nearly 50 years. While Makai has historically been an engineering services provider, with the help of the State's manufacturing assistance program, Makai has been able to diversify into low-volume manufacturing. Makai has been involved in marine-related engineering in Hawaii for over 50 years, and began a heat exchanger R&D program in 2009. Now, we are ramping up production from a small manufacturing plant for heat exchangers on the Big Island of Hawaii, which is sustaining approximately 8 highly-skilled, high-paying STEM / engineering jobs in rural Kona. We have a strategic advantage for developing and manufacturing low-volumes of these components in Hawaii for two reasons: the U.S. Navy and Air Force's presence in Hawaii, and Makai already owns and operates a marine heat exchanger test facility and marine corrosion lab on the Big Island. As an example, Makai has been awarded contracts by the U.S. Air Force, U.S. Army, and U.S. Department of Energy to design new heat exchangers for vehicle cooling and renewable energy applications. We hope to continue and scale-up manufacturing units over the coming years.

The program limits reimbursement to 20% of qualified expenses capped at \$100,000. Because they are matching funds, a manufacturer is eligible only if they are already making an investment in the local community and providing jobs. The program amplifies these efforts, and shows the State's support for local manufacturers willing to make the investment and commitment to adding jobs, and growing their businesses and the industry in Hawaii.

This is why we **STRONGLY SUPPORT SB2807**, which would provide the state matching funds for manufacturing assistance to enable companies to build a manufacturing base in the islands. Not only would this expansion of funding enable our tech industry to advance manufacturing within the State, it would provide highly-skilled professional engineering and manufacturing jobs for our keiki here at home.
