S.B. 2895, S.D. 1 RELATING TO METROPOLITAN PLANNING ORGANIZATIONS

Senate Committee on Ways and Means

S.B. 2895, S.D. 1 creates a temporary intergovernmental task force to assist in the establishment and certification of a metropolitan planning organization (MPO) for the County of Hawaii. It requires the Department of Transportation (DOT) to provide a list of certain highway projects to the task force and a report to the legislature.

The DOT **opposes** this S.B. 2895, S.D. 1 because it conflicts with federal regulations. 23 Code of Federal Regulations 450.310 states that an MPO "shall be designated for each urbanized area with a population of more than 50,000 individuals (as determined by the Bureau of the Census)." Therefore, the process required by this bill not only conflicts with federal regulations but also creates redundant and unnecessary processes. The DOT would support the creation of an MPO if the Bureau of the Census designates Hilo to meet the urbanized area requirements of an MPO. The Bureau of the Census is expected to release this information in the summer of this year.

Instead of forming the task force required by the bill, the DOT recommends meeting with the County of Hawaii as part of the existing transportation planning process to discuss potential alternatives to forming an MPO—for example, the potential for creating a Regional Transportation Planning Organization (RTPO). Similar to an MPO, the responsibilities of a RTPO would include:

- -ensuring transportation equity
- -conducting public involvement and non-metropolitan stakeholder involvement
- -developing, updating, and implementing the regional long range land transportation plan
- -developing and managing the regional Transportation Improvement Program
- -managing the work program
- -participating in statewide planning activities
- -be involved in and lead regional special studies

Funding for an MPO or RTPO would come out of existing funding sources. Federal funds would be split among the existing MPOs and RTPOs for Hawaii. The exact distribution of Federal funds would be determined through development of a planning agreement among the existing MPOs and RTPOs for Hawaii.

Aloha Chair Dela Cruz and Members of the Committees:

I thank you for the opportunity to testify in support of SB 2895 SD1. My testimony is submitted in my individual capacity as a member of the Hawai'i County Council and Chair of the Hawai'i County Council Climate Resilience and Natural Resource Management Committee.

The Federal-Aid Highway Act of 1962 required metropolitan planning organizations to be established for any urbanized area with a population over 50,000 as a condition to eligibility for federal transportation financial assistance. Metropolitan planning organizations to serve as a forum for promoting collaboration among local communities and government agencies and to direct federal funds toward projects that increase access to opportunity and prosperity through improved multimodal pedestrian, bicycle, and transit options.

According to the 2020 United States Census, which provides critical data that lawmakers, business owners, and many others use to provide daily services, products, and support for communities throughout the nation, the population of the county of Hawai'i has grown to over two hundred thousand; thus moving local officials to reexamine the feasibility of a metropolitan planning organization to address the many transportation infrastructure and connectivity challenges exasperated by its growing population and topography.

Aloha Chair Dela Cruz, Vice-Chair Keith-Agaran and Members of the Committee on Ways and Means:

Mahalo for the opportunity to testify in support of SB 2895, relating to a metropolitan planning organization [MPO] within the County of Hawai'i, with consideration of comments submitted by County of Hawai'i Mass Transit Administrator, Mr. John Andoh.

In our work on the Hawai'i County Council to update and modernize our construction codes, it has become clear that we have many challenges facing us with our transportation infrastructure and connectivity. With our growing population and topography, I am hopeful we can substantially address these issues by creating a process for the Department of Transportation [HDOT] to authorize the formation of Regional Transportation Planning Organizations [RTPO]. As stated by Mr. Andoh, this would dovetail with the County's Planning Department's efforts in performing this assessment and consider the evaluation of the formation of a RTPO as the first step towards a MPO.

The allowance of a RTPO could set the framework towards creating a formal MPO once the population reaches the threshold; likely in the 2030 census. In the meantime, the RTPO could operate on the same principles as a MPO with a policy board, technical advisory committee and citizen advisory committee to support the work.

The importance of this collaborative work cannot be minimized. The decisions and direction set through this endeavor will directly impact projects like affordable housing and public infrastructure, and the ability of public and private sectors to deliver those projects in a timely manner when they are needed the most. Therefore, this kuleana is definitely worthy of our support.

Mahalo, again, for the opportunity to recognize the collaborative efforts needed between the State and County as we evolve our transportation and mobility planning for Hawai'i Island. Our

work is ongoing and there is much to be done. By partnering and focusing our efforts to allow HDOT to implement RTPOs, we will make the best use of our precious resources and develop viable solutions for a more efficient and effective transportation system. Our residents deserve access and opportunities to live in a vibrant Hawai'i.

The Hawai'i County Council adopted Resolution 262-21, which calls for intergovernmental collaboration to assess Hawai'i Island's transportation infrastructure and identify steps necessary to establish, administer, and staff an MPO.
