Fiscal Implications: The staff and programs of the Office of Primary Care and Rural Health are funded solely through federal project grants and the Department of Health does not have the resources to implement the requests as outlined in this measure. The Department requests that passage of any appropriations in this measure does not replace or adversely impact priorities indicated in our Executive Budget.

**Department Testimony:** The Department respectfully offers comments on S.B. 2914, which 6 establishes the one shared health vision plan with a pilot program in Hawai'i County. This 7 measure may not be needed since it duplicates efforts that are already underway. The 8 9 Department of Health, Office of Primary Care and Rural Health (OPCRH) is engaged with 10 community-based organizations on Hawai'i Island, including the Hawai'i Physician Shortage 11 Taskforce and Community First, to conduct a Community Health Needs Assessment for Hawai'i County. Efforts to date have resulted in over two thousand survey responses and eleven focus 12 groups with providers, community members, and social service organizations. Currently the 13 14 results of these interactions are being analyzed and a report is in development. Additionally, 15 there are plans to expand this work to other rural areas throughout the state as a part of a broader 16 effort to address disparities in health equity.

Chair Moriwaki, Chair Keohokalole, and Members of the Committee:

The Hawaii Primary Care Association (HPCA) is a 501(c)(3) organization established to advocate for, expand access to, and sustain high quality care through the statewide network of Community Health Centers throughout the State of Hawaii. The HPCA <u>SUPPORTS</u> Senate Bill No. 2914, RELATING TO HEALTH., but bring to your attention our concerns.

By way of background, the HPCA represents Hawaii's Federally Qualified Health Centers (FQHCs). FQHCs provide desperately needed medical services at the frontlines to over 160,000 patients each year who live in rural and underserved communities. Long considered champions for creating a more sustainable, integrated, and wellness-oriented system of health, FQHCs provide a more efficient, more effective and more comprehensive system of healthcare.

This bill, as received by your Committee, would direct the Office of Primary Care and Rural Health (Office) within the Department of Health to initiate a 2030 "One Shared Health Vision" plan for the County of Hawaii. This bill would also require the Office to facilitate discussions with key community health and social service organizations within Hawaii County to address the health and wellness needs of the most vulnerable populations.

The HPCA and its member FQHCs stand committed to participating and assisting in this endeavor. We note that three of our members serve the people of the County of Hawaii -- Bay Clinic; Hamakua-Kohala Health; and West Hawaii Community Health Center. All provide high-quality primary care to Hawaii County's Medicaid population.

### Comments:

Thank you for the opportunity to testify on behalf of Bay Clinic in **SUPPORT of SB #2914**, which establishes the "one shared health vision" plan for Hawai'i County, which requires the Office of Primary Care and Rural health to facilitate discussions with key community health and social service organizations to address the health and wellness needs of the most vulnerable.

I personally approached Senator Dru Kanuha's Office to propose this first step in aligning the health priorities for our most vulnerable citizens on Hawaii Island. I believe this will help decrease competing funding requests that much of our islands Health entities are seeking from the legislature. The goal is for everybody to support each other's mission and to pause when we are crossing each other's lanes. The intent is collaboration not competition or duplication of services.

On the island of Hawaii, there's a nonprofit agency called Community First. They are funded through the county to provide an island-wide community needs assessment and they have already assembled partnerships to fulfill the intent of this legislation. Although much of the work can be done by Community First, this legislation will ensure that a 2030 plan will developed. Questions like do we need more health centers? Do we need another hospital? How can we increase more specialists on island? Do we need more urgent cares? Should health centers consolidate their services and what are the pros and cons of consolidation? Is competition in healthcare good for the island? It is here that HPCA and the Rural Health Association can serve more of a liaison overseeing the process.

The Hawaii State Rural Health Association (HSRHA) respectfully submits comments on S.B. 2914, Relating to Health.

As a non-profit rural health association, our mission is to advocate for rural health issues and promote communication, education and research of issues related to rural health. Our vision is that we are the collaborative health leader for rural communities in Hawai'i.

Though Hawaii State Rural Health Association thanks the Legislature for attention to these needs, we also wish to inform you of our progress on this matter.

Recognizing the great importance to understand our state's rural communities' health and wellness needs, the Hawaii State Rural Health Association launched a health needs assessments initiative for the neighbor island counties. This project started with Hawaii County, with Community First as the lead and Hawaii State Rural Health Association as the secondary organization supporting the undertaking. These efforts include community and provider surveys of needs and stakeholder focus groups including business chambers, providers, hospitals, federally qualified health centers, and others. In total, we have completed 11 focus groups and received over 2,000 survey responses from Hawaii Island. Approximately 10% of responses were from providers; the rest represent community members.

Initial findings from Hawaii Island are currently in draft.

Thank you for the opportunity to provide comments and for your support and recognition of the unique needs of the rural geographies of our state.
