SENATE BILL NO. 2964, SD1 RELATING TO AGRICULTURAL DISTRICTS

Chairperson Rhoads and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill No. 2964, SD1 that amends the State land use law (Section 205-4.5(d)) by specifying "recreational athletic venues" and "cultural activities that promote the arts" as permissible uses on golf courses on Agricultural District land that were approved for development by a county prior to July 1, 2005. The Department of Agriculture has very strong concerns that this measure that would amend Chapter 205 to circumvent State and county land use regulations. This may adversely impact the integrity of Hawaii's extensive contiguous agricultural lands with existing or potential for intensive agricultural production.

An example of extensive contiguous agricultural lands with existing intensive agricultural activity is the Kunia Road corridor between the Village Park/Royal Kunia residential communities to the south and Schofield Barracks/Wheeler Army Airfield to the north. For many years, both the City and County of Honolulu and the Department of Agriculture have identified this area as possessing the most productive agricultural

lands on Oahu. To date, there has been 3,252 acres of agricultural land designated as Important Agricultural Land in the Kunia corridor. These designations were voluntarily sought by the landowners who now have access to the IAL Incentives that the Legislature passed in 2008 to help sustain and establish agricultural activity on these lands. The Department of Agriculture urges the Legislature to not allow non-agricultural uses as permitted uses on agricultural lands in such a highly protected area.

Chair Rhoads, Vice Chair Keohokalole, and Members of the Senate Committee on the Judiciary.

The Office of Planning and Sustainable Development (OPSD) offers **comments** on SB 2964 SD 1, which would amend Hawaii Revised Statutes (HRS) §205-4.5 (d) to allow recreational athletic venues and cultural activities on existing golf courses within the State Land Use Agricultural District. Golf courses and golf driving ranges are allowed within the State Agricultural District under §205-4.5 (d) only if they were approved by a county before July 1, 2005. Otherwise, these are expressly prohibited uses within the State Agricultural District under \$205-4.5 (a) (6).

Recreational athletic venues and cultural activities that promote the arts are also nonpermitted uses within the State Agricultural District under HRS §205-2 (d) and HRS §205-4.5 (a). OPSD notes that this bill would allow a grandfathered non-permitted use within the Agricultural District which would not be allowed if proposed after 2005, to have additional nonpermitted uses. Existing State and county laws already provide ways to accommodate such uses, for example, through a Special Permit, a State Land Use District Boundary Amendment, or a county zone change.

SUBJECT: Senate Bill No. 2964, SD 1 Relating to Agricultural Districts

The Department of Planning and Permitting **opposes** Senate Bill No. 2964, SD 1, which authorizes recreational athletic venues and cultural activities that promote the arts on existing golf courses within the State Land Use Agricultural District.

The measure's broad language would allow a wide range of activities that ostensibly promote the arts, on a permanent, full-time basis. These could include amusement activities and events, such as art, music, and dance festivals, as well as concerts, which typically are considered urban-type activities. We recognize the allure to use agricultural lands for these events as they represent large open spaces that are able to accommodate a large crowd and parking. However, such uses in the Agricultural District are not supported by City agriculture and open space land use policies contained in our long-range development plans. These policies support golf course, agriculture, and open space uses, not the more urban-type land uses that could be allowed if this Bill became law, such as stadiums and racing vehicle tracks/circuits. Such uses should be reviewed via the Special Permit process, pursuant to Section 205-6, Hawaii Revised Statutes (HRS). This process requires details of a proposed project to be disclosed and evaluated on its own merits, and allows for conditions to be placed on the applicant to mitigate the activity's impact on the project site and surrounding areas.

It is ironic that this Bill would allow urban-type uses on existing golf courses, which became nonconforming in the State Agricultural District in 2005 due to the

concern over non-agricultural use proliferation on agricultural lands. Allowable uses proposed in this Bill are more appropriately located in the Urban District.

There are five golf courses on Oahu that are in the Agricultural District. They are: the Hawaii Country Club, Hawaii Prince, Mililani, Royal Hawaiian, and Ted Makalena golf courses. Except for Hawaii Country Club, these golf courses abut or are surrounded by residential uses. As mentioned above, athletic venues and performing arts activities at these golf courses would be contrary to the City's agriculture and open space land use policies, and may negatively impact the surrounding residents and community.

We ask that this bill be deferred.

My name is Mr. Guy Fong and I represent the Hawaii Country Club Golf Course, one of the four privately operated golf courses on Oahu this bill impacts.

We fully support this bill passing- however, there was a concern that the bill could be interpreted permitting motorized vehicular racing events when SB2964 was heard previously at the AEN/WTL joint hearing.

To address that concern, please consider defining recreational events and culture and the arts to exclude, and carve out, motorized racing- making that activity a prohibited venue. We are **not** advocating for motorized racing activities.

From carnivals, farmers markets, weddings, music festivals to outdoor movies, the four golfcourse properties located within the State Agricultural District should be able to serve and play host to temporary special events just like any other golf course can that is not located within the Ag District.

In 2019, the City and County of Honolulu published its Important Agricultural Land (IAL)map and **declined** to include the four privately operated golf course properties located within the State Ag District as qualifying for that status. Thus, the justification for the State to continue to treat the four privately operated golf courses as having congruity to the agricultural district is moot.

It's time to lift the prohibition on outdoor recreational sports and culture and the arts activities from taking place on the four privately held golf courses.

Please pass SB2964 SD1.

Aloha Chair Rhoads, Vice-Chair Keohokalole, and Members of the Committees:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau respectfully offers our concerns about broadening the scope of the current exemption that allows golf courses that were previously approved within the agricultural district to continue to operate.

Allowing for open-ended, undefined "Recreational athletic venues" and "Cultural activities that promote the arts" may lead to unintended consequences that may conflict with or be incompatible with the surrounding agricultural operations, for example, due to the activities of normal farm operations that may be considered to be nuisances by these new ventures on golf courses, or former golf courses.

And because the terms are not defined, would vacation or camping facilities, for example, including temporary residences be considered to be "recreational athletic venues"? We believe that misuse or abuse of the expansion of the grandfathered golf course exemption is likely.
