Chairpersons Gabbard and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill 3004. The bill establishes and appropriates funds for a compost reimbursement program within the Department of Agriculture and one full-time permanent compost reimbursement program manager position to oversee the program and requires an annual progress report of the program to the legislature prior to each regular session. The Department supports this bill.

The Department successfully administered a similar program in 2019-2021 and would implement the same controls to ensure the proper disbursement of funds for this program. In order to maximize funds available for reimbursement, the program will be adminstered by existing staff. The previous program was popular with the agriculture sector and would assist farmers and ranchers with compost costs.

RELATING TO COMPOSTING

The Department of Budget and Finance (B&F) offers comments on this bill.

Senate Bill No. 3004 requires the Department of Agriculture to establish a compost reimbursement pilot program to provide reimbursements to farmers and ranchers for up to 50% on purchases of compost from certified vendors, provided that no single farmer or rancher can receive more than \$50,000 per year. This bill also appropriates an unspecified amount of general funds in FY 23 for 1.00 permanent Program Manager position, program administrative costs, and reimbursements.

B&F notes that, with respect to the general fund appropriation in this bill, the federal Coronavirus Response and Relief Supplemental Appropriations Act requires that states receiving Elementary and Secondary School Emergency Relief (ESSER) II funds and Governor's Emergency Education Relief II funds must maintain state support for:

 Elementary and secondary education in FY 22 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and Higher education in FY 22 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

Further, the federal American Rescue Plan (ARP) Act requires that states receiving ARP ESSER funds must maintain state support for:

- Elementary and secondary education in FY 22 and FY 23 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 and FY 23 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

The U.S. Department of Education has issued rules governing how these maintenance of effort (MOE) requirements are to be administered. B&F will be working with the money committees of the Legislature to ensure that the State of Hawai'i complies with these ESSER MOE requirements.

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports SB 3004, which establishes and appropriates funds for a compost reimbursement program within the department of agriculture and one full-time permanent compost reimbursement program manager position to oversee the program.

HFB strongly supports the concept of building soil structure and nutrient capacity. Caring for the soil is a cornerstone to having multigenerational farms that continue to provide for the people of Hawai'i. Many of our farms add compost made off-site as well as utilize short-term fallow between crop cycles to increase organic content in their soils. HFB recognizes and supports the diversion of discarded food and other useful wastes away from landfills. The benefits of this and of composting are well-known.

Farming is a tough business. High production costs are a major driver of narrow profit margins for Hawai i's farmers. Land, water, labor, taxes, transportation, utilities, inputs, invasive species, and food safety regulations are all costs of doing business that often results in our farmers just being able to break even. HFB supports this initiative that could reduce the cost of production for local farmers by incentivizing, with a 50% match, the use of compost material. This is another mechanism that can help locally produced goods compete with imported products, strengthening our local economy.

We stand in support of SB3004 establishing a compost reimbursement program and program manager because the benefits of compost are undeniable and numerous: organic waste reduction, reduced burden on landfills, improvement of our agricultural soils, and reduced toxic fertilizer use.

The concept of composting is not a new one; it is an ancient technology that Native Hawaiians and peoples around the world have practiced for thousands of years. Pits used for compost would allow households to compost their own waste and enrich the soil. But today people have come to rely on synthetic fertilizers that eventually runoff into our oceans and streams, creating deadzones that kill our marine life. When our home is surrounded by water, this fact is especially alarming and concerning for all our marine life prevalent in our waters. Supporting, encouraging, and incentivizing the use of compost through a bill like **SB3004** could effectively increase the accessibility of this extremely valuable resource.

By increasing the access and demand for compost, other efforts to divert food waste and other organic materials from the landfill could fall into place also. Compost can be used in many markets, from agronomic, horticultural, urban/suburban landscaping, forestry, to bioremediation. This bill would be supporting a diverse set of actors in Hawai'i's economy.

Especially with ambitious goals set by the Aloha+ Challenge of doubling local food production by 2030 or Act 175 requiring 30% of school foods to be local, meeting these goals will be dependent on the quality of our soils, which are the foundation to agriculture. The increased accessibility to compost resulting from this bill would increase the quality of soil and its ability to produce nutritious foods to meet our local food production goals.

To ensure the benefits are incurred for our local economy, we are requesting that **SB3004** be <u>amended</u> to specify beyond just reimbursements for compost from a certified processor, dealer, retailer, or wholesaler licensed to do business in the State, but that the
