1 EOA's Position: Thank you for scheduling a hearing on this measure. The Executive Office

- 2 on Aging (EOA), an attached agency to the Department of Health, strongly supports SB3113 SD
- 3 2, Relating to Kupuna Care Program and offers an amendment.
- 4 Fiscal Implications: \$1.5 million is being requested in HB1600 HD1 for the Executive Office
- 5 on Aging (HTH-904) for the Kupuna Care Program to enable working caregivers to maintain
- 6 their employment.

7 **Purpose and Justification:** The purpose of this bill is to amend Chapter 349, part II, HRS, to

- 8 incorporate the Kupuna Caregivers Program into the Kupuna Care Program.
- 9 The Kupuna Care Program began in 2001 to provide long-term services and supports to kupuna,
- and the Kupuna Caregivers Program was established in 2017 specifically to provide support for
- 11 working caregivers. However, EOA determined that having two programs that offer the same
- 12 services for the kupuna and the caregiver caused silos in the system and did not lend itself to a
- 13 seamless system of supports for older adults and their caregivers.

1	The combined program model will streamline the administrative and programmatic burdens
2	imposed by both programs while continuing to provide an array of seamless services and
3	supports to meet the holistic and comprehensive needs of both older adults and their caregivers.
4	The purpose of this measure is to increase efficiencies in implementation and delivery of services
5	by the Area Agencies on Aging (AAA).
6	The EOA will include a provision in our Kupuna Care contracts to earmark the \$1.5 Million
7	additional allocation in the budget bill for caregivers' support.
8	Additional highlights in the bill are:
9	• Adds definitions for "caregiver", "caregiver support services", "employed
10	caregiver", and "financial management service provider"
11	• Adds "caregiver support" and "respite" services for the employed caregiver into
12	the list of Kupuna Care services
13	• Adds "care coordination" to the list of services for the care recipient (older adult)
14	• Simplifies the process of delivering services through the Kupuna Care Program
15	(i.e., traditional service delivery and participant-directed services)
16	• Specifies that the Kupuna Care Program shall award funds for services to the
17	service provider or financial management service provider upon receipt of an
18	invoice for services rendered
19	EOA offers an amendment to SB 3113 SD 2 Page 5, line 20 amend (D) "Chores" to "Chore" to
20	be consistent with the Older Americans Act.
21	Recommendation: EOA recommends the merger of both programs under the title of KUPUNA
22	CARE with the dual purpose to serve the needs of Hawaii's kupuna and caregivers, under a more
23	efficient and streamlined administrative and programmatic system. EOA strongly supports
24	SB3113 SD 2 with amendments.

Dear Chair Luke, Vice Chair Yamashita, and Members of the Committee,

Members of AAUW of Hawaii thank you for this opportunity to testify in strong support of SB3113 which would incorporate the kupuna caregivers program into the kupuna care program and add services for care recipients, caregivers, and employed caregivers. This action is needed to guarantee care, independence and dignity for the many kupuna and dedicated caregivers in our communities.

Women shoulder a disproportionate burden of elder care responsibilities: About 25% of women aged 45-64 care for an older relative according to a 2019 survey from the Bureau of Labor Statistics. Being forced to leave the labor force to do unpaid care work limits women's advancement and corresponding pay increases, contributing to the gender pay gap. On average, women spend 12 years less in the workforce than men – if they choose to leave workforce to take care of their elders at least they are getting compensated. By offering support services to care recipients, caregivers, and employed caregivers, SB3113 allows caregivers to remain in the workforce so they can support their families while ensuring care for older relatives.

Many kupuna find a shortfall in dollars spent for basic care and assistance and the gender pay gap also continues into retirement, with the 2019 U.S. Census Bureau American Community Survey showing a nearly 30% difference in total retirement income between men and women. There are serious and disproportionate financial barriers to seniors aging in place and avoiding institutionalization. Providing the support services outlined in SB3113 for the kupuna care program will greatly assist all older adults who wish to continue residing in their homes.

The American Association of University Women (AAUW) of Hawaii is an all volunteer, statewide chapter of a national organization and is made up of six branches: Hilo, Honolulu, Kaua'i, Kona, Maui, and Windward O'ahu. UH Hilo, UH Mānoa, UH Maui College, and Windward Community College are also AAUW partners. AAUW's mission is to advance gender equity for equal opportunities in education, at workplace and for economic security, and in leadership.
