Fiscal Implications: Funding estimated at \$100,000 would be needed for the Department of Health to implement this measure including, medical records system changes, training and data analysis and reporting. The Department requests that passage of any appropriations in this measure does not replace or adversely impact priorities indicated in the Department's supplemental budget request.

6 Department Testimony: The Department of Health supports the intent of S.B. 3206 that
7 requires first responders to record in the incident report for each water rescue event the type of
8 snorkel and mask, if any, worn by the person who was rescued or recovered. The Department is
9 providing comments in regard to emergency medical services only.

Every year an average of 66 Hawaii residents and visitors experience snorkel related drowning 10 11 events, including 20 which are ultimately fatal. Data is not systematically collected on the 12 circumstances of the event or type of snorkel. Understanding snorkel use can lead to better public health messaging and improvements in snorkel design. The Department of Health 13 14 recently installed a Department of Transportation compliant NEMSIS 3.4 pre-hospital medical 15 record system statewide. Although the system meets all state and federal requirements, the system has no data entry fields for collection of snorkel information nor does any other 16 17 commercially marketed medical record system. In order to collect, study and report the 18 information proscribed in this bill, changes need to be made to the existing pre-hospital medical 19 record system. Systematic data collection is needed. Three components are required: 1) the addition of snorkel specific data fields, 2) training for field personnel, and 3) reports 20

- 1 summarizing the newly collected data. The data fields would include (to name a few) snorkel
- 2 type, circumstances of the event, and familiarity with use of snorkel equipment. To fulfill the
- 3 intent of this bill, funding would need to be appropriated for the project.
- 4 Although the bill mandates this data collection, the department does not recommend a mandatory
- 5 requirement. Providing the paramedic and emergency medical technicians a convenient way to
- 6 document in the pre-hospital medical record is the preferred way.
- 7 Thank you for the opportunity to testify on this measure.

Aloha Chair Nishihara, Vice DeCoite, and Senate Committee on Public Safety, Intergovernmental, and Military Affairs Members Baker, Fevella, and Riviere,

Mālama Pūpūkea-Waimea (MPW) is a Hawai'i non-profit organization founded on the North Shore of O'ahu in 2005. Our mission is "working to replenish and sustain the natural and cultural resources of the Pūpūkea and Waimea ahupua'a for present and future generations through active community stewardship, education, and partnerships." For eighteen years, we have focused our stewardship and education efforts on the Pūpūkea Marine Life Conservation District (MLCD), one of only three MLCDs on O'ahu and eleven statewide.

Due to the Pūpūkea MLCD's extreme popularity as a premier snorkeling destination and our constant presence there, we see first-hand the unfortunate number of snorkeling-related rescues conducted by our City and County lifeguards. Often, in the moment of an in-water emergency, whatever mask a victim was wearing is tossed aside as resuscitation measures are taking place and there is no documentation of gear type.

We **support SB3206** to require first responders to document which type of mask a victim was wearing when the emergency occurred because we indeed notice that far more in-water snorkeling emergencies happen with people wearing full-face masks in comparison to the traditional two-piece mask and snorkel. Collecting this data would allow the Hawai'i Department of Health to assess the risk of certain equipment, and ultimately take action to inform and protect the thousands of people who snorkel throughout Hawai'i each day.

Voting in favor of SB3206 would enable updates to the Hawaii Department of Health's system to allow for much-needed snorkeling equipment data collection and analysis.

My name is Julie Urbon. I strongly support SB 3206 which would require first responders to document what type of snorkel equipment is used during rescue and recovery incidents. It is my understanding that this information is not currently collected in a consistent or standardized manner which cripples the Dept. of Health's understanding of the true risks of full-face snorkel masks.

This bill was introduced in honor of David Loasby, who died while using a full-face snorkel mask in December 2021. I was there with his family just before the incident occurred. I see daily the pain this has caused his family.....Not just that Dave lost his life, but the added anger and hurt knowing that it might have been preventable. Since the tragedy, I have done digging and found that studies on these masks has shown that carbon monoxide can build up and can render the user unconscious. But apparently no one is willing to definitively say that there is a direct link to increased drowning? I think it is safe to say that going unconscious while in the water definitely increases your risk of drowning. This seems like such a basic request.... when a snorkeler dies, document what type of equipment the victim was using. A study can only go so far. The studies show that there are concerns. Once the product is on the market, any "additional data" is unfortunately gathered after the fact. We cannot let this valuable information go uncollected.

Many tourists who come to the islands only snorkel a few times a year and don't know a great deal about the differences in the types of masks that are sold. Many times, the rented condos have snorkeling equipment available for use, so if a warning were on the original packaging.... It would do no good. There are snorkel tours on Maui that ban those masks on their boats. Why would they do that if they didn't see the connection? They are the ones most familiar with the equipment. If THEY are nervous about the masks... we should all take notice and listen. And yet the masks are sold widely. Had we gone on a snorkeling tour, we might have heard about the risk through the tour operator, but instead we snorkeled at the beach near our accommodations. A beautiful vacation turned into a horrific nightmare because "not enough information is there to conclude those masks are dangerous"? Then we need to collect the information! It is simply one more question for first responders to ask or determine if possible. In a car accident, isn't it documented whether the passengers were wearing seat belts? It harms no one to collect this information. I think it sends a horrible message if the state is unwilling to take a simple step to be more thorough in the investigations into these drownings to safeguard local residents as well as the tourists that are such a part of the local economy. I appreciate your time. Imagine it was a member of your family....

My name is Rachel Lance, and I am a PhD researcher at the Duke University School of Medicine specializing in the physiology and survival of human beings in extreme environments, such as underwater. I also worked for many years as an engineer with the US Navy, where I specialized in the design and testing of underwater breathing systems.

Full face snorkel masks (FFSMs) present an as-yet-unknown level of risk to snorkelers. Through the clever use of the word "snorkel" in their name, they have slipped into the commercial market without regulation or scrutiny, as if they are the same type of product as the simple breathing tube snorkel with which we are all familiar. However, although they allow the same sport of snorkeling, FFSMs work very differently. Unlike a normal snorkel, FFSMs manipulate and direct breathing flow in a deliberate, functional way that traditional snorkels do not. They have mechanical valves and seals, which snorkels do not. They FFSM themselves perform an active function that allows people to breathe, and they have parts that can fail, which might interfere with the gas supply. In short: in my opinion, FFSMs may allow snorkeling, but they are more than just snorkels. Rather, they would be more appropriately classified as breathing equipment. I think that calling an FFSM a snorkel is like calling an airplane a parachute simply because both allow you to travel through the sky and descend to earth safely. In reality, one is more complex than the other, and therefore needs more testing and oversight.

However, our route to testing and regulation for FFSMs, which will hopefully stop the rash of FFSM fatalities, is complicated by the fact that it's almost impossible to conduct proper statistics on the devices. Are more people dying with FFSMs? Or is it simply that we don't have complete statistics? Is one type of mask causing most of the deaths, with the other ones being safe? Can we therefore prevent deaths simply by removing one or two problematic models?

I recently completed a research project that found one problematic feature for some models of FFSM that could lead to user breathing issues (the paper is peer-reviewed and will be published in the academic journal *Undersea & Hyperbaric Medicine* on Feb 11), and other peers in the field have found other problems with different model FFSMs as well. Passing this bill is an important public safety step toward gathering the data we need to understand how widespread this problem is, what is causing it, and hopefully stop the deaths.
