Relating to the Sunshine Law

Thank you for the opportunity to submit testimony on this bill, which would apply the requirement for a board member participating in a remote meeting to state the names of persons present who are 18 or older or below 18 but have a private interest in an issue before the board. The Office of Information Practices (OIP) offers comments.

The Sunshine Law's newly effective remote meetings provision requires a board member participating from a nonpublic location to state who, if anyone, is present at the same location. This gives the public some information about off-camera voices or presences they may notice with a board member and prevents speculation as to whether they represent a lobbyist or a household member or child. OIP interprets the current provision not to specifically require identifying everyone present by name, but instead to allow for a statement such as "my children are in and out of the room" without specifically identifying the children in question. This bill would specifically require identifying all adults, and minors with a private interest in an agenda issue, by name. **OIP has no objection to the proposed amendment**.
