# S.B. 3370 RELATING TO CONSTRUCTION MANAGEMENT

Senate Committee on Transportation

The Department of Transportation (DOT) **opposes** this bill that creates a three-year pilot program within the DOT that requires procurement of professional services from construction management consultants using the competitive sealed bidding and competitive sealed proposals methods of procurement. Exempts emergency procurements. Requires annual reports to the Legislature. The DOT opposes the bill for the following reasons:

- The Brooks Act of 1972 (Public Law 92-582) establishes a qualifications-based selection process, in which contracts for A/Es are negotiated on the basis of demonstrated competence and qualification for the type of professional services required at a fair and reasonable price.
- The majority of Highways construction management consultants are federally funded and subject to procurement in compliance with the Brooks Act.
- 103D-302, Hawaii Revised Statutes (HRS) (Competitive Sealed Bidding) is not compliant with the Brooks Act
- 103D-304, HRS (Procurement of Professional Services) provides a procurement mechanism that is compliant with the Brooks Act.
- Procuring the services of licensed Professional Engineers, Architects, Surveyors and/or Landscape Architects as construction management consultants provide the competency, qualifications and experience needed to oversee projects.

Dear Chair Lee, Vice Chair Inouye, and Committee Members:

We strongly oppose this bill because it does not comply with HRS §103D-304, which involves Qualifications-Based Selection (QBS). Construction management services, just like design services, for all Hawaii DOT (and all public works) construction projects should only be performed by professionals licensed under HRS Chapter 464 that are deemed the most qualified for the specific nature and scope of each individual project – NOT THE LOWEST BIDDER.

The primary reasons for this include the roles of responsibility that construction management services have regarding public safety and responsible oversight of government-funded construction projects. That is why Qualifications-Based Selection (QBS) is the nationally recognized model for procuring construction management services, and design services, for all public works construction projects.

Construction managers serve as the project owner's on-site representative and are responsible for observing and documenting compliance with the design plans and specifications and project permits. They are intimately familiar with the scope of work, project tasks, and potential constructability constraints. Construction mangers need to work closely with the designers and construction contractors to solve potential unforeseen circumstances. This essential collaboration is needed for safety reasons and can help minimize cost overruns, but only if the most qualified professionals are selected on a project-by-project basis to serve as the construction manager.

Our construction services group is thoroughly familiar with the requirements and needs of a qualified and knowledgeable construction manager position on construction projects. They are an essential person tasked with ensuring compliance with the plans and specifications as well as contract management. This position requires a high level of construction processes and contracting knowledge to ensure the project proceeds according to schedule and remains within budget. Construction mangers need to work closely with the contractor to solve potential unforeseen circumstances. This essential collaboration can help minimize cost overruns or costly change orders if the construction manager is thoroughly qualified and properly trained.

It is crucial that the construction manager have a deep understanding of design and construction processes. We are unsure if the bill is attempting to encourage the use of unlicensed firms to provide construction management services, but we question whether the State wants to assume the related risks and costs of using potentially unqualified firms for this role.

For design professionals licensed under Chapter 464 and providing construction management, qualification-based selection in accordance with HRS §103D-304 is required. "Qualifications-based selection" (QBS) is the nationally recognized model procurement code for the procurement of design professional services and provides the project owner with the most qualified representative in the construction process, reducing the owner's risks.

CONSOR requests this bill be deferred.

Dear Chair Lee, Vice Chair Inouye, and Committee Members:

As the President of a local professional construction management and engineering company, I strongly oppose SB 3370 for the following reasons:

- This bill does not comply with HRS §103D-304.
- To protect the safety of the public and the environment, and to provide responsible oversight of government-funded projects, only licensed professional engineers, architects (or other professionals licensed under HRS Chapter 464) and only those with experience and qualifications that are specifically pertinent to the project should be considered to serve as construction managers on public works projects. Such has been, and still is, the nation-wide industry standard, which is also known as Qualifications-Based Selection (QBS).
- To select a construction manager for any public works project based on what is being proposed in this bill (i.e. lowest bidder) would be irresponsible, increase the potential for public safety and environmental risks, and increase the potential for construction cost overruns.

I also join in the testimony of the American Council of Engineering Companies of Hawaii who also opposes this bill.
