At the February 14, 2023 Regular Meeting of the Waikiki Neighborhood Board the board supported the concept of Senate Bill 346.

All Waikiki Residents are aware of the noise a Honolulu Fire Department (HFD) Truck makes when responding to an emergency. While the numbers of actual Fires and Ocean Rescues is relatively low the Waikiki Fire Station responds to about 200 Medical Emergency Calls in the radius of the Station each Month.

Currently the City and County of Honolulu has Ordinances and Policy that requires the Firefighter driving an Emergency Vehicle to use the Siren and Horn when responding to an Emergency.

Residents are concerned that during the early morning hours, normally 2-4 AM, that the sirens only disturb sleep and are not necessary for Safety when the HFD vehicles respond to an Emergency.

Senate Bill 346 would make the use of Sirens/Horns optional for the Firefighter Driving the Vehicle.

If enacted this Bill would allow the Fire Chief, Mayor, City Council, Corporation Council and the Firefighters Union to deliberate if it could be implemented in the City and County of Honolulu.

Honorable Chair and Committee Members:

The Waikīkī Neighborhood Board is in strong support of Senate Bill 346, and its companion House Bill 175, both titled "Relating to Emergency Vehicles." These acts clarify that the use of sirens by emergency vehicles shall not be necessary if it is not reasonable under the circumstances.

Waikīkī has been subjected to an unprecedented amount of noise pollution. Noise pollution has been documented to have ranging negative impacts on both human and animal life. One common and frequent source of noise pollution in Waikīkī is the use of emergency sirens at all hours through the day and night. Although emergency sirens can be necessary, recent studies suggest that the use has minimal positive effect, and use can cause further accidents and injury. *See* Joint Statement of Lights & Siren Vehicle Operations on Emergency Medical Services (EMS) Responses, dated February 14, 2022. The Waikīkī Neighborhood Board also understands that every 911 emergency call results in both a fire truck and an ambulance being dispatched to the scene, and that a majority of these calls regard non-life threating emergencies.

The Waikīkī Neighborhood Board appreciates the opportunity to submit this testimony. We encourage the passage of this minimal effort to address the severity of noise pollution within Waikīkī.

Resolution for Reducing Siren Noise in Waikiki

Whereas sirens do NOT significantly increase the timely delivery of patients to hospitals; (1)

Whereas sirens do NOT significantly increase the timely arrival of fire personnel to accident sites; (1)

Whereas civilian safety is NOT enhanced by siren use; (2)

Whereas ambulance use of sirens is associated with increased risk of ambulance crashes. (3,5)

Whereas many motorists cannot hear sirens due to driving habits; (4)

Whereas limiting use of sirens will DECREASE risk of injury and death; (6)

Whereas siren use has LITTLE bearing on patient outcomes; (2)(7)

Whereas traffic in Waikiki is significantly reduced between the hours of 10 pm and 5 am;

Whereas fire and EMT sirens are a daily occurrence that create significant disturbances;

Whereas such disturbances greatly affect the peace and sleep patterns of residents in Waikiki;

Resolved, that the Waikiki Community Council urges the Honolulu Fire Department to eliminate

the deployment of sirens between the hours of 10 pm and 5 am.

Further, the Waikiki Community Council urges the Honolulu Fire Department to re-examine its coding policy in order to reduce the number of code three extreme emergency dispatches during

all hours, day and night.

Although research has shown that sirens are often counterproductive, we agree that they can be an important safety device and people should pay attention to them. But using them when they are not absolutely necessary causes people to fail to distinguish when they're REALLY REALLY needed and when they're not, such as at nighttime when there is little or no traffic and everyone, including children who need their rest, are asleep. The result is the sirens fail to have their desired effect and result in nothing but noise. The indiscriminate use of sirens is a blight on the public's right to peace and quiet. SB346 addresses this by leaving it up to the ambulance or police car driver to decide whether the siren is needed or not and at what volume. Re: SB 346 SD1 – Relating to the Emergency Vehicles

Dear Chair Au Belatti, Vice-Chair Takenouchi, and Honorable Committee members:

I serve as the President of the State of Hawaii Organization of Police Officers ("SHOPO") and write to you on behalf of our Union in **strong support** of SB 346 SD1. This bill amends HRS § 291C-26(c) to make the use of emergency sirens by authorized emergency vehicles discretionary.

As noted in the measure, the use of sirens by emergency vehicles can be and is necessary to alert other vehicles and pedestrians that an emergency vehicle is exercising its authority to disregard certain traffic laws. However, use of the sirens is not always necessary or mandatory. The unnecessary use of a siren contributes to noise pollution, especially in heavily-congested residential areas. Further, providing emergency responders like police officers with the discretion to use their sirens will alleviate noise pollution, the unnecessary disturbance of our citizens who are sleeping at night when the streets are empty of cars and pedestrians, as well as curb unnecessary traffic situations and panic. This Act will provide much needed flexibility in the use of sirens by emergency response vehicles in certain circumstances.

We thank you for allowing us to be heard on this very important issue and hope your committee will unanimously support this bill and allow this bill to take effect upon its approval.
