## In consideration of SENATE BILL 409, SENATE DRAFT 1 RELATING TO FIRE PREVENTION

Senate Bill 409, Senate Draft 1 proposes to appropriate funds to the Department of Land and Natural Resources (Department) to reduce hazardous wildfire fuels on the landscape, particularly on lands adjacent to communities. **The Department strongly supports this measure.** 

With changes in land use and climate in Hawai'i, wildfire is a significant and growing hazard in many places across the state. Research in wildfire science shows that vegetation is a key component for recurring wildfire. Vegetation management is essential for reducing wildfire hazard, creating safer conditions for firefighters, and serving as a key climate adaptation strategy as climate change increases risk for fire. Funds are needed by the Department to reduce hazardous fuels on the landscape that threaten not only the watersheds the Department manages but also the adjacent communities and critical public infrastructure such as powerlines and communication facilities. The requested funds will be used to create firebreaks between communities and watersheds, reduce flammable grasses on the landscape through projects like managed grazing and forest restoration, and provide water infrastructure for tree planting, grazing, and fire suppression.

Aloha,

The Big Island Invasive Species Committee strongly supports SB409 which would appropriate funds to DLNR to reduce hazardous wildfire fuels on the landscape, particularly on lands adjacent to communities.

As an organization on the front lines of fighting invasive plants, we are all too familiar with the difficult job of controlling invasive weeds like fountain grass, a dangerous fire fuel which contributes each year to bigger, hotter and more dangerous fires on our island. With each fire, we lose more native vegetation and create more space for the incursion of invasive grasses which in turn lead to more fuel for fire – a vicious cycle that can only be broken with intensive, boots-on-the-ground effort.

We support the passage of this bill because we know vegetation management is essential for reducing wildfire hazards, creating safer conditions for firefighters, and serving as a key climate adaptation strategy as climate change increases our wildfire risks. The requested funds will be used to create firebreaks between communities and watersheds, reduce flammable grasses on the landscape through projects like managed grazing, and provide water infrastructure for grazing and fire suppression. On February 15th, a webinar on wildfire in Hawaii was held as part of Hawaii Invasive Species Awareness month. I concur with DLNR Chairperson Dawn Chang's testimony relating to Senate Bill 409, Senate Draft 1 which proposes to appropriate funds to DLNR to reduce hazardous wildfire fuels on the landscape, particularly on lands adjacent to communities.

I live in Waikoloa Village where, in 2021, we were evacuated due to the advancing Mana fire. Fuel loads in high wind areas like the leeward, dry side of Hawai'i Island pose an extreme fire risk to not only native species of plants and animals, to our watershed and reefs, but also to the property and health of our communities. Air quality was diminished for months after the Mana fire as the winds kicked up clouds of dust.

There are solutions, but they require funding. Creating and maintaining firebreaks is one solution, but in windy places, they won't suffice. Reducing the fuel loads will take solutions like managed grazing, followed by forest restoration. Protected lands, like the Palila Sanctuary will not survive a wildland fire, if the fuels loads surrounding the sanctuary are not properly managed.

The funds needed to fight historic wild fires could be reduced if attention as paid to proactive steps to reduce the threat. Please support this initiative.
