Dear Chair Dela Cruz, Vice Chair Keith-Agaran, and Committee Members:

The Hawai'i State Ethics Commission ("Commission") supports S.B. 556, S.D. 1, which seeks to eliminate potential conflicts of interests in the Grant-in-Aid ("GIA") funding process.

The bill prohibits an organization with a legislator on its governing board from receiving state funding under Hawai'i Revised Statutes ("HRS") chapter 42F. The bill also prohibits individuals who are current members of the Legislature from receiving GIA funding. S.B. 556, S.D. 1 promotes integrity in government by addressing potential conflicts of interests.

The existing Conflicts of Interests law, HRS § 84-14(a), applies differently to state legislators compared with other state employees: legislators are unique in that the Ethics Code does not specifically prohibit legislators from taking official action affecting businesses and nonprofit organizations on which they serve as an officer or director.¹ As a result, the State Ethics Code does not prohibit legislators from awarding GIA funding to their own organizations.

By amending the requirements under HRS chapter 42F – and limiting which individuals or organizations are eligible to receive funding – S.B. 556, S.D. 1 would help to avoid the appearance of conflicts of interests in the award of GIA funds, thus promoting integrity in state government. The Legislature would still maintain control over its own conflicts of interests rules, but organizations would be prohibited from obtaining a GIA if a legislator sat on the organization's governing board.

The Commission supports this measure and respectfully asks that the Committee pass it. Thank you for your continuing support of the Commission's work and for considering the Commission's testimony on S.B. 556, S.D. 1.
