TESTIMONY Janet Mason, Legislative Committee, League of Women Voters of Hawaii

Chair Rhoads, Vice Chair Kaohokalole, and Committee Members:

The League of Women Voters of Hawaii supports SB 741, that would require Hawaii electors to vote for the candidates whose names appear on the presidential general election ballot and who are of the same political party or group they represent and invalidates an elector's vote for failure to vote accordingly and would also require an alternate to vote in place of the original elector if the original elector fails to vote for the proper candidate.

The Electoral College arises from Article II, Section 1, Clauses 2 and 3, of the U.S. Constitution which permits each state to "appoint electors "in such manner as the Legislature may direct." Based on my lay reading of this provision, Hawaii has the right to prohibit "faithless electors" who do not vote for the candidate for whom they had pledged to vote.

This bill is important and will protect the choices for president and vice president made by the people of Hawaii during a presidential general election. A "rogue" elector can subvert the will of the electorate if he or she casts a vote contrary to the winner of such elections, and this is completely contrary to democratic principles. The League thanks the introducers of this bill for trying to build a safeguard to prevent this in the future. We hope the measure will take effect upon passage.

However, the League of Women Voters does not support the Electoral College. We believe that the Electoral College should be abolished entirely because the national direct popular-vote method for electing the President and Vice-President is essential to representative government. If our country could achieve such direct election, bills like this would not be necessary.

Common Cause Hawaii supports SB 741, which increases (1) requires an elector to vote for the candidates whose names appeared on the presidential general election ballot and who are of the political party or group they represent and invalidates an elector's vote for failure to vote accordingly and (2) requires an alternate to vote in place of the original elector if the original elector fails to vote for the proper candidate.

Common Cause Hawaii is a nonprofit, nonpartisan, grassroots organization dedicated to reforming government and strengthening our representative democracy.

Faithless electors are rare and have never affected a presidential election. Hawaii has not yet had a faithless elector. The U.S. Supreme Court has held that states may remove presidential electors. Chiafalo v. Washington, 591 U.S. __, 140 S. Ct. 2316 (2020).

Even though rare, there have been faithless electors throughout the nation's history. See https://www.fairvote.org/faithless electors old (retrieved Jan. 22, 2022). Faithless electors seek to overturn the will of the people expressed at the ballot box, which violates the very foundations of our democratic society and governance.

Common Cause Hawaii supports SB 741 to ensure that the political will of the people as expressed at the ballot box is not overturned by a faithless elector. The Uniform Law Commission has approved the Uniform Faithful President Electors Act and recommends states adopt a faithless elector law to address this persistent issue.
