EOA's Position: The Executive Office on Aging (EOA), an attached agency to the Department

of Health, strongly supports SB900 SD2, HD1, relating to the Hawaii State Health Insurance

Assistance Program (SHIP).

Fiscal Implications: This measure appropriates funds for SFY 2023 and SFY 2024 for one full-

time equivalent (1.0 FTE) Program Specialist III position, one full-time equivalent (1.0 FTE)

Program Specialist IV position, and one full-time equivalent (1.0 FTE) Program Specialist V

position within the EOA to be expended for the Hawaii SHIP.

Purpose and Justification: The purpose of this bill is to:

 Require the Executive Office on Aging to submit an annual progress report on the Hawaii SHIP. Once the positions are established, ongoing progress of the program shall continue to be included in the annual legislative report submitted by EOA. Appropriate funds for three permanent Program Specialist positions within the EOA to meet the growing aging population's demand for accurate, timely, and unbiased information and assistance.

Hawaii ranks first in the nation with the highest life expectancy of 81.3 years of age. Hawaii's cost of living is almost double that of the national average at 193.3%. In 2022, medical and prescription drug spending rose to \$157,480,248 nationally. Medicare is essential to providing health care coverage for older adults and persons with disabilities. However, the rules and procedures for Medicare and Medicaid eligibility and enrollment are complicated and difficult to navigate. Medicare also imposes lifetime late enrollment penalties for those who don't sign up when first eligible at the age of 65 or upon termination of creditable group coverage.

In 1992, EOA received the first SHIP grant with two temporary staff. Over thirty (30) years later, the program is still managed by two full-time equivalent (2.0 FTE) while the Medicare population in Hawaii has more than doubled from 133,439 to 296,653. The table below compares the ratio of full-time staffing to the target population served, as compared to other states of similar size. Hawaii SHIP has the least number of staff for the largest, fastest growing population of Medicare beneficiaries.

Hawaii SHIP was established to inform and assist Medicare beneficiaries to: (1) Find medical or prescription drug coverage if uninsured; 2) Make informed choices based on the individual's needs and budget; (3) Enroll in Medicare to avoid lifetime late enrollment penalties; (4) Access wellness and preventive services to improve health outcomes, lower health costs, and support aging in place; and (5) Enroll in low-income subsidy programs such as Medicaid, Extra help, and Medicare Savings Programs to reduce or eliminate out-of-pocket costs. Hawaii SHIP provides free, 1:1 counseling by phone, email, or in-person to beneficiaries, caregivers, and soon-to-be retirees statewide through the support of volunteers.

In 2016 and 2017, federal funding for SHIP grantees was nearly eliminated by Congress, who undervalued the importance of qualified Medicare education and assistance despite 65,000 people turning 65 every day. Continued advocacy, support, and stable funding is critically needed to sustain the program and services to help Hawaii's aging population.

The Administration for Community Living oversees 54 SHIP projects nationwide and considers an eight percent (8%) penetration rate (23,191 individuals) as acceptable (minimum) performance and justification for continued funding. However, Hawaii SHIP currently serves 8,800 individuals per year, which is approximately only three percent (3%) of Hawaii's Medicare population. With additional staff and dedicated resources, EOA shall reach its acceptable performance measures by expanding outreach and increasing local, 1:1 assistance to kupuna and persons with a disability in each county. Additionally, and more importantly, the staffing ratio needs to meet the growing demands of our aging population.

Recommendation: EOA strongly supports this measure provided that its enactment does not reduce or replace priorities with the Administration's budget request.

When CCH staff refer older adults to other organizations to receive services, we need to have confidence in the organization to serve the best interest of those individuals. We are confident that SHIP is a quality, unbiased referral source for older adults in need of Medicare advice. We can trust that SHIP will have the most up-to-date Medicare information and that they are not influenced by any ties to specific Medicare plans.

Aloha Chair Yamashita, Vice Chair Kitagawa and Honorable Committee Members:

I present this testimony to SUPPORT of SB900, SD2, HD1—as amended, but with date changes— which would, among other things: 1) require the Executive Office on Aging to provide annual progress reports to the Legislature; and 2) provide additional funds to support the State Health Insurance Assistance Program (SHIP) within the Executive Office on Aging.

Currently, this program is hampered by staffing shortfalls with ONLY 2 temporary staff positions allocated to the SHIP program since its inception in 1992. Right now, the program can only assist the 8,000 individuals cited in the previous Standing Committee Report. In order to expand its reach throughout the State of Hawai`i, the SHIP program urgently needs funding for 3 full-time staff. Meanwhile, the federal funder of SHIP, the Federal Administration for Community Living notes that their goal is 23, 191 people served – or approximately 8% of Hawai'i's Medicare population. However, if SHIP loses its federal funding, it has NO way to reach that goal – and continue assisting beneficiaries, their families, caregivers and folks turning 65 with Medicare concerns.

For all of the above reasons, and in order to improve our access to health care, I urge your Committee to please pass SB900, SD2, HD1 with sufficient funding for 3 full-time staff contingent on annual legislative-reporting – and to please change the effective date to ideally 07/01/2023, BUT not later than 07/01/2024 as ALL of in Hawai`i share an interest in continuing this SHIP program.

Aloha Distinguished Legislator,

I hope you will take the time to hear and support SB900 in the next round of committee hearings. When I received assistance last year from SHIP to go through the Medicare enrollment process, I was so impressed and appreciative of the service that I signed up to become a volunteer myself. Since then, I have had the privilege of assisting other kupuna this past year and continue to assist those who call the SHIP office.

Hawai'i SHIP is a statewide, volunteer-based program at the EOA that EDUCATES, ASSISTS and EMPOWERS Hawai'i's Kupuna and people with disabilities, their families, caregivers, and individuals turning 65 with Medicare and other healthcare topics. SHIP assists individuals who identify as Native Hawaiians, are rurally isolated, speak limited English, and have low incomes through the Medicare Improvements for Patients and Providers Act (MIPPA) grant which supports SHIP's work in Hawai'i.

Services are offered free of charge and includes:

- One-on-one, Local, Unbiased, Timely, Accurate & Cost-effective Counseling to kupuna and families about Medicare
- Presentations on Medicare education are offered at senior fairs, community groups and anywhere else it is requested
- Distribution of Certified Medicare Publications
- Health plan comparisons and financial assistance eligibility screenings and application submission to help pay Medicare costs.

Hawai'i's Medicare population is currently over 295,000 beneficiaries, an increase of 300% since 1992 when EOA received the 1st SHIP grant. However, we only served around 9,000 clients in 2022. Currently we have 2 temporary, full time equivalents because SHIP is funded 100% by a federal grant. We haven't increased the number of positions since 1992 and could potentially serve many more kupuna with the passage of SB900.

SB900 is one of Kupuna Caucus' 5 priorities in the 2023 session. The bill asks for 3 permanent positions to sustain the program should federal funding be eliminated (which happened during the Trump Administration).

Medicare is very complex and changes annually. Without the education SHIP provides many won't enroll into Medicare and become uninsured or underinsured. Older adults often live off fixed incomes (SS benefits) and it only takes one healthcare scare for a kupuna to deplete their savings.

I humbly ask for your support of SB900.

Hawaii State Health Insurance Assistance Program (SHIP) is a federally funded, volunteer-based program that is administered by the Hawaii State Department of Health, Executive Office on Aging. Hawaii SHIP helps Medicare-eligible individuals, their families, caregivers, and soon-to-be retirees to make informed, cost-effective healthcare decisions. This is accomplished through one-on-one counseling and community outreach such as presentations, fairs, and exhibits. Services are free, local, individualized, and unbiased.

As a Social Worker in the field of Gerontology, I see an increased need for services and supports for older adults in Hawaii. With increases to Social Security and Medicare expenditures, coupled with an increase in cost of living, older adults often find themselves struggling to financially meet their basic needs. Health insurance should be considered a necessity. Older adults are more predisposed to chronic conditions, hospitalizations, and have a higher utilization rate of medical services and prescription medication. Medicare is a complex program which is difficult to navigate for even the most capable and connected. With annual changes, numerous Medicare notices, enrollment periods, and lifetime late enrollment penalties it can often be overwhelming.

What happens if the SHIP program goes away tomorrow? People won't know when or how to sign up for Medicare. Because they didn't enroll into Medicare, they have no health insurance. Without any health insurance they won't go to the doctors or get the appropriate health care. Uninsured or under insured people will face expensive medical bills. It only takes one health scare for a Kupuna living on fixed income (SS benefits) to lose their home. We want to prevent lower health outcomes, higher healthcare costs, and higher rates of poverty.

Hence, I strongly support SB900, relating to the State Health Insurance Assistance Program, which would provide Hawaii SHIP with three additional staff to sustain the program and meet the growing needs of our older adult population. Medicare will continue to rapidly grow as kupuna ages into it. With more permanent SHIP positions, Hawaii could increase outreach and education to Hawaii's residents so they can make well informed decisions for themselves.

I urge the committee to pass SB900. Thank you for this opportunity to testify.

I am a volunteer counselor for the Hawaii SHIP, and I have experienced the positive impact that SHIP has on the lives of our local Medicare beneficiaries.

Medicare is a maze that is difficult to navigate and comprehend even for the savvy and educated. I am writing in support of SB900, Relating to the State Health Insurance Assistance Program

Hawaii State Health Insurance Assistance Program (SHIP) is a federally funded, volunteer-based program that is administered by the Hawaii State Department of Health, Executive Office on Aging. Hawaii SHIP helps Medicare-eligible individuals, their families and caregivers, and soonto-be retirees make informed, cost-effective healthcare decisions. This is accomplished through one-on-one counseling sessions, answering questions, and distributing informative brochures at health fairs, and providing Medicare-related presentations. These services are free to the public who contact Hawaii SHIP through the Help Line and website. Volunteers, who provide these important services, are recruited and trained throughout the year to keep up with the changes or updates to Medicare.

As a volunteer, I respond to calls from the public about Medicare. Medicare can be quite confusing and may lead to lifelong penalties in premiums if the person does not enroll at appropriate times or they be without insurance coverage if they miss an enrollment period. I have had state/city retirees who call wondering if they should respond to the barrage of TV ads, mailers and phone calls they receive during Medicare Open Enrollment period wondering if they should change their coverage. Generally, this would result in less coverage and difficulty in returning to EUTF coverage. We exhibit at fairs, malls and conferences and always have individuals come up to ask questions about their Medicare coverage. Federally funding is never guaranteed and while SHIP has been fortunate to have many years of funding, the loss of funding would result in the free, unbiased and local resource no longer available to Hawaii residents.

Hence, I strongly support SB900, relating to the State Health Insurance Assistance Program, which would provide Hawaii SHIP with much-needed funding for three program specialist positions. This will result in expanding access to important Medicare-related services to Hawaii residents statewide.

There are 295,405 Medicare beneficiaries statewide as of 2023. Hawaii SHIP's goal is to assist as many beneficiaries in Hawaii as possible. With 80+ volunteers statewide in 2022, SHIP assisted 2,675 with Medicare counseling and reached 6,465 beneficiaries through outreach presentations and fairs/exhibits. By 2025, SHIP will need to reach 10,000 Medicare beneficiaries which is a drastic increase from SHIP's current capacity.

With more positions, we could sustain the Hawaii SHIP program and increase our outreach and education to Hawaii's residents. I urge the committee to pass SB900. Thank you for this opportunity to testify.

Aloha and thank you for an opportunity to explain why I support this bill. As a SHIP volunteer for about a year, I've had several discussions with clients who are lost when navigating the medicare options. It's one of the reasons I volunteer--I also need to enroll and it's so confusing.

As an AARP tax-aide volunteer, I've had so many clients who most likely qualify for additional support paying for premiums and prescriptions, but have no idea what's available to them. I share SHIP contact information so they can get additional counseling to help determine whether they could be eligible and how to apply for that assistance.

Many of the clients here on Kauai do not use computers and need additional assistance, and often an interpreter could make it easier to understand the medicare system. If we no longer have a SHIP office with so many knowledgeable volunteers, many kupuna will continue to survive on very little income. One of my tax clients cried because of her situation--health problems, oldest child preceded her in death, and no one to really help her. It's heart-wrenching seeing the situations and knowing there are resources available, but they just don't know how to access them.

Please continue to support the efforts of the SHIP office and provide additional staff, so the volunteers can continue to receive the training needed to be current with all the changes and submit documentation necessary to ensure proper reporting to the federal system demonstrating the need in HI.

Aloha Chair Yamashita, Vice Chair Kitagawa and Honorable Committee Members:

I present this testimony SUPPORTING SB900, SD2, HD1—as amended, but with date changes— which, among other things: 1) requires the Executive Office on Aging to provide annual progress reports to the Legislature; and 2) provides additional funds to support the State Health Insurance Assistance Program (SHIP) within the Executive Office on Aging.

This program is presently hampered by staffing shortfalls with ONLY 2 temporary staff positions allocated to the SHIP program since it began in 1992. Right now, the program can only assist the 8,000 individuals cited in the previous Standing Committee Report. Yet, in order to expand its reach throughout the State of Hawai`i, the SHIP program urgently needs funding for 3 full-time staff. Meanwhile, the federal funder of SHIP, the Federal Administration for Community Living, notes that their goal is 23, 191 people served – or approximately 8% of Hawai'i's Medicare population. However, if SHIP loses its federal funding, it has NO way to reach that goal – and continue assisting beneficiaries, their families, caregivers and folks reaching age 65 with Medicare concerns.

For all of the above reasons, and in order to improve our access to health care, I respectfully urge your Committee to please pass SB900, SD2, HD1 sufficient funding for 3 full-time staff contingent on annual legislative-reporting – and to please change the effective date to ideally 07/01/2023, BUT not later than 07/01/2024 as ALL of in Hawai`i share an interest in continuing this SHIP program.
