REQUESTING THE STATE FOUNDATION ON CULTURE AND THE ARTS TO COLLABORATE WITH THE OFFICE OF VETERANS' SERVICES TO PLAN AND CONSTRUCT MEMORIALS TO HONOR THE SACRIFICES AND CONTRIBUTIONS OF VETERANS FROM HAWAII

Chair Tam and members of the Committee, the State Foundation on Culture and the Arts (SFCA), is pleased to offer **COMMENTS** on S.C.R.100. The SFCA works with all departments, including the Office of Veterans' Services on planning and integrating works of art into facilities as works of art are an important part of the State building presence as they tell the stories of place and humanize our built environment.

The State Foundation on Culture and the Arts, Art in Public Places Program acquires completed, portable works of art, and commissions artists to create works of art for specific locations. Works of art are displayed in over 640 sites statewide including schools, libraries, hospitals, airports, state office buildings, the State Capitol, the Hawai'i State Art Museum and the soon to be completed Daniel K. Akaka State Veterans' Home in Kapolei.

When curating public space, the State Foundation on Culture and the Arts looks to the legislature to designate specific statues, monuments, and memorials to honor individuals or events.

While monuments may "give tangible and visible recognition to the sacrifices and contributions of veterans and military personnel," participation in creative arts therapy or in community arts programs have proven to increase those individuals' quality of life. Arts in healing programs such as "Creative Forces" serve the unique and special needs of military patients and veterans who have been diagnosed with traumatic brain injury and psychological health conditions, as well as their families and caregivers. Healing arts use creativity through music, visual arts, dance, drama, creative writing, craft-making and other creative pursuits in both clinical and non-clinical settings to promote health and well-being and improve quality of life.

With over 110,000 veterans, service members and their dependents in Hawaii, such programming would be appropriate providing a mechanism for organizations sponsoring programs in the arts, culture and humanities to expand their focus to include veterans. If it is the desire of the Legislature, the State Foundation on Culture and the Arts endorses collaborating with the Office of Veteran's Services to plan an arts in healing program for consideration by the legislature for future appropriations.

I am Maj Gen Joseph Harris, Commander of the Hawaii Air National Guard (HIANG) in the State Department of Defense, and I am providing written testimony in **STRONG SUPPORT** of SCR 100, SSCR 1489.

HIANG personnel generated and flew countless combat missions, provided unparalleled command and control, delivered life-saving intelligence information and communications capabilities, and

secured critical infrastructure, often at great risk to themselves. Meanwhile, their families supported their loved ones while facing many challenges.

The construction of memorials throughout the state of Hawaii to honor our GWOT fallen military members, Veterans, and their families, to include our Gold Star Families, is an important step in recognizing their courage, sacrifice, and commitment to our country. These memorials will serve as a symbol of our gratitude and appreciation for their sacrifices and provide a place for us to come together to pay our respects.

This resolution, if passed, creates the foundational collaboration of the State Foundation of the Culture and the Arts with the State Office of Veterans' Services to plan and construct a main memorial at the Hawaii State Veterans Cemetery at Kaneohe and smaller replica memorials at the neighbor island State Veterans Cemeteries to honor our Global War on Terrorism (GWOT) fallen military members, our Veterans , our Gold Star Families and the families who have supported their loved ones who served during this elongated period of war. From Operation Desert Storm in 1991 to conflicts in Iraq covering war campaigns including; Operation Iraqi Freedom (Mar 2003-Nov 2011), Operation New Dawn (Sep 2010-Dec 2011) and Operation Inherent Resolve (Jun 2014-Dec 2021) and conflicts in Afghanistan covering war campaigns including; Operation Enduring Freedom (Oct 2001-Dec 2014) and Operation Freedom Sentinel (Jan 2015-Aug 2021) and other conflicts globally that the US has participated in.

More than 327 servicemembers with Hawaii ties died in the line of duty during this lengthened period that has been labeled as one of the longest running wars in US history. Act 139, signed by then Governor Neil Abercrombie on June 21, 2013, created a special State Task Force headed by Gold Star Fathers and Distinguished Veterans, Allen Hoe and David Brostrom, with the late State Representative at the time, K. Mark Takai, a GWOT Veteran himself, to

collectively lead the Task Force in this endeavor for a GWOT Memorial(s) to honor and to never forget the sacrifices made by these men and women on behalf of a grateful State and Nation.

Thank you for this opportunity to offer testimony in **Strong Support** of SCR100, SSCR 1489, supporting our Veterans and their loved ones who served during this extended period of global conflict.
